Biographical Note:

Nathaniel Ragland Parrish, born on 22 May 1884, was a long time resident of Roanoke and a well known court reporter, public stenographer, and notary. Mr. Parrish was the son of Judge H. T. Parrish who served as county judge for Appomattox County for 17 years. He died on 25 May 1960 at age 76.

Scope and Content:

This manuscript contains a collection of the professional and personal communications of Nathaniel R. Parrish. The documents date from 1916 to 1929. The collection is contained in one box and divided into two folders. Folder one contains personal communications between Parrish and his family, friends and any personal business not directly related to his profession. Folder two contains professional communications associated with Mr. Parrish's work as a court reporter and stenographer.
