Introduction:

This collection contains the papers and personal documents of several notable leaders in the Boy Scouts of America (BSA) from the Roanoke, Virginia area. The bulk of the collection extends from the 1930s to the 2010s. The collection contains information on awards, camps, menus, membership lists and member data, agendas and minutes of meetings, newsletters, various versions of official records, correspondence, financial records, and unofficial and personal documents. There are lists of attendees at camps and various events sponsored by the Roanoke-Area and Blue Ridge Mountain Councils of the Boy Scouts of America, as well as examples of the brochures and promotional literature for these camps, events and institutes, and the planning processes that went into holding them. Committee records, programs, clippings and newsletters are included, as are photographs, a few videotapes and a digital video disk. The collection provides an overview of scouting in the Roanoke area and the Blue Ridge Mountains for over eighty years, from the 1920s into the 2000s.

Historical Information:

The Boy Scouts of America (BSA) is one of the largest youth organizations in the United States, with 2.7 million young men who are members and over a million adult volunteers. Since its founding in 1910 as part of the international scouting movement, more than 110 million Americans have been members of the BSA.

The BSA intends to train young men in responsible citizenship, character development, and self-reliance through participation in a wide range of outdoor activities, educational programs, and, at older age levels, career-oriented programs in partnership with community organizations. For younger members, the scout method is part of the program to inculcate typical scouting values such as trustworthiness, good citizenship, and outdoors skills, through a variety of activities such as camping, aquatics, and hiking.

The Blue Ridge Mountains Council, Boy Scouts of America, includes 21 counties and nine cities in southwest and south central Virginia with council headquarters located in Roanoke, Va. A total of 37 employees, nearly 5,000 volunteers, over 300 local charter organizations, 431 Cub Scout packs and Boy Scout troops provide scouting experiences for over 14,000 participants each year.

Scope and Content:

The Roanoke-Area Scouting History Collection 1926-2009 is contained in 5 record storage boxes, a total of 5.5 linear feet, and are located in the Virginia Room of the Roanoke Public Libraries in Roanoke, Virginia. All materials are foldered in acid free, labeled folders.

The papers encompass several lots of materials that belonged to notable scouts and scout leaders from the Roanoke area and were collected by Stephen C. Warren and W. Scott Smith. These scouts and leaders include Stephen C. Warren, Alton Parker, Richard Wimmer, Michael Cannaday, Glenn Street, Robert De Windt, George Carr, W. Preston Leech, and E.C. Warren. Overall the bulk of the materials come from the estate of E.C. Warren, who was not related to Stephen C. Warren.

In bringing together the contents of several estates, Stephen C. Warren gathered many relevant documents on local scouting in the Blue Mountains and Roanoke areas, including certificates and awards, brochures and lists from various camps, their menus, and participant lists. Troop and council membership lists and member data, agendas and minutes of meetings, newsletters, various versions of official records, correspondence, financial records, and unofficial and personal documents were also collected. There are documents on events sponsored by the Roanoke-Area and Blue Ridge Mountain Councils of the BSA, as well as examples of the planning and promotional literature for these camps, events and institutes. Committee records, programs, clippings and newsletters are included, as are a number of photographs, a few videotapes, and a DVD.

The bulk of the oldest materials in the collection go back to scout troop records from the 1930s. One old item is from 1926. The most recent materials in the collection deal with camp menus from 2008 and newsletters from 2009. Important areas in the collections are the camps and lodges, such as the Tutelo Lodge # 161 and the Powhatan Lodge #456, and the Order of the Arrow, an honorary society.

The original order of the materials, as they were received, was retained in processing, and there are several roughly chronological sequences in the collection, which mostly follow the order assigned by the scout leader who originally collected them. However the order of materials is not strictly chronological and some papers are not chronologically arranged. To preserve the original order of the materials, the various series are arranged by topic and provenance as they appeared in the unprocessed collection. Likewise, the order of materials found in the addenda was maintained based on its order upon acquisition.
