Organizational Note

Youth Haven is a probation house for Roanoke City Juvenile Court in the State of Virginia. It was created in 1970 as a project of the Junior Woman's Club of Roanoke, Inc. Youth Haven, Virginia's first probation house, was the state's first preventative facility for juvenile delinquency. In its beginnings, Youth Haven was under the jurisdiction of the Juvenile and Domestic Relations Court of Roanoke City and was staffed with a full-time housemother, a caseworker, three male supervisors who alternated shifts around the clock (with the help of a part-time supervisor), a part-time psychologist and a cook-housekeeper. The primary function of Youth Haven was to provide a community-based service of short term, small group residential training for delinquent children. Youth Haven could accommodate eight boys ranging in age from 10 to 16 in the first few years.

Scope and Content

The Youth Haven Collection is comprised of materials relating to the early stages of the organization from 1969 through 1972. The Collection includes 15 folders containing the organization's founding, financial beginnings, activities, and connections to other government and community organizations. The collection is a single report that has been divided into 15 sections. The collection contains organizational reports, legislative reports, financial reports, pictures, newspaper clippings, and correspondence.
