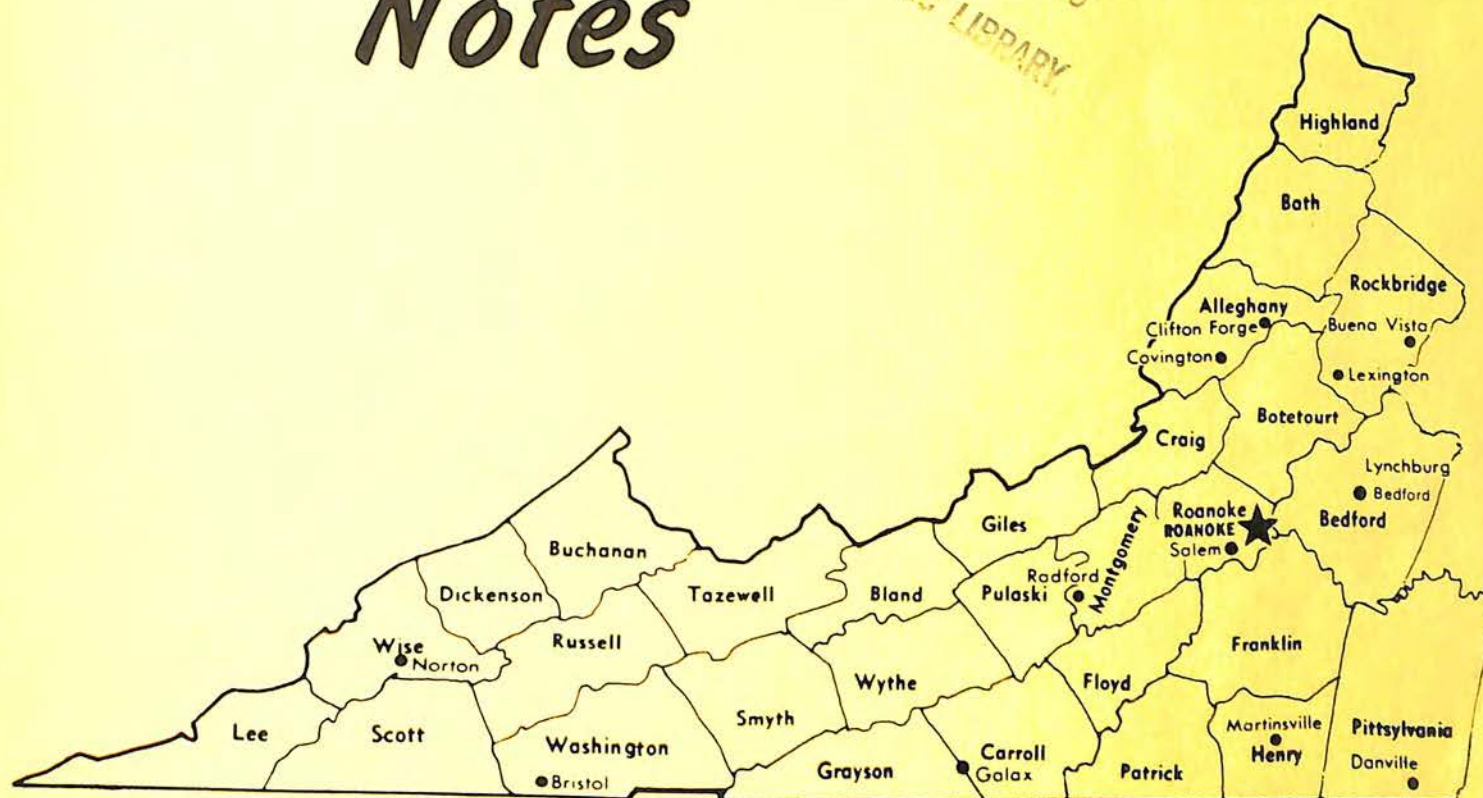

On pedigree charts #1 is you or the person the chart is about; #2 and all even numbers are males, all odd numbers are females. #2 is father, #3 is mother; #4 is grandfather & #5 is grandmother & wife of #4 and parents of #2; #6 is grandfather & #7 is grandmother & wife of #6 and parents of #3. You will notice that that each number is doubled for each generation. A pedigree chart is included in this issue.

SURNAME INDEX FILE: At one time we attempted to place all names on the pedigree charts on cards, but membership is growing and just too much for one person to record all the surnames --- so if you want the surname entered in the index file, please fill out a 3x5" index card and mail to us. PROCEEDINGS OF MILITIA COURT-MARTIAL

The following is the proceedings of the Tory trial of Botetourt and Montgomery Counties taken from microfilm of "The Preston & Virginia Papers of the Draper Collection of Manuscripts" of the State Historical Society of Wisconsin. A copy of the original may be obtain from the Historical Soc.

Aug. 1780: At a meeting of the Justices of Montgomery County and Botetourt for the Examination of Col W'm Ingles of Montgomery County, who stands charged with being guilty of Treason against the Commonwealth

Present: Col'o W'm Preston, Col'o W'm Christian, Col'o James Robertson, George Rutledge, Capt John Taylor, Capt Ja's Thompson, Capt Dan'l Trigg, Capt James Barnett, Capt Jos'h Grey, William Neeley, Patrick Lockart, Andrew Boyd, Robert Sayers, William Campbell, James Byrns.

Whereupon the Witnesses were examined as well in Behalf of the Commonwealth as for the Prisoner. The charge not being proven and information being ?_____? that further evidence may appear.

The Court are unanimously of opinion that the final Cehrmnation of the Matter be defor'd & that in the mean time Col'o Ingles do enter into Bond with sufficient Security to appear at any time when call'd or under the ?Bond? of 100,000 £.

Robert Grayson, is allso charged for the same offense & witness being sworn & examined as well for the Commonwealth as the prisoner. The Court are of opinion that the charge is not fully proven & he offers to enlist into the Continental Army till the last of Dec'r 1781. He is received & he took the Oath accordingly & as long as he serves, his Family & property is to be protected--

Joseph McDonald allso stands charged with the same offense and witnesses being examined, as well, in Behafe of the Commonwealth as for the prissoner. The Court are of opinion that the charge is proven but he being 58 years of age & a large family & his Two sons Joseph & Edward offering to enlist into the Continental Army untill the last day of Dec'r 1781 ?in order? to have Their Fathers Familly & Property Protected during their Services (W'm Lockhart desents)

John McDonald; is charged as above & witnesses being examined as well in Behalf of the Commonwealth as the prisoner. The Court are of opinion that the charge is fully proven & that he be sent to Augusta Goal for a further Tryal.

Joseph Poppecaughofer is charged as the rest & the witnesses sworn & Examined as before & the Court are of opinion that the charge is fully proven & that he be sent to Augusta Goal for further Tryals.

Jacob Shull Jun'r is also charged as the rest & the witnesses sworn & exam'd as well in behalf of the Commonwealth as the prisoner. The Court are of opinion that the charge is proven & that he be sent to Augusta Goal for further Tryal.

John Grayson, Gasper Reed & Jeremiah Patrick stands charged with being guilty of Treason against the Commonwealth. Witnesses being sworn & examined. The Court are of opinion that the charge is (blank or faded)

Gasper Garlick is charged as ?_____? the above & the witnesses being sworn and examined. The Court are of opinion that the charge is supported & he appears to be a simple fellow. do acquit him on his agreeing to take 39 lashes

Henry Stafford being charged as the rest & witnesses being examined. The Court are of opinion that the charge is not supported & that he be acquitted.

Abraham Morgan, stands charged as the rest & the witnesses being sworn & examined. The Court are of opinion that the charge is supported, but it appearing that he is an Ignorant Poor Man with a small Family to order him to be acquitted after getting 39 lashes.

Swain Polson stands charged as the rest & witnesses being sworn & examined. The Court are of opinion that the charge is proven that he be sent to Augusta Goal for further Tryal.

Robert McGee stands as the rest, charged for Treasson & witnesses being sworn & examined. The Court are of opinion that he be sent to Goal for further Tryal.

Jeremiah Stover, stands charged as the rest, & the witnesses being sworn & examined. The Court are of opinion that the charge is so far proven as finding him with his gun hid in a Barn with Several Tories & has been known frequently and allways since in this part of the Country to live among them, therefore do order him 39 lashes.

Thomas Copeley is charged as the rest & witnesses being sworn & examined. The Court are of opinion (the last line has been damaged).

Henry ?Savier? stands charged as the rest & being examined. He acknowledge he was an enlisted Soldier under Howard Haven for the British Service. But it appearing to the Court that he was a youth & (marked out) & advised to do so by Haven. & an his agreeing to enlist into the Continental Service for 18 months after his ?_____? The Court are of opinion that he be admitted to do so --- & he took the oath.

Andrew ?Savier?, stands charged as the rest & being examined, acknowledge himself an enlisted Soldier under Howard Haven for the British Service. But it appearing to the Court that he was a youth & might have been persuaded, to enlist into that service without properly understanding the matter & he now recanking & offering to enlist into the Continental Service & there to serve for 18 months after his arrival at the Grand Camp. They are of opinion that he be admitted to do so and he took the oath.

George Walter is charged with Treason as the rest & examined. The Court are of opinion that the charge fully proven. He having been enlisted as a soldier. But he appearing to be a poor & ignorant Man, offering to enlist into the Continental Army for 18 months from the time of his arrival in Gen'l Washington Camp & he took the oath accordingly.

John Harrison is charged as the rest & witnesses being sworn & examined. The Court are of opinion that the charge is not proven & that he be acquitted.

John Henderson is charged as the rest & acknowledges himself sworn by Tho's Heaven, not to lift arms against the British Army & to adhere to the King of England. The Court are of opinion that he (blank)

William Grant is charged as the rest. But he voluntarily agreeing to enlist into the Continental Army to serve for 18 months from the time of his arival in the Grand Camp. The Court did not go into the Examination of witnesses. But admitted him to the oath of a soldier.

Walter Stewart is charged as the rest & witnesses being sworn & exam'd. The Court are of opinion that the charge is not fully supported & that he be acquitted on entering into Bond with sufficient security in the sum of 20'000 £ for his Good Behavior.

Samuel Robinson being charged as the rest, & witnesses sworn & Exam'd. The Court are of opinion that the charge is not fully supported & that he be acquitted on entering into Bond & with sufficient Sec'y In the sum of 20'000 £ for his Good Behavior.

John Heaven & his two Sons James & William being charged as the rest ?___? ?___ndthing appearing to fix the charge fully on them & William voluntarily offering to enlist into the Continental Army to serve as long as those troops ordered to be raised by the last seembly (for that service) & the said James & his other son James offering to take the State oath at the Table. The Court are unanimously of opinion that the s'd William be received as a Soldier upon which he took the oath for that purpose & that John & James be acquitted & that they & their property be protected during the service of the said William & forever ?to serve? so long as they behave as becomes Good Citizens.

William Gurant stands charged as the rest & witnesses being sworn & examined. The Court are of opinion that the charge is (blank)

Adam Sevier being charged as the rest & acknowledging himself guilty of the charge & offering to enlist himself in the Continental Army to serve as long as the Troops ordered by the last assembly. The Court are of opinion that as he is a youth & it is probable he was inadvertently drawn to the wrong side of the Dispute. And that he be admitted as a Soldier & there upon he took the oath of a Soldier.

Jacob Francisco is charged as the rest & he confesses that has been sworn & enlisted with Howard Haven for the British service.

Hexekiah Phillips & Henry Laybrook being charged for assaulting & Beating Christian Snido, an officer on duty. & Witnesses being sworn & exam'd. The Court are of opinion the charge is proven.

Jacob Shull charged as the rest and voluntarily enlists a Soldier in the Continental Army until the last day of Dec'r 1781 and also John Shull enlists on the same terms. on which their & their Fathers property all is to be protected, while the said Jacob ?& John, if their said fathers behaves well.

David Price, charged as the rest; and the Court are of the opinion that he be having voluntarily enlisted himself for that purpose till last Dec'r 1781 be rec'd as a Soldier in the Continental Army.

Jacob Francisco, charged as rest, and enlists as a capt ?_____? soldier until the last Day of Dec 1781

Robert Mcgee charged as the rest. He stands a prisoner ?capis? Parole that he will appear at Dec'r court next, then & there to answer to all charges heretofore said & that they be laid against him in the mean Time, and in penalty of having his Estate

Samuel Ingram charged as the rest and his sons Jonathan & James voluntarily enlists themselves as Soldiers in the Continental Army until the 31 of Dec'r

1781 upon which the said Samuel Ingram & his two sons property is to be protected whilst he & them behaves well.

W'm Grayson charged as the rest. He voluntarily enlists himself as a Soldier in the Continental Army until the last Day of Dec'r 1781 after which him & his property is to be protected, while he behaves well.

Abraham Beaver charged as the rest. He voluntarily enlists himself as a Soldier in the Continental Army until the 31st of Dec'r 1781 upon which him & his property is to be protected, so long as he behaves well.

Henry Laybrook charged for misbehaviour. voluntarily enlists himself as a Soldier in the Continental Army until the 31 Dec 1781.

Robert King charged for Treason. The Court waved giving Judgment upon it upon his enlisting as a Soldier in the Continental Army until the Last Day of Dec'r 1781 and his pledging his own Estate real & personal; also his Father in law Joseph Robson pledging his Estate, real & personal as Security that thes'd King will find another good and fit Soldier, for the Term as above when Col Preston

Frederick Smith being charged with Treason against the State. But the charge not being fully proven & his son offering to enlist into the Continental Army during the Term for which the Troops are to be raised agreeable to an act of Assembly, lately passed? for Filling up the Virginia Quota. The Court are of opinion that he be admitted as a Soldier & the prisoner is acquitted during the service of his Son.

Robert Henderson is charged as the rest & witnesses being sworn and examined The (blank)

Thomas Downard being charged as the rest & the witnesses being sworn & examined. The Court are of opinion (blank)

Nathaniel Britten being charged as the rest, & the charge being examined into The Court are of opinion that he be sent to Augusta Goal & there to be confined for a further Tryal.

James Keer being charged as the rest & the charge being exam'd into. The Court are of opinion that he be sent to Augusta Goal & there to be confined for a further Tryal.

Jeremiah Patrick being charged, now singly, as the rest, & witnesses sworn & examined & the charge not being fully supported & He offering to enlist himself a Soldier in the Continental Army until the last day of December 1781 The Court are of opinion that he be admitted as a Soldier & that his family & property be protected so long as he remains in the Service & thereafter so long as he behaves himself as becomes a good citizen. (W'm Lockhart disents to this order)

Gasper Reid being charged, now singly, for Treason against the Commonwealth & the charge being examined into & proven, But he appearing to be Sixty years old, & his son David appearing & offering to Enlist into the Continental Army until the last day of December 1781. The Court are of opinion He be rec'd as a Soldier & that during the Term of his Service the old man, his Family & property is to be protected He himself go to the Minds by the 25th of this Month of August & there serve as a Soldier two & a half months from that time.

Samuel Pepper is charged as the rest & (blank)

Abraham Beaver stands charged as the rest & witnesses being sworn & examined The Court are of opinion (blank)

James Bane Sen'r being charged as the rest. But his son Edward coming into Court & agreeing to enlist into the Continental Army until the last day of Dec'r 1781. Whereupon the Court received his son as a soldier & let the old man go. & so long as his Son Serves in the Army his family & property is to be protected and afterward, so long as he behaves as becomes a Good Citizen.

Samuel Sadlon is charged as the rest, But he offering to enlist into the Continental Army, to serve to the last day of Dec'r 1781. Whereupon the Court did not proved to the full Hearing of the charge but received him as a soldier & he took the oath accordingly & so long as he serves as a soldier, his Family & property is to be protected & for ever after if he behaves well.

James Bane Junior? stands charged as the rest But he agreeing to enlist into the Continental Army to the last day of Dec'r 1781 & his Father coming into Court & acknowledging that he will forfeit his estate if his son ?_____? & the s'd James agreeing to forfeit his on the same conditions. The Court are of opinion that he be received & he took the oath during his service his Family & property is to be protected & forever after so long as he behaves well.

AMENDMENT REVISIONS TO THE BY-LAWS

The following amendments were offered to the SVGS and accepted at the September meeting.

ARTICLE II: Membership and dues.

Section 2. Membership in the Society shall be of four classes: individual, family, student, and honorary. Student membership shall be offered to any person attending high school that is interested in the Society's activities. Honorary membership may be conferred upon any person by unanimous vote of those present at any regular meeting. Honorary members shall not be required to pay dues and shall not have a vote in the meetings of the Society.

Section 3. Annual dues of \$7.50, \$10.00, and \$2.50 for individual, family, and student memberships respectively shall be due and payable on January 1 of each calendar year. Members whose dues are not paid by January 31 of each year will not receive the next issue of Virginia Appalachian Notes (VAN). Family memberships shall be furnished only one copy of any newsletter, notices, or other publications. All members will be furnished a list of members of the Society, a copy of the By-Laws, and a copy of the Van to be published quarterly.

Section 5. Subscriptions to the VAN are available exclusively to non-profit and/or public organizations at a rate of \$5.00 per annum if received by January 30 of current year (1981) and future years.

"PATRICKS" WHO SERVED IN CONFEDERATE ORGANIZATIONS IN THE WAR
BETWEEN THE STATES

The following names were found on the microfilm copy of the Consolidated Index to Compiled Service Records of Confederate Soldiers which is part of a body of records in the National Archives designated as Record Group 109, War Department Collection of Confederate Records. The Consolidated Index . . . contains "all the names of Confederate soldiers found in the records used in compiling service records for each soldier."

These compiled service records are arranged according to a complicated organizational breakdown beginning with the state or Confederate Army organization. With the following list, a searcher gains to the compiled service records. Included in these records are abstracts of entries for each soldier found in original muster rolls, returns, rosters, payrolls, appointment books, hospital registers, Union prison registers and rolls, parole rolls and inspection reports.

The first column in the following list is the name of the soldier as it appears in service records; second, the entering rank; third, the final rank; and fourth, the company and outfit with whom the soldier served.

The last section, "Miscellaneous" are those outfits which do not indicate a particular state affiliation. Further research will be required to determine where the original records will be found.

There are definite short-comings to this list: (1) Spelling is as it appears on the records. This causes many problems. One specific problem is that different officers may spell one man's name in different ways, thus causing several different sets of records. Also, nicknames and variant names may also be used. Thus, J., J. J., Joe, and Joseph J. may possibly be the same person. Only a detailed inspection of the compiled records may indicate if this is the case. (2) The Confederate Records are organized by outfit. Thus, if two regiments or batteries consolidated, there is an entry for each soldier in both the old and the new outfit.

Mr. Editor. A few days ago in looking over an eastern paper, I discovered a catalogue of words entitled the "Western dialect," and the "Yankee dialect." The writer is pretty correct so far as he goes; but he has forgotten, or has never been acquainted with many more which might with propriety, have been added to his list; and as he has omitted it, I will beg leave to lay a few before the public, for the information of foreigners.
