LEGISLATIVE PETITIONS

The following is from "Fifth Annual Report of the LIBRARY BOARD of the Virginia State Library = 1907 - 1908", Richmond; Davis Bottom, Superintendent of Public Printing; 1908.

These are abstracts of the legislative petitions in the Virginia State Archives, Richmond, Virginia. A photocopy may be obtained, or, in some cases, a photostat is necessary. There is a minimum charge of \$8.00 on material that is ordered by mail (as of 1980). On petitions where several counties are listed on the petitions, all listed county folders must be checked for the original - one original (signatures) and copies of the petition placed in other counties.

BLEDSOE, ANTHONY.

1777. Dec. 11. A 1534. Payment of balance due petitioner for use of wagons. In September, 1776, he hired the State two wagons for carrying provisions to troops at Great Island and to haul timber for the forts. Upon return of troops from the Cherokee expedition, wagons were used as baggage wagons and petitioner procured a third wagon. He charged State 14s. 6d. a day for each wagon, according to the hire allowed in Cherokee expedition, but auditors made some reductions and petitioner asks that these be made good.

CITIZENS.

1792. Oct. 5. A 1535. Establishment of a town at Warm Springs on the lands of John Lewis, deceased, as the county seat. Place to be called Bathville. Danial Yevins, William McClintick, Thos. Milhollin, John Bollar, John Paul Patteson, John Scott and 164 others. Referred.

LEWIS, MARGARET.

1792. Oct. 16. A 1536. Protest against establishment of town on petitioner's lands at Warm Springs, left her by her husband, John Lewis. By means of this spring, which is visited by many people, she has been able to sustain herself and children since her husband's death.

WILKINSON, NATHANIEL, JOHN CARTER LITTLEPAGE & JOHN OLIVER.

1793. Oct. 23. A 1537. Establishment of a town at Hot Springs. Petitioners have laid off 100 half-acre lots and desire establishment of town for benefit of those who wish to use waters for "scorbutick and rheumatic complaints." Reported.

ROBINSON, JAMES.

1794. Nov. 14. A 1538. Grant of a pension. Petitioner received a wound at the battle of Point Pleasant in 1774, which resulted in loss of hearing in his right ear and rendered him incapable of labor and military service. Certificates of James Persinger, John Dickinson, John Bollar and Robert Gillespey. Reported.

KNOX, HEREMIAH.

1794. Nov. 14. A 1539. Grant of allowance to petitioner for a service of two years six months and 23 days in the 2nd Virginia State Regiment. Certificate of William Long. Reported.

BOWLAND, ELIZABETH, & JAMES BOWLAND & ANNA CRAWFORD BOWLAND, Her children. 1795. Nov. 12. A 1540. Authority for appointment of trustees to sell land in Bath left by John Bowland, who died intestate in 1787. Land cannot be improved; trustees would invest money rising from sale of it in Kentucky. Endorsed by Alexr. St. Clair, John Poage, Alex. Nelson, John Mathews, Matthew Kenney, Wm. Wilson and 7 others. Reported.

LEWIS, THOMAS.

1795. Nov. 25. A 1541. Establishment of a town on lands of petition's father, John Lewis, at Warm Springs. John Lewis laid off lands in lots, proposing to establish a town thereon, but his death prevented. Reported.

CITIZENS.

1796. Nov. 14. A 1542. Annexation of part of Bath in which petitioners live to Pendleton. Jacob Henkle, Joseph Bennet, Jon. House, James Sweet, John Baith, Alexr. Picken and 35 others. Bill drawn.

REAGH, ROBERT.

1796. Nov. 22. A 1543. Divorce from his wife, Martha Meek, on grounds of adultery and desertion.

BROWN, JOHN, Sheriff.

1800. Dec. 5. A 1544. Return to petitioner of \$23.28, which he paid into treasury as costs and interest on a judgment given against him in the General Court. Petitioner was required to pay revenues of 1798, for which he did not know he was bound; he thought that he had given bond to finish the collection of the taxes of 1797, as he succeeded to the office of sheriff on the death of John Oliver. Copy of John Brown's account. Letter of Charles Cameron, Clerk of Court. S. Shepherd's receipt for \$23.28. Bill ordered.

BROWN, JOHN, Sheriff.

1801. A 1545. Return of interest and costs paid by petitioner on a judgment obtained against him. Rejected.

CRAWFORD, WILLIAM, Sheriff.

1802. Dec. 21. A 1546. Authority for auditor to credit petitioner with settlement of accounts for 1801, together with \$92.37, which is the amount of damages, interest and costs paid by him on a judgment given against him by the General Court for failure to pay the taxes of 1800 into the treasury at appointed time. Bill drawn.

DUNWCDY, WILLIAM, Late Major of the 81st Regiment. 1803. Dec. 27. A 1547. Remission of fine of \$30 imposed upon petitioner by a court-martial for alleged neglect of duty. It was charged that he failed to notify the battalion officers in time for muster. Depositions of Captain Stewart Stevens and Captain Robert Given. Reported.

CRAWFORD, ROBERT, Deputy Sheriff.

1803. A 1548. Authority for auditor to credit petitioner with \$9.08, sum allowed by Bath County Court for insolvents and delinquents for the year 1800. Auditor refused to accept the list owing to the lateness of its arrival. List of delinquents and insolvents. Reported.

SITLINGTON, ROBERT, Sheriff.

1804. Dec. A 1549. Authority for auditor to account with petitioner for the delinquent list of 1802, amounting to \$142.51. Reported.

CITIZENS OF BATH & BOTETOURT.

1804. Dec. 27. A 1550. Act establishing the line of Bath County.

John H. Crawford and George Chapman. Reported.

VANCE, SAMUEL.

1805. Dec. 18. A 1551. Payment of petitioner's expenses as one of the commissioners appointed to report on opening the road from upper navigation on James River to Kanawha River. He called a meeting of commissioners at Lewisburg on March 9, but owing to an accident to one James Preston he was detained for nineteen days, and governor and council did not feel authorized to pay his expenses for that time. Two certificates. Rejected.

MAYES, JOSEPH, Sheriff.

1806. Dec. 16. A 1552. Release from damages and costs on a judgment obtained against petitioner for balance of taxes for 1804. Bill drawn.

HICKLIN, JAMES, Late Sheriff.

1809. Dec. 28. A 1553. Release from damages on judgment obtained against petitioner for failure to pay promptly the taxes of 1807. Scarcity of money in country and danger of impoverishing the people were the causes of his seeming neglect. Reported.

FRAVEL, GEORGE, Jr.

1811. Dec. 4. A 1554. Payment of \$26.58 expended by petitioner for benefit of negroes committed to jail when he was acting as jailor. Prisoners murdered Taylor and Schutz in Botetourt but were taken prisoners in Bath; Botetourt and Bath county refused to certify petitioner's claim. Account of expenses. Bill drawn.

DONAVAN, CHARLES.

1811. Dec. 4. A 1555. Release to petitioner of Commonwealth's right in land purchased by him from the widow of Owen Kelly, who died intestate and without heirs. Reasonable.

BRADSHAW, JOHN, & CITIZENS.

1811. Dec. 5. A 1556. Remission of fine imposed upon petitioner by county court for alleged sale of liquor without license. Jno. Lewis, George Francisco, James Naylor, Joseph Wallace, Robert Mauze, Jno. Brown, Jr. and 30 others. Bradshaw's deposition giving names of persons to whom he sold liquor and circumstances of the sales. Rejected.

HANSBARGER, JOHN, & Citizens of Bath & Botetourt.

1811. Dec. 7. A 1557. Inclusion of Hansbarger's house in Botetourt County. John Halloway, Joseph Haynes, Jilson B. Douglas, William Hill, Alexr. Wilson, Simon Gillespie, John Hansbarger and 52 others. Bill drawn.

CITIZENS.

1811. Dec. 9. A 1558. Aid in building road from Hot Springs across Warm Spring Mountain to Fincastle, passing within two miles of Falling Spring. Hot Springs is ten miles distant from Falling Spring, which is twn miles from the junction of Cow Pasture and Jackson rivers, where a market is to be established. At present it is difficult for travellers from the south to reach the mineral springs, but the proposed road will make connection with the main road to Tennessee, North Carolina, South Carolina and Georgia and with the roads to Petersburg and Richmond. Aid may be given road out of public dues of Bath County. John Lewis, Chas. Cameron, John Brown, Alexr. McClintic, J. B. Brown, Robert Kincaid and 155 others. Address accompanying the petition, which states that Legislature granting ample aid for building the road, but the money was appropriated to mending an old road. Bill drawn.

MEMBERS of Bar. Acting Magistrates & Citizens.

1812. Dec. 4. A 1559. Change of quarterly term of county court from second Tuesday in May to second Tuesday in June. Joseph Mays, Alexander McClintic, James Tallman, Chas. A. Lewis, Robt. Gray, John Jordin and 7 others. Bill drawn.

McCLINTIC, WILLIAM & THOMAS MILHOLLIN.

1812. Dec. 15. A 1560. Allowance for petitioner's services in 1810 in carrying eleven slaves charged with murder from Bath to Botetourt County. Botetourt County Court has refused to certify accounts. Seven certificates and accounts. Bill reported.

MANN, WILLIAM, & others.

1812. Dec. 15. A 1561. Pay for petitioners' services as guards in carrying eleven slaves charged with murder to Botetourt County. William Mann, Moses Mann, George Hull, Peter Smith, Josiah Shanklin, Robert Morris, Edward Morris, Andrew Kincaid. Bill reported.

CITIZENS.

1812. A 1562. Authority for citizens in western part of Bath to

hold elections, regimental and battalion musters at some more convenient point that the courthouse. Great inconvenience for inhabitants of Little Levels and western waters to go to courthouse, which is 25 to 50 miles distant. They have preferred not to vote and to pay fines for non-attendance on musters rather than make so great and tedious a journey. John Bradshaw, John Jordin, Richard Hill, John Stumbaugh, Charles Kinison, Jr., John Chitter and 96 others.

KEE, GEORGE.

1813. Dec. 7. A 1563. Confirmation of petitioner's title to certain land given him by his father-in-law, Joshua Buckley. He is a native of Ireland and came to America in 1796; as an alien he cannot hold the said property, but he has served in the militia and he intends to become a citizen of the United States. Reasonable.

McCAUSLAND, JOHN.

1814. Nov. 15. A 1564. Remission of fine of \$96 imposed upon petitioner by a court-martial. Reported.

MORRIS, EDWARD.

1815. Dec. 12. A 1565. Divorce from his wife, Rhoda Morris, on the ground of adultery. Major Moses Mann named as corespondent. Depositions and other papers. Rejected.

WHITE, VALENTINE.

1815. Dec. 14. A 1566. Pay for petitioner's services as clerk of the battalion and regimental courts of inquiry of the 81st Regiment. He was allowed from \$70 to \$96 a year from 1809 to 1814 by courts of inquiry, and he transferred these claims to other parties after they were certified by the colonel commanding. Auditor, however, refused to pay the claims on ground that law does not allow clerks of courts of inquiry more that \$40 a year. Referred.

BLANKENSHIP, JOHN.

1815. Dec. 20. A 1567. Payment of fifty cents a day to grand jurymen for their services. At present men are sometimes summoned from a distance of 50 miles to serve, without any compensation. Rejected.

BLANKENSHIP, JOHN.

1815. Dec. 20. A 1568. Provision for the recovery of debts by persons who are about to move from a county. Also for the recovery of laborers' hire in the same manner as recovery of rents from tenants. Rejected.

McCAUSLAND, JOHN.

1815. Dec. 22. A 1569. Refunding to petitioner of \$96, which amount he was fined by a court-martial. He was a member of a company of light horse under Capt. John Dickinson. In 1814 he went to Rockbridge County on business, having requested Dickinson to notify him in case the company should be drafted in his

absence. He was detained in Rockbridge for sometime and was enrolled in the militia of that county; he later returned to Bath and joined his company. He was thereupon informed that a court martial in Rockbridge had fined him \$96 and he was refused a hearing. In February 1815, his company was called into service and he was arrested at Staunton and forced to pay the fine. Certificate of John Steele, Deputy Marshal. Bill drawn.

INHABITANTS.

1815. Dec. A 1570. A petition supporting the address of the Rockingham meeting of July 4, 1815, calling for a constitutional convention to extend suffrage to all citizens. It is not just that men who pay taxes and serve in the militia should be refused the right to vote. George Happel, Jesse Allen, Jeremiah M'Key, Joseph Allen, William Wood, J. W. Abbott and 72 others. Duplicate with 36 names. Laid on table.

FREEHOLDERS.

1816. Nov. 15. A 1571. Annexation of petitioners to the chancery court district of Staunton in preference to the Greenbrier Chancery District. Present arrangement is inconvenient. John Davis, Walter Richards, John Hoover, Crofford Jackson, Arnold Richardson, J. N. Pitt and 38 others. Bill drawn.

CITIZENS.

1816. A 1572. Appropriation of \$500 for building road across Warm Springs Mountain about 14 miles southwest of Warm Springs. Road will make connection with roads to Fincastle, Lynchburg, Petersburg and south. Two appropriations have already been made for this road but they proved insufficient. Lewis Payne, Franc. Crutchfield, Richard Davis, Jr., Richard Davis, John Oldridge, George H. Payne and 31 others.

CITIZENS.

1818. Dec. 10. A 1573. Improvement of navigation of Cow Pasture River. Sum of \$5,000 was raised by lottery for a seminary at Hot Springs, which was never built, and this money may be applied for the improvement of river. Walter Richards, John Burns, Henry Richards, Chas. L. Kinkead, Wm. Venable, Samuel Corbitt, Jr. and 32 others. Reasonable.

CITIZENS of Bath & Randolph.

1818. Dec. 18. A 1574. Formation of new county from Bath and Randolph. William Edmiston, Wm. Cackley, John McCarty, Andrew Edmiston, John Karns, Valentine Cackley and 230 others. Bill drawn.

ELDERS & Members of Windy Cove Congregation.

1820. Dec. 5. A 1575. Incorporation of elders so that they may receive a bequest of \$1,000 made by Elizabeth Sitlington interest upon which sum is to be used for maintaining a minister. John McClurg, James Hughart, William Crawford, And McCausland, Joseph Turper, Hugh McDonald, Elders, and 8 others. Reasonable.

CITIZENS.

1820. Dec. 18. A 1576. Formation of a new county from Botetourt, Bath and Monroe. John Pateson, John Howard, Conrad Brunner, William Brunnemer, Samuel Carpenter, Wm. McClusky and 366 others. Bill Drawn.

CITIZENS of Bath, Randolph & Pendleton.

1821. Dec. 7. A 1577. Formation of a new county. John McCarty, Francis W. Perkins, Daniel Mattiany, William Campbell, Henry Harold, Lautz Lockridge, Peter Harold and 138 others. Bill drawn.

CITIZENS.

1821. Dec. 7. A 1578. Protest against division of county. Bath, though large in area, contains only 4,000 white inhabitants; it has a revenue of only \$1600. John Mayse, Lud Richards, Henry Richards, W. D. Kincaid, Jno. Fry, Henry L. Culp and 98 others. Reported.

CITIZENS.

1821. Dec. 20. A 1579. Removal of seat of government from Richmond, which last census shows is not the center of white population. More convenient to have the capital in the up country. Chs. L. Francisco, Saml. Gay, John Bratton, Hugh McDannald, Robert Carlile, Jno. Lewis and 22 others. Referred.

CITIZENS of Bath & Pendleton.

1822. Dec. 4. A 1580. Formation of a new county. Samuel Givens, Jr., Jacob Bright, William Benson, John Grim, Jessie Slaven, Reuben Slaven and 214 others. Rejected.

CITIZENS.

1822. Dec. 4. A 1581. Permission to remain in Bath County. Commissioners appointed to run dividing line between Bath and Alleghany counties cannot agree. If line is run according to wishes of Alleghany commissioners, petitioners, to their great inconvenience, will be included in Alleghany County. Thos. McClintic, William McElwer, William McClintic, William K. Tidd, Richard Snead, John Akerman and 49 others. Reports of Commissioners. Rejected.

INHABITANTS.

1822. Dec. 5. A 1582. Removal of seat of government from Richmond to a more central and secure situation. Richmond is easily accessible in time of war; it is rapidly growing in population; its luxurious habits increase cost of government and its climate is less salubrious than that of the upper country, where Legislature could hold summer sessions and sit two hours a day longer. Printed. Norborne Wood, Robert Lockridge, Pat Carpenter, Daniel Monroe, Saml. Vance, Saml. Gay and 38 others. Duplicate with 28 names.

CITIZENS.

1822. Dec. 14. A 1583. Re-annexation of Bath County to the

Augusta Chancery Court district. Attachment of Bath to the Greenbrier district has not proved convenient, as petitioners can better conduct their business at Staunton than at Lewisburg. William McClintic, John Chesnut, Richard Hickman, Abijah Hathery, Jacob Hardway, William Bird and 43 others. Duplicate 1, with 43 names, 2 with 59 names, 3 with 23 names.

INHABITANTS of Bath & Pendleton.

1823. Dec. 4. A 1584. Formation of new county. Difficult for petitioners to reach Bath and Pendleton courthouses on account of mountains and rivers. Samuel Given, Jr., David L. Ruckman, Adam Rees, Otho Wade, Jr., John Bird, Charles S. Callihan and 100 others.

CITIZENS.

1823. Dec. A 1585. Re-annexation of Bath County to the Augusta Chancery Court District. John Fry, George Francisco, William McClintic, Robert Bratton, W. Wilson, Chs. L. Francisco, and 7 others. Duplicate with 38 names. Certificate. Bill reported.

FRY, JOHN.

1824. Jany. 7. A 1586. Repayment of excessive license tax levied against petitioner as innkeeper at Warm Springs. Property was over-assessed and he was required to pay license of \$70 for years, when \$24 was proper tax. Four certificates.

WARM SPRINGS Company & its Tenant, JOHN FRY.

1825. Dec. 16. A 1587. Repayment of excessive tax of \$70 a year on his property. Tenant of tavern was charged with taxes on tanyard, blacksmith shop and other property he did not occupy. Bill drawn.

INHABITANTS.

1825. Dec. 16. A 1588. Vote at spring election on question of holding constitutional convention. Printed. Haz Williams, Robert Sitlington, Van Swearingen, Jr., James Frazer, J. Payne, J. W. B. Stuart and 15 others.

INHABITANTS.

1826. Dec. 18. A 1589. Establishment of turnpike across Warm Springs Mountain to replace present road. Road from Richmond to the west passes by Warm Springs and Hot Springs on to White Sulphur Springs and should be a good highway. James McGriffin, Otho Wade, William Benson, Robert Carlyle, James Mussan, W. W. Cameron and 47 others. Duplicate with 50 names.

MISLED BOOK BUYERS WARN OTHERS

by Margaret Drody Thompson

WARNING has come from several who have been misled into purchasing books they believed were family histories, but were not! They found no pertinent history or pedigrees in an irrelevant collection of information pulled together under the guise of their surnames in the book's title.

There are many credible family histories being published of which their members are proud to own. It is important to know how to identify and safely purchase these. Legitimate family historians will welcome your inquiries and should be able to provide proper descriptions or abstracts that will give enough information for you to determine if the book relates to your family in some way, accurately.

You may also ask for assistance from your local genealogical librarian, genealogical society, or historical society. Try to see a copy of the book prior to purchase either in a library, through another member of the family, or on an "approval" basis.

An Evaluation Guide for Purchasing Family Histories

- . What are seller interests (member of the family)? Reputable? Long-established?
- . Is my satisfaction guaranteed, with adequate return information, if refund is desired?
- Does it meet my needs? What are my criteria? (for instance: are my ancestors in it? How? Does it list their origins? Vital statistics? Is the information documented? Does the book have a bibliography? In other words, are there things included about which you are most curious or that will help your search?)
- . Does the book contain only begets? My pedigree (from me to my earliest known ancestor)? My family tree (my immediate kindred)? Allied lines?
- . Does the book contain only general information that could pertain to any surname in America?
- . Does it contain only general history or is specific history related to my particular family?

If you are actively engaged in research, it is sometimes necessary to own books of surname's lineages to eliminate unnecessary research on the ancestor of unknown decendancy. Or, if you are just beginning research, a book of pertinent lineage can be a touchstone from which you work. There are various reasons for purchasing family history books, and it is important for you to first decide why you want or need a book prior to its purchase, for economy.

Ancestor searching is becoming the popular new hobby of an increasing number of Americans. Memberships in genealogical societies, ethnic associations, and family associations are growing. Unfortunately, however, all this increased interest and monetary outlay is attracting the attention of a few who are interested only in capitalizing in the market, at the expense of the unwary.

Most involved with genealogy as a pastime or a profession are helpful, reputable people, and with a little care and thoughtfulness you can avoid the unscrupulous. A cardinal guide is: It takes time to discover YOUR family history. It is unique! So, take a little time in deciding which purchases will best meet your needs.

CHRISTIANSBURG HISTORY LIES IN RUIN by Mary Bland Armistead *

CHRISTIANSBURG: The way to the venerable Craig Family Cemetery is up a hill from Park Street and through waisthigh growths of thistle and snaggy blue wildflowers.

The path is hardly more than a depressed tracing through the hillside growth.

Once it was pretty well defined, but that was in the day when the old burying ground was in use as "the" cemetery for people of prominence in the Christiansburg area.

Indeed, as Mrs. Roy H Collins points out, lots of older families were buried there, and Mrs. Collins' family was one of them.

Now Mrs. Collins, who lives in Christiansburg, is one of a small group deploring the neglect of the in-town cemetery which has an unknown age, a known historical value and a \$2,500 trust fund set up for its maintenance.

People are wanting to know what's happened to that money; the graveyard has become the victim of vast and heedless abuse.

Mrs. Collins' grandparents, M.F. Akers and wife, are there, and the remains of her great-grandparents, the Anderson Alleys.

But their graves are disgraced by underbrush, their carefully carved markers in shambles. A fallen tree enshrouds the plot in snags and rustling leaves.

"It's a shame the grounds have gotten in this shape," Mrs. Collins comments.

And Mrs. Charles King of Roanoke says, "It hurts me to see this place." In its jumble and desecration by vandals and infrequent care lie her forebears who, ironically, had handed over acreage two centuries ago on which Christiansburg would be built.

Mrs. King, her concern heightened by an unusual genealogical motivation, walks carefully around chunks of stones fallen into honeysuckle, long grasses and old Virginia creeper vines. Under the tangle are her great-great-great grandparents, James Craig and Anne Montgomery Craig, whose home was in Hans Meadows, the territory on the headwaters of Crab Creek where Christians-burg would rise.

The first courthouse Montgomery County ever had was built on land given by this James Craig in 790, and the settlement of Christiansburg sprang up two years later on the rest of his 175-acre gift.

Craig was a patriot and only 18 when he fought in the Battle of King's Mountain. He was given fine lands in the newly formed Montgomery County in recognition for his war services. His son, Robert Craig, served in the Virginia legislature, and was elected later to Congress. Craig County was named for him.

Mrs. King says she was not aware of these historical vignettes until three years ago when she started tracing her Craig and Bowyer lineages. Her research led to Christiansburg, and up the desolate hill, where she found the spot where her ancestors lie.

Two years ago, their grave marker was undisturbed; today it is in fallen ignominity, inscriptions eroded and decorative motifs nearly gone.

And there are graves of other people there whom history should not forget.

Someplace, under giant fir trees swiftly succumbing to age, is the grave of John McHenry, who died in a duel with Thomas Lewis in May, 1808. His grave was never marked; its site unknown today. But it's there.

Thomas Lewis died in that confrontation, too. It was said to be the first duel with rifles known to have taken place in Virginia. It led to the passage in January 1910 of the Barbour Bill outlawing dueling in Virginia.

Lewis, a grandson of Gen. Andrew Lewis who is buried in Salem's East Hill Cemetery, has an unmarked grave somewhere in Shawsville's Madison Cemetery.

There are Confederate veterans in the Craig cemetery, and the grave of Lewis Miller, a Pennsylvania Dutch artist who wandered, notebook in hand, through the mountains and valleys of the land, and left beguilingly vivid sketches of the scenes he saw.

He roamed the Shenandoah Valley, through Big Lick and the Bennett Springs area, and up the mountain to Montgomery County, where he had relatives and places that interested him. He traveled abroad, too, always looking and always drawing, but he returned many times to the Virginia scenes he liked best.

Some of the best of his little pictures are on display in the Abby Aldrich Rockefeller Folk Art Center in Williamsburg, for Lewis Miller has become justly famous.

He was born in York, Pa., in 1796, and made a living as a house carpenter. When his traveling days were over, he made his home with a niece, Mary Sherwood Flagg, who, when he died in 1882, saw to his burial in the old Craig grounds on the hill near her Christiansburg home.

His stone, originally standing tall with an open Bible carved above the letterings of his name and vital statistics, has toppled and broken now, and grasses and wild strawberry vines thread its fallen pieces into a random mosaic.

There are an estimated 50 graves in the area, and in many of them are people who, as Mrs. King points out, "had the most to do with the building of this town."

She shakes her head, "Here they are up on this hill, and neglected."

Mrs. Collins says her family is thinking about clearing its section of the land, "but if the vandalism keeps up, we're not interested." She speaks of "motorcycle gangs riding up here and drinking beer," and Mrs. King points

to the scraggly path -- a short cut to a trailer park on the back side of the hill.

The women are aware of the \$2,500 Flagg trust. They question why it is not being expended on cemetery maintenance.

If the plots and fence lines were cleared, they say, and if the "hiding places for vandals" were removed and the safety of the graves insured, there may be other descendants who will show interest in the place.

"Lots of people don't know they got kin folks uo here."

WYTHE COUNTY (VIRGINIA) CEMETERY SURVEY

by Bruce Anderson

Work has started on a comprehensive survey of cemeteries in Wythe County. The project is sponsored jointly by your Wythe County Historical Society and the Southwestern Virginia Genealogical Society. Bruce Anderson, Jr. is serving as General Chairman of the joint committee to plan and coordinate efforts of members of both Societies and other interested people. Rate of progress will depend greatly on the willingness of volunteers to come forward to help locate and identify cemeteries and to record data from individual grave markers. As work progresses, a list of cemeteries surveyed and names found therein will be made available for publication in the Wythe County Historical Review and the Virginia Appalachian Notes.

To insure that no overgrown, near-forgotten burial site is overlooked, "Old Timers" in our County are urged to volunteer their services to the Committee. As names and locations of burial sites are made known, each will be assigned a serial number and placed on the List of Cemeteries to be Surveyed. Then a Search Team, accompanied by the informant, will visit the burial site and initiate a Cemetery Description form. It's location will be plotted on the appropriate section of U.S. Geologic Survey Map. Informational items to be recorded on the Cemetery Description Form include serial number, name, location (in reference to State and National roads), name and telephone number of the person from whom permission might be gotten to enter the cemetery, level of care, etc. (If anyone voices opposition to entry, the name of the objecting person will be recorded and listing of grave markers deferred.)

Data-taking Teams will perform a detailed study of each cemetery. A Grave Site Location Gride and Grave Marker Description will be prepared. The position of each probable grave site (marked or unmarked) will be marked on location gride sheet by means of a small square. After all sites have been so marked, each square will be serially numbered. Larger cemeteries, say greater than 100 grave sites, will be sectioned and each section assigned a letter of the alphabet.

Transcription Teams of two people each -- one reading and one recording -will transcribe data from grave markers. (Every reasonable effort will be made to assure that vital statistics are recorded precisely as they appear on the marker.) Every name transcribed will be given the same number as the one entered on the grid sheet. (If the cemetery was sectioned, the section letter should precede the serial number.) When more than one name appears on a marker (i.e., husband and wife), the same marker number will be assigned to both names. If no death date shows on the marker, the name will be recorded by the Team. Names of military veterans will be flagged and all military information transcribed. Other non-vital data that might be recorded at the option of the Team include Bible quotations, fraternal order, type of marker, weathering, orientation (i.e., flat on ground or partially buried, etc.). Every Team should inquire about a bag of tricks for locating buried markers and improving legibility of blurred characters. Snapshots and/or "rubbings" are encouraged if time permits.

It is planned that the transcription of data, initiated in the southeastern end of the County, will procede toward the northwestern end. It is anticipated that additional data, over and beyond those acquired by direct transcription, will be offered by interested citizens in the County. White it would be highly desirable to record indirect data, lack of manpower and facilities have precluded creation of a system for such.

Presented below is the first report of work performed by the Cemetery Survey Committee. These cemeteries are located in the southeastern edge of the County along its border with Carroll and Pulaski Counties. Each name and date was taken from a grave marker. In order to improve readability, a uniform format has been adopted and most non-vital data deleted. Surnames have been placed in front of Christian names and dates are cast in the DAR-preferred military form. Also omitted from this list are those names for which no death date shows on the marker. Where military service is indicated on the marker, an asterisk has been placed opposite the name.

(Editor's note: The cemetery records mentioned above will be in a later issue of VAN. We thought that the members would like to have a report on what is happening and maybe someone out there will know of a cemtery that has been "forgotten" and will let Bruce know about it.)

FLOYD COUNTY A HISTORY OF ITS PEOPLE AND PLACES

by: Dr. Amos D. Wood Edited by: Ann Scott Swain

In compiling the history of Floyd County's people and places, Dr. Wood drew on the memories of the old timers in the area. Civil War veterans were still living when he began this endeavor and their recollections are a vital part of the book.

Patriotism is highlighted by references to veterans of the Revolutionary War, the War of the Rebellion and the World War (I). Close family ties are evident in the location of homestead and the intermarriage of families in communities. Education is shown to be highly desirable by those that acquired it and became "well known". The establishment of various churches is recorded.

Over 100 families -- Brammer, Graham, Lancaster, Lawrence, Phillips, Phlegar, Scott, Short, Spangler, Turner, Vest, Wood and many others -- are sketched in detail, some at greater length than others. Thousands of names are recorded. How familiar places and watercourses in the county were named is related -- truth or fiction is not known!

The author used family manuscripts, personal letters, diaries, Bible records, court records, questionnairies and genealogical publications available in the 1920's to trace family connections. On the lighter side one will find reminiscences of bygone days, poetry, superstitions, some folklore and amusing anecdotes.

Through the study of birth and death rates is shown that many young children succumbed to infectious disease. Although Floyd was never a "plantation county", it seems the early homesteads were aided by slaves.

The editor has compiled a bibliography of books and sources used by Wood and also listed those written about or by Floyd countians.

1853-1872 BIRTH AND DEATH RECORDS FLOYD COUNTY, VIRGINIA, and THE ZION LUTHERAN CHURCH REGISTER

compiled by

This is a register of births: white, black, male, female, date and place of birth, parents and informant. The register of deaths is white, black, male, female, date of death, cause of death, parents and informant.

The records of the Zion Lutheran Church are of historic value. The data compiled involved transactions from the German script. The Church records were written and this is a rough translation. The Church was organized in 1813 under the authority of the Evangelical Lutheran Conference of the State of North Carolina. The travelling preachers were B. G. Miller and J. Scherer. The cover sketch is from a watercolor by V. Simpkins of the Primitive Baptist Church built about 1831. The book has been given the Southwestern Virginia Genealogical Society and has been placed in the Roanoke County Public Library, Electric Road.

Also, he and his brothers were the only Buckinghams in the area at that time, but they were in Carrol, Wythe, Pulaski and Montgomery counties. Only Lewis A. Was residing in Floyd County." Richard W. If you feel you cannot type well, please type the material with double space. Please read the material over before sending it and check all dates.
- 2. Give source of material. Original documents where found, type, number of page, etc. We cannot print material from printed source unless we have permission from the author.
- 3. Deadline for submitting material is the first of the month previous to the month of publication.
- 4. Material contributed will not be returned unless accompanied by a stamped self-addressed envelope.
- 5. We welcome all family histories (may have to be edited due to space) copies of court records, Bible records, etc. That little bit of information may be of help to someone. Of course, we cannot promise next issue publication.
- 6. On family histories, our policy is to print prior 1900 -- much as we would like to carry forward the modern day generations it uses too much space.

NOTE: We cannot vouch for the accuracy of the material submitted to us or that the "translation" of the original document is true. If you have read such material, you can understand.

QUERIES:

- 1. Unless queries are to be used as fillers, submit one at a time. Since this is a quarterly, queries not used when originally submitted may become dated and of no value to the writer.
