HERALDRY. THE ART AND SCIENCE OF BEARING ARMS

"Azure a chevron argent between three mullets of the second." That is the everyday language of the heraldic artist, the artist who specializes in HERALDRY, THE ART AND SCIENCE OF BEARING ARMS. This language is descended from an archaic French which, in this case, describes a coat of arms of the Hilliard family. In translation, this describes a blue shield with a silver chevron between three silver star-shaped figures. The chevron takes its shape from an ancient roof-tree and is frequently borne by those who have built fortresses or churches, and the star-shaped figures refer to the rowel of a knight's spur.

In heraldry colors as well as figures have a significance. In this case, blue denotes truth, loyalty and patriotism, while silver is symbolic of purity, peace and sincerity.

There are five basic colors used in heraldry. They are red, blue, green, black and purple. In addition to these basic colors, the metals silver and gold are also used. The color of some charges or objects found on arms is described as "proper." This means that they are shown in their natural or normal colors.

In British heraldry especially, most coats of arms consist of at least one of the five basic colors and one metal, displaying either a colored object on a metallic background or a metallic object on a colored background. The main reason for this is that the shields were then easier to see, thus allowing the knight, dressed in full combat regalia, easy recognition by both his enemies and friends. Otherwise, covered from head to tow with a suit of armor and helmet, the knight could never be identified.

The term "coat of arms" very logically derived from a fabric coat or cloak the knight wore over his suit of armor. This coat displayed the same figures and colors shown on the knight's shield. It served both to identify the knight and to protect his armor from the hot sun and cold weather.

The coat of arms as we display it today consists of the shield, the helmet, the crest, motto and lambrequin or mantling. Some are shown with animals or other figures on each side of the shield supporting it. The mantling — the design shown around the helmet and shield — represents the mantle or cloth-covering the knight wore falling from his helmet around his neck and shoulders. This also helped to protect his metal helmet from the hot sun and cold wind. The inside of the mantle is shown as the primary metal of the shield and the outside is shown as the primary color (being the cloth) of the shield. The divisions seen in the mantle represent the cuts and slashes the knight received in his mantle from his enemy's sword.

Who has the right to display coat armor? Technically, the countries where arms are actually granted, only the person to whom the arms was granted and his direct heirs could bear the arms. Since Americans cannot be granted arms by our government, we, in a manner of speaking, "adopt" the arms from

a known ancestor who had been granted an arms. In this case, one should have evidence of his family's connection to the original bearer of the arms. There are books that list American families which are directly descended from those Europeans who were granted arms.

Heraldry, in one sense, dates back to the dawn of the history of man, for when the first primitive man marked his crudely-made shield in such a way as to identify himself, heraldry was born. But the <u>science</u> of heraldry never reached its peak until the Middle Ages, especially during the Crusades (from 1096 to about 150 years thereafter), when thousands of European knights, footsoldiers, churchmen, and even kings, joined ranks to go to the Holy Land to rescue it from the infidel Saracens who had occupied it.

The French were primarily responsible for establishing the science of coat armor. Even today the descriptions of arms from which heraldic artists work, though in English, have retained the original sentence structure and many - now archaic - French words.

One outstanding continental European authority on coats of arms is J.B. Rietstap, while Sir Bernard Burke is one of the authorities on British arms. Some other authorities on heraldry are: Fairbairn, DeBrett, Wade, Boutell, Scott-Giles, Bolton, Crozier.

While the majority of continental arms were granted to royalty and the aristocracy, the British granted arms to nobility and commoner alike.

An interesting story, whether true or not, tells of a farmer working in his fields one day. He suddenly heard a lady's screams for help coming from the direction of a nearby stream. Upon arriving at the edge of the stream, he discovered a lady rider who, while crossing the stream, had been thrown from her horse into the water. In order to save her from drowning, he dashed into the water, grasped her by her riding girdle or belt and began to pull her from the water. In fear and desperation, she screamed to him, "Hold fast, hold fast!" while he pulled her to the bank and safety.

Since she was a lady of noble birth and from a family of high standing and influence, as a reward for saving her life, he was granted a coat of arms bearing three buckles representing the buckles on her riding girdle and a motto quoting, "Hold fast!"

Many coats of arms have a story behind them, and often, wherever possible, display figures making a play on the family name, such as the three bulls' heads on my own family coat of arms. Heraldry is both a fascinating and revealing art and science.

* * * * *

MARRIAGE RECORDS

The personnel in the Court House at New Castle, Craig Co., Va., told me that the following marriages were not recorded in the marriage register. I did not get a chance to check the register, so I do not know if any of them are recorded. During the Civil War, the Union Army was in New Castle and burned many of the books and records of the county. After the war, the Clerk of Courts reconstructed the record books -- no one knows how many records were not recorded because of lost of original documents or death of the people involved.

Please remember, if possible, get a copy of the original document -- I am no expert in reading the handwriting. I can come back later and decide that it should be something else.

The following is a copy of (A) Certificate to obtain marriage license, (B) Minister's certificate of Marriage, (C) Marriage License, and (D) the minister return has not been included because usually it was just a written note or included in the Minister's Certificate of Marriage.

Most of the older record books of Craig County are of blue paper and the ink has faded to a brown, so it almost impossible to zerox the pages. If copies are required of deeds, wills, etc., the records will have to typed. The marriage records copied should be easy to 'zerox' -- just remember that each type of document is a separate page.

New Castle (where the court house is located) is a small town and there are a couple of quick order places to eat. One is across the street and down from the court house and the other is on the edge of town. The clerk's office is small but the personnel were very pleasant (when I was there).

GIDEON MACON OF VIRGINIA AND SOME OF HIS DESCENDANTS

compiled by

Aletha Jane Macon

The Macon family of Virginia began with Gideon Macon, and English citizen of French parentage, who became identified with the prominent people of the New World and founded a family which has played a not unworthy part in the history of our country.

The earliest definite references to Gideon Macon are found in the Court Records of York County, showing that he was attorney-at-law in the county as early as 1671. He was an Indian interpreter and served as secretary to Sir William Berkeley, Governor of Virginia, during his second administration which ended in 1677. It seems that Gideon Macon arrived in Virginia about 1670 and that he was at that time in his early twenties; so that the year of his birth was about 1648.

In religious affairs Gideon Macon seems to have taken an active part and is listed as one of the earliest vestrymen of Bruton Parish Church, which still stands in Williamsburg, Virginia.

He owned extensive acreage in New Kent, Henrico, and King and Queen Counties. About 1680 he married Martha Woodward of King William County. Gideon and Martha Woodward Macon were the parents of eight children, four sons and four daughters, Gideon Macon Jr., Anne, Martha, William, John, James and two daughters, whose names were unknown.

The first section of the book gives eight generations of the Macon family and one chapter of recent generations. The second section develops the Allied families of the Macon family which includes the families of Green, Grimes, Hunt, Jack, Jones, Thorn and Woodward.

There is a bibliography and an index of 46 pages of individual names. This is a revised edition of the 1956 Aletha Jane Macon edition by Arthur Jarvis Wood, Jr, 1979 and published by the Wilkes Publishing Company, Inc. 1981, Washington, Georgia. A PLACE APART

A BRIEF HISTORY OF THE EARLY WILLIAMSON ROAD AND NORTH

ROANOKE VALLEY RESIDENTS AND PLACES

Mark Evans arrived in the Big Lick area and Roanoke Valley about 1744 from Pennsylvania. He married Katherine Thomas on June 17, 1723 at Christ Church in Philadelphia. With thousands of acres from which to choose, he took his time and chose well lying fertile land fed by gushing springs. He built his upended log home at Evans Spring.

Mark Evans died at Evans Spring in 1748 leaving his lands to three sons, Daniel, Nathaniel and Peter. His original grant was 1200 acres, but later by survey proved to be 1910 acres.

There are a number of descendants of the Evans family in the Valley. Mr Charles Burton of Botetourt County is a direct descendant of Peter Evans. Early owners of the Evans tract were James Breckinridge, John C. Griffith, Charles Johnston and William Watts.

Early families that followed and contributed to the area were Betts, Bushong, Campbell, Cannaday, Fellers, Fleming, Garst, Harshbarger, McClanahan, Moomaw, Nelms, Nininger, Oliver, Petty, Read, Rudd, Stokes, and Williamson (for whom the Williamson Road area is named).

Community builders of the Williamson Road area continued to arrive at the turn of the century. Some of the family names were Andrews, Bowman, Coulter, Epperley, Hansbrough, Huffman, Hunt, Lemon, Prillaman, Riley, and Woodson.

Miss Prillaman brings the early days of the area to life with her many pictures and sketches -- Black Horse Tavern and "Bellvue", The Barren's Mansion, Guildhall, "Greenridge", "Old Bushong House, Tombstone Cemetery-The Denton Stone, Grayholme, Huntington, Monterey and many others.

The book has 187 pages and is completely indexed.


