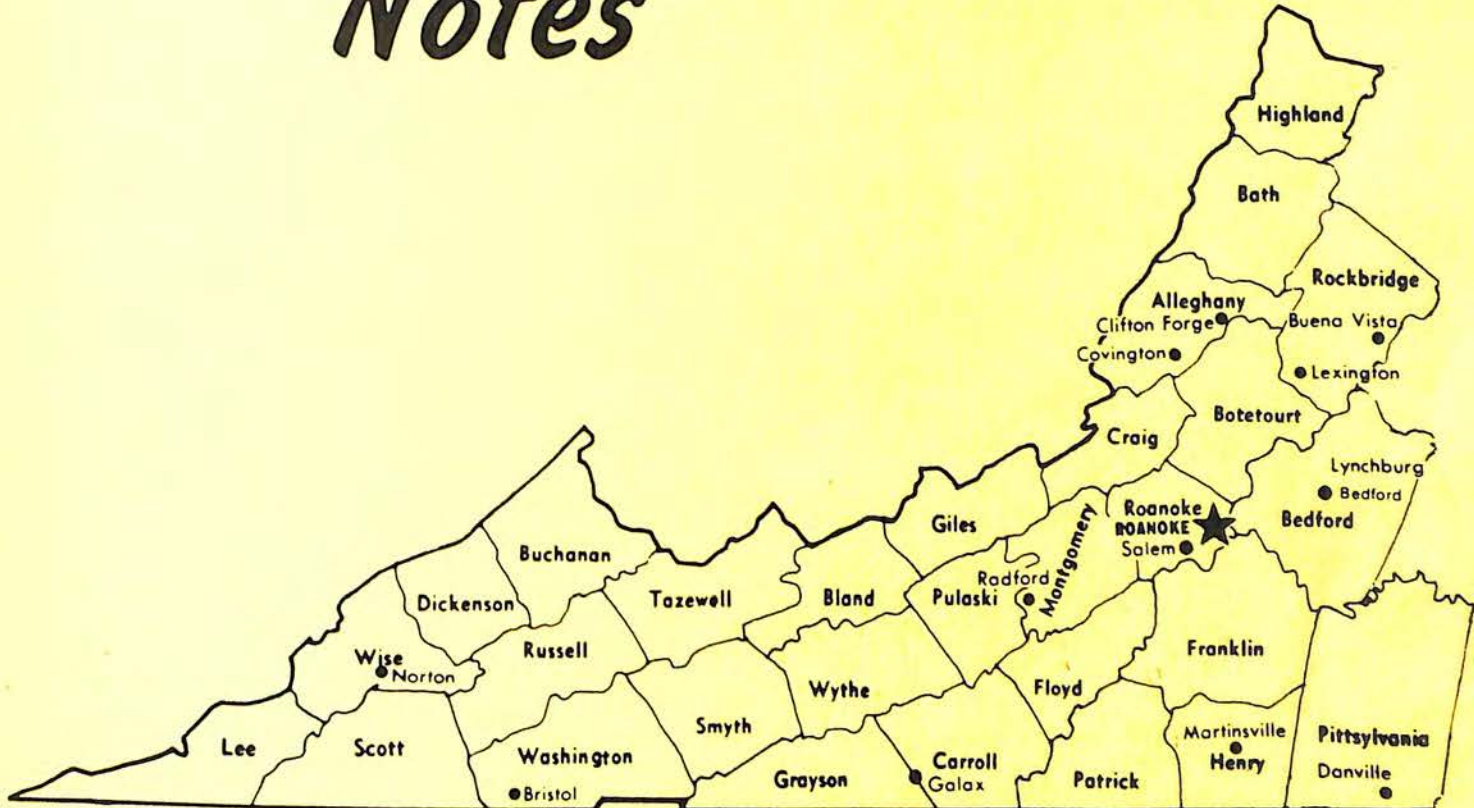

Mrs Mary Taylor, mother of Att. Gen. J. C. Taylor, died at her son-in-law Rev. C. A. Miller Friday evening....77 years.....

July 20, 1900:.....8 inst at Harlan Court House, Kentucky, W. S. Palmer of Big Stone Gap & Mary Elizabeth Moore of Crab Orchard married...daughter of J. H. Moore.

July 17, Christiansburg..Dr. W. H. Pepper died...born Germantown, N.C...1813...87 years...came here 45 years ago...married Annie Elizabeth Taylor daughter of Creed Taylor & sister of Gen. James C. Taylor ....leaves one son, J. W. Pepper of Snowville, and one daughter miss Minnie Pepper, both single...wife died 5 years ago....

Aug 31, 1900: We are sorry to note that our townsman, Mr Walter Moore, continues seriously ill.

*Our friend, Mr Joseph Branch, who moved to Bedford City, some time ago is again with us trying to rent or buy a farm. He says that he has travelled a great deal & that he has not found any place that suits him like old Montgomery County.*

....death of W. W. Stuart of Floyd Co., brother-in-law of Thomas L Moore...accident on Court day in Christiansburg.

Sept 7, 1900: ...Harman S. Keister died, residing on New River, ca 56 yrs.

Oct 19, 1900: Mr John Thomas of Elliston died this week & was buried in the Big Springs graveyard.

Oct 26, 1900: Burial of Moses Hoge, father of Mrs Rolin Woolwine, 81 yrs.

From the manifestations given through the newspapers, and from what I hear, from citizens of the District, passing through Washington, the chief difference of opinion among your candidates, is, that some are in favour of remodelling every thing, while the others are for sweeping away every thing and a little over with it if not sooner. Reform is necessary and proper, but it is a very unfortunate, to mistake all change for reform. It is very important, I think for the People to select men of

Many things seem defective as our constitution now stands and a rush will be made upon them, but it <sup>will</sup> depend greatly upon the character of the substitutes adopted in their place ~~whether~~ we shall be benefited by a change or not. MADISON COUNTY: 200 YEARS IN RETROSPECT by Madison County Historical Society. "Madison County, Kentucky, located astride the path of early western emigration in the latter part of the eighteenth century, fell under the whole gamut of pioneering experiences. Essentially it was one of the earliest points of destination of the human movement into Virginal Kentucky by that great in-rush of emigrants from Virginia and the Carolinas. Its early history is inseparable from that of Cumberland Gap and the Wilderness Road"

For over two years Drs. William E Ellis and H E Freeman of Eastern Kentucky University wrote the chapters, Madison County Pioneer Days, 1775 - 1850 and Madison County Growth and Maturity: 1900 - 1985. Dr Richard D Sears of Berea College wrote the chapter, Madison County, the Middle Period, 1850-1900.

The Madison County story is covered in a 450 page book, attractive dust jacket, foot notes, bibliography, index, 90 photographs, hard bound, colorful personalities as Daniel Boone, Cassius Clay, John Fee, and the Burnam family -- the establishment of Berea College, and Eastern Kentucky University and their impact on the development of the county. He was in Stanford, Connecticut, as pastor 1644-1694. William Tolman, born 1608 in England, to Mass. in 1630. William Hewitt, born 1745 England, in 1781 married Sarah Krieg in New Hampshire.

Lewis Conley Bishop, born 1818 Indiana, father of thirteen children: step-father of five.

Allied lines: Whited (Whitehead), Tolman, Branen and others: Adams, Allen, Beadel, Branen, Brown, Buckner, Burnside, Cain, Camblin, Chappell, Coffin, Cunningham, DeBusk, Dunn, Frey, Franklin, Gerloch, Glover, Griffin, Hayes, Howard, Kincaid, Kennedy, Koresky, Lambert, Lewis, McKee, McNare, Petty, Peterson, Scott, Sharp, Smith, Starr, Stone, Surber, Tolman, Wallace, Whitehead, Woche and others.
