

The Place Namers

The little known agency that tried to make Pittsburgh drop its "h" has had successes too

At first we throught that we would omit some of the article but on rereading it, we could not decide just what to omit - so here is the article in full. Our thanks to the American Legion magazine.)

Not so long ago a group of federal officials assembled around a conference table in Washington and literally made a mountain out of a mole hill. This happened at a regular meeting of the Domestic Names Committee of the US Board on Geographic Names and one of the agenda items was a request from the town of Mole Hill, WV, that it be renamed Mountain. The Committee considered the matter and sanctioned the change.

But if there are moments of lightness in BGN proceedings, it is not a fun-and-games operation. The Board is the arbiter of the nation's nearly four million placenames and of the federally-accepted version of the uncounted millions of foreign names, including the labels pinned on topographic features on seabeds and on extraterrestrial bodies. With a mandate extending from the smallest crossroads hamlet to the far side of distant planets, its decisions affect legal, political, economic, academic, and even military matters.

At the outbreak of World War II, when the US urgently needed worldwide maps with standardized place-names to forestall confusion among its own forces and between itself and its allies -- a monumental undertaking complicated by the requirement for devising ways to render in the Roman alphabet such non-Roman systems as Japanese, Arabic, Chinese and Russian -- it was BGN that leaped into the breach.

Remarkably, BGN has achieved the ultimate state of grace that zealots of economy in government dream about. It has no staff, no budget and no facilities of its own, at least in a technical sense. It exists entirely on no-fat-on-the-bone handouts from other federal agencies. The Board's operations are directed by Dr. Richard R Randall, who also serves as geographer of the Defense Mapping agency, assisted by a staff of 27 who are carried on Department of Defense and Department of Interior rolls. They work out of a handful of offices scrounged from the US Naval Observatory and from the US Geological Survey.

It is entirely fitting that the Board should be unique among government agencies — it was created to cope with a unique situation. It stemmed from the long-ago day in 1513 when Ponce de Leon made landfall off a peninsula in the New World and dubbed it Florida, the oldest geographic name of European origin still in use in the nation. "Ponce de Leon started the country off on a naming jag that never ran out os steam," Dick Randall observes. "Few who followed in his footsteps were immune to the bite of the place-name bug."

Explorers, settlers, soldiers, woodsmen, all showered the face of the land with whatever geographic labels struck their fancy.

Take, for instance, the Spanish explorers in what would become Colorado, who named a river El Rio de Las Animas Perdidas en Purgatorio, "the river of souls lost in purgatory, "because many of their party were slain there by Comanches. French trappers who followed the Spaniards truncated the long, storytelling name and gave it a French accent by recasting it as Purgatoire. English-speaking settlers altered it once more, making it more comfortable on Anglo-Saxon tongues by transmuting it to Picketwire.

Or consider the place in Massachusetts that the Indians called Shamut. When the white men arrived they ignored Shamut and adopted Trimountain in its stead, but only 10 years later they dropped Trimountain and replaced it with Boston. To the south was a Connecticut site that Indians called Quinnipiac after an adjacent river, but Dutch surveyors laying out a town there chose a new name, Rodenberghen. When the English displaced the Dutch they erased Rodenberghen from the map, restoring Quinnipiac. A short time later they had second thoughts and relabeled the place New Haven.

After the westward expansion began in earnest, place-naming went from fever to epidemic, often with bizarre consequences. Settlers putting down their roots at the mouth of the Licking River in Ohio christened the place Columbia but almost at once a scholar among them engineered a switch to a new name he coined. His linguistic invention started with L for Licking River; then added "os", Greek for "mouth"; "anti," Latin for "opposite"; and 'ville', French for "city"; ending up with Losantiville -- "city opposite the mouth of the Licking River." Two years later, General Arthur St. Clair, governor of the Northwest Territory and devoted member of the patriotic Society of the Cincinnati, arrived for an official inspection. His first words were, "Damn it, Losantiville is a terrible name. Change it to Cincinnati."

If St Clair was forthright, Archibald Yell was devious. Yell, running for Congress from Shawneetown, Ark, was being pressed by a local rival for the same seat. Theorizing that if he could get Shawneetown to rename itself for him the resulting publicity would translate into votes, Yell slipped \$50 to some go-betweens to promote the switch. The ploy worked and Shawneetown became Yellsville. It would be nice to say that tainted politics never succeed, but the truth is that Archibald Yell of Yellsville went to the nation's capital.

Slowly it began to dawn on government officials that the nation's haphazard, free-wheeling approach to place-naming was tripping it up. So many places had dubbed themselves Lafayette to honor the Revolutionary hero that mail, goods and travelers were forever ending up in the wrong one. Ensared in the tangle, harried postal

authorities cried out, "Enought! No more Lafayettes!" This was a challenge many could not resist -- there was an outpouring of such variants as Lafayette Hill, Lafayette Springs, Fayette, Fayette City and Fayetteville.

Even if the Frenchman had stayed home there still would have been plenty of thorms in the thicket of American place-names. There were scores of Washingtons, Franklins, Manchesters, Newports, Alexandrias. Fifty places were named Cedar. Seventy-five were named Summit and 20 states had more than one Summit within their borders. Indiana had two towns named Scipio only 50 miles from one another. Mount Tabor, NC, and Mount Tabor, SC, were confused with one another so consistently that in desperation the South Carolinians dropped their Mount and turned their Tabor backwards to become Robat.

To make a bad situation worse, numerous places went by several different names simultaneously. To begin with, a town would have the title adopted for it by its municipal authorities but its post office might, and frequently did, bear a quite different designation assigned by postal officials. Meanwhile, its railroad station often bore yet another name bestowed by the railroad serving the town, and, if there were a local military post or lighthouse, the departments responsible for them might list their locations by place-names unique to them alone. Finally, if the community served as a county seat, the county authorities often had their own designation for the place, as in the case of the West Virginia town that county officials insisted was Raleigh Court House, while the city fathers were adamant in proclaiming that it was Beckley.

Alarmed by the topsy-turvy situation, President Benjamin Harrison issued an executive directive in 1890 creating the US Board of Geographic Names to bring order out of the chaos. It was that directive that established the Board's unique position as Washington bureauracy's scrounger, because in it Harrison specified that BGN "shall entail no expense on the Government." He appointed 10 members to the Board from other federal departments, instructing the parent bodies to continue their salaries. He had not, of course, invented a way of creating a cost-free agency, but by having others foot the bill he played a budgetary shell-game that produced that illusion.

In its first year, BGN tackled two different tasks. First, it devised a set of principles for the form and spelling of place-names. Second, it considered 2,000 cases in which places were identified by more than one name and decided which was the proper designation.

The decision was usually accepted calmly enough because BGN tried, with reasonable success, to select the name enjoying widest usuage and strongest public support. If it ignored local wishes -- as it did when it chose Porto Rico over Puerto Rico -- the cries of protest were instantaneous and loud. In the case of Porto Rico the cries did not abate for nearly 50 years until Congress, taking the matter out of the Board's hands, passed a bill restoring the name to Puerto Rico. On the whole, though, BGN's efforts to hack clearings through the wild linguistic growth usually went fairly smoothly.

It was a different story with the principles laid down for the place-name forms. Nobody quarreled with the objectives: simplification and streamlining. It was the way the goal was to be achieved that raised hackles. Most of the objections focused on two BGN edicts: that names ending in "burgh" drop their 'h' to become "burg" and that apostrophes be eliminated so that a place like Miller's Lake would become Millers Lake. Of the two, the 'h' drew first blood.

There were at that time a half-dozen towns around the country that had styled themselves Pittsburgh in mimicry of the original in Pa. They groused for a while and then, concluding that resistance was futile, dropped their 'h' to become Pittsburg, The Pennsylvanians were made of sterner stuff. It was not just pride of authorship, but more because many of the early settlers were Scots. In fashioning their municipal title they had given it a typically Scottish ending of 'burgh" to remind of their heritage. If "burg" was unmistakably German -- as in Hamburg and brandenburg -- and the Pennsylvanians balked at hiding their Scottish light under a German bushel. So they dug in their heels and fought the BGN edict, backed by a vigorous editorial campaign in the local press. Federal maps, documents and post offices dropped the city's 'h' but residents stubbornly continued to use it in all correspondence. Municipal leaders enlisted the aid of Pa.'s congressmen to pressure the Board to reverse its ruling, but it declined.

Both sides were adamant and the stand-off persisted year after year. Not until 1932, in a report to President Hoover, did the Board wearily raise the white flag of surrender, conceding that Pittsburgh was entitled to its 'h'.

The seemingly innocuous apostrophe was to become as troublesome for BGN as the 'h'. At first it seemed that the public would agree docilely to relinquish its apostrophes. In one year alone -- 1894 -- postal authorities industriously pruned 1,665 apostrophes from post office names. Mapmakers, railroads, educators, editors and publishers fell in line, snipping away at the grammatical mark. The affected places themselves, bowing to the inevitable, followed suit. Except Martha's Vineyard, Mass.

The Vineyarders doted on their apostrophe. It had been theirs ever since 1642 when Capt. Bartholomew Gosnold discovered the island and named it for its lush growth of will grapevines and for his daughter, Martha. The Vineyarders refused resolutely to relinquish their three-century-old apostrophe. Flaunting it like a battle flag, they counter-attacked through the press, through citizen lobbies and through their elected officials. It took a long time but ultimately, like the Pittsburghers, they were victorious. By coincidence, it was in its 1932 report to President Hoover -- the same one in which it tossed in the towel on the Pittsburgh 'h' -- that the Board announced its surrender on the Martha's Vineyard apostrophe.

With the files closed on those two nagging issues, the BGN staff breathed a collective sigh of relief. It was premature. A new storm broke out in the north.

Thompson's Point, VT, had been stripped of both its apostrophe and its 's', being converted to simply Thompson Point. Never reconciled to the amputation, the residents now launched an offensive to recapture their missing linguistic parts. The Board refused to lift its ban but the voices of protest would not be silenced. Finally, in 1964, BGN relented to the extent of restoring the 's' while holding fast to the apostrophe. Thompsons Point was only a half-victory that did not satisfy the Pointers; they continued to press their campaign. Four years later, the Vt. legislature joined the fray officially by voting unanimous approval of Thompson's Pint, with the cherished curlicue firmly in place, as the town's authentic name. The Board was unmoved by the action. The matter is still unresolved, both sides still entrenched on opposite flanks of the disputed little mark.

"I know it must make us sound like bureaucratic nincompoops," Randall says ruefully, "but there is good reason for our obstinacy. We ban apostrophes in place-names because on a map they can be misread as topographic marks, causing confusion. This is especially true on nautical charts where an apostrophe is often mistaken as an indication of rocks."

The fact is that as the nation's arbiter of its place-names the Board frequently finds itself in a damned-if-we-do-and-damned-if-we-don't dilemma. Cape canaveral demonstrates how it can wind up in a no-win situation. In 1963, Pres. Lyndon Johnson asked BGN to redesignate the Fla. cape as Cape Kennedy to honor his assassinated predecessor in office. Complying with the White House request, the Board made the change. But Canaveral was so firmly entrenched among Floridians that they refused to go along with the switch. The issue was debated in the state legislature which voted for retention of Canaveral as the authorized name for all except the portion of the cape under federal control for operation of the space flight center. Later,

when Pres. Johnson was occupied with other problems, BGN quietly rescinded its order.

Involvement in place-name disputes is no novelty to Dick Randall -- he was born into one. At the time of his birth, Seattle was rent by a move to rename Mount Rainier, its famous landmark, a proposal the Randalls opposed vigorously. "That mountain was named for an ancestor of mine; in fact, my middle name is Rainier," he explains. "So I am delighted that we balked the change."

One recent change that did go through brought Randall and his colleagues at BGN a spage of good-natured ribbing, including coast-to-coast quips by Johnny Carson on the 'Tonight' show. It grew out of the Board's laudable undertaking to eliminate offensive or derogatory place-names, an effort that has erased such indignities as Jap Mountain. (BGN, however, achieved only cosmetic improvement with another mountain; resistance to elimination of the earthy name of this outhouse-shaped rock formation was so strong that the Board succeeded only in truncating it to S.H. Mountain.) What drew the recent coast-to-coast chuckles was BGN's treatment of an Oregon site noted for an establishment where the world's oldest profession was plied. The Board altered the place-name from Whorehouse Meadow to Naughty Girl Meadow.

But a current place-name issue is not generating chuckles for anyone. It arises from an Alaska request to BGN to revert to Mount McKinley's original Indian name, Denali. Because the modern name of the continent's highest peak honors the Ohioborn 25th president, the Ohio Congressional delegation has risen in defense of its native son. At present the controversy is swirling through the halls of Congress, with both Alaska and Ohio pressing for support of their opposing points of view. Hoping it will not be scorched by this political hot potato, the Board is maintaining a discreetly low profile in the matter.

In an average month the Board renders some 100 decisions on domestic place-names and those generating the heat of a Pittsburgh, a Canaveral or a McKinley are the exception. That is fortunate because now BGN faces a challenge from abroad that is taxing its lean resources -- Pinyin, the new system adopted this year by the People's Republic of China for rendering Chinese names in the Roman alphabet. Pinyin confronts geographers with complexities on a par equal with those most of us would face if suddenly we had to adopt the metric and Celsius systems in place of our familiar units of measurement. In Pinyin, Peking becomes Beijing, Canton becomes Guangzhou, Sinkiang becomes Xinjiang, and Tibet is Xizang. "It's the biggest problem we've ever faced," Randall exclaims. "We have to alter all our place-names on China as the Chinese release the new Pinyin forms. We are working on the 18,000 they have released so far but the total will probably run over a million."

The arrival of Pinyin can bring no cheer to Vermont. Confronted by the enormity of its Chinese challenge, the BGN is unlikely any time soon to reconsider the plea for restoration of the Thompsons Point apostrophe.

These volumes are found in the Manuscript Room (Rare Book Room) at the National Archives, Washington, DC. The Ist Report is a small volume, the 2nd Report has 200 pages and all place names are in alphabetic order and I did not have time to go completely through the book. The US Board of Geographic Names (formed 1890) was created to devise a set of principals for the form and spelling of place-names and 2nd, it considered 2,000 cases in which places were identified by more than one name and decided which was the proper designation. The following are some of the Virginia place names that were and what they were changed to.



JOHNSTON'S LETTERS

I recently read through one of the volumes of the "Draper Manuscripts", which are on microfilm. This manuscript collection includes letters written to Lyman Copeland Draper, the great historian. The entire collection is indexed in the book "Guide to the Draper Manuscripts", by Josephine L Harper, 1983.

The volume I read was from Series C, the Daniel Boone Papers. Some of the letters were written by Thomas Colley Johnston, of Abingdon, Va in 1884. Mr Johnston was the great-grandson of my ancestor, Thomas Colley (b ca 1740), who fought with Gen William Campbell in the Battle of King's Mountain......

Excerpts from letter to Lyman Copeland Draper from Thomas C Johnston of Abingdon, Va. Letter #31 dated August 7, 1884 (letter regarding John Broady)

He lived and died about 600 yds above my grandfather <u>Elder Thos Colley</u>, on the North Fork Holston River, and about 1 3/4 m. NW of Saltville. When a child, many a time <u>Old John</u> carried me up home, a back from my grandf's. - But here we enter upon a historic vacancy in the biography of <u>Gen Wm Campbell</u>. But who were the <u>Colleys?</u> By the side of great mental(?) me we have "the Colleys" as great physical men. <u>Tom. Colley</u>, no. 1 in Wales, a powerful man, manager of an iron foundary - born (about) 1682. Tom. Colley (oldest child) no. 2 in 1710.

Tom. Colley eldest, no. 3 in Pittsylvania, Va, 1740 Tom. Colley eldest, no. 4 " " 1770

Sarah Colley, my mother, born in 1798 -myself, first born - - in 1818; hence the name after my grandfather - Thos. Colley Johnston - my grandfather died 13 Feb 1855 at near 85 - after 63 yrs ministering in the baptist church of great remain here still: the church is now building a monument over his grave at mouth of McHenry's Creek 2 1/8 m. NW of Saltville. Colley no. 2 at the age of 19 had the misfortune to kill a bully with his fist. The man had often followed him and challenged him, for a trial of manhood. struck him but one, - and not then, until his father seeing the affair, walked up and ordered him. He killed the man - "Stelseg" - at the one lick. He hid out of the way of sheriffs for several weeks - and then found his way to London; there married a Huguenot woman and shiped at once for New York - found his way to near the place Chatham. I saw his deed to two bodies of land, in that office in 1854. - This Colley was 6 ft. 9 inches in height, and a giant every way - In being, his son, Tom no. 2 built a cabin on Gen. Campbell's land, 250 yds to the right of the road from "Preston's Mill", on the river. This Tom was another powerful man. He was a favorite of Gen. Wm Campbell - Where is his name on any of your records? My grand Father, Tom Colley no. 3, was 10 yrs old (nearly) at battle of King's Mt. - remembered well the day his father left & that of his return from this battle. He was not with the footmen left - but actually in the fight.

On <u>Sunday afternoon</u>, (suggested to have been, <u>Sunday 24th</u>, <u>Sept 1780</u>) <u>Campbell</u> came dashing thro' the hollow east of the mill and down along the road (or "outlet") to <u>Colley's</u> cabin. This fact my grandfather well remembered. The last time I ever saw him - Fall of 1854 - he gave me the account in full over again & perhaps again?

His father took down a rifle from over the door, and sat in the door with it on his lap as long as <u>Campbell</u> remained. He rode with him when he left a mile or two on his way - <u>Campbell</u> then leaving in a gallop and Colley inrevirse for home. The next week the old man went to Abingdon. When he returned he cam back from <u>battle of King's Mt.</u> - Sir, this itself, this Colley connection is a volumn. I must resist - Please hand in this letter. I see I was wrong, but here I never knew the Seeslin(?) co., is a perfect myster. (The buggy is here - for Shady again). Why does <u>Wm C Preston</u>, say of Lee's, of Campbell "at twilight"? The Shelbys - Isaac most - were curious of <u>Campbell</u>. Mrs Todd gave me a mighty lecture one night, against <u>Gen Campbell</u> - as a coward. Yours truly -- Thos C Johnston P.S. Please write <u>Boone</u> inquires to "<u>James Colley</u>" <u>Sandlick</u>, <u>Buchanan</u> Co. Va. <u>Old Dick Colley</u> the father, was a great bear hunter - a romance within himself. Jim owns immense tracts of lands over there.

Abingdon, Va., Aug 19, 1884 My Dear Friend, for such in return, I will call you - here I am again, and, on this morn (?), with unusual patience, suborned to that mental poise which above can enact us a true diseration. There you are, before me, younder, on a special shelf, are your books and memoirs, - below, in a special drawer, your letters. could we but penetrate to the predetermination of this alliance, so happily adapted to my own moral incentives, and so peculiarly abstracted from the influcious of personal presence - that often despoiler of sympathy, - So often, indeed, of all correct appreciatives! - My philosophy, sir is truly a species of Fatalism. I will not, therefore, compliment you - that no such is colorings as flattery may be even supported to tint the pages of this letter. But I will say, that I am reading nothing but yours, - that, yonder lies, under a two-week's dust, Boswell's Life of Johnson and Johnson's journey to the Hebrides - and there they must lie, until are read and reread your King's Mt. Heroes & of, to the bottom. You found me at the first deeply involved with the work mentioned -- Last evening I was in consultation until nearly midnight, with the widow of Walter Preston, the orator, whose biography I have now been the fourth year, in composing. This fact I must give you as an egotism, with the purpose of a little more light. --

About four years ago, I happened to drop the hint, that I was writing History of Washington. I told Gov. Campbell, the fall before his death what Col. Campbell had insisted on my doing. He coincided, - and took it upon himself to open out his scrutvire(?), and write me down many notes, which he gave me, with an hour's comment. But from whence the materials of the Abingdon literate, I have no information! - Jno. G. Ward, editor of the Virginian (Attorney at 12 v) ays he was talked to by one of those geniuses in pretense, and that he convict I h mself so conclusively of an assumed authorship of a treater in which "he in the ly igorant", that he advised him first to get up his notes, and he would a vise with him about these before the history itsself should be begun". - This ended this newspaper variety in a display of youthful ardor, in the department of literancy & are in glory, on this especial subject! - And now, herefore, I do propose, it, with the help of Heaven, I may be permitted to complete my History of Washington County, to transmit it to "The Historical Society of Wisconsin"; and to your especial care. Please consider my intention. I have just today, mentioned my intention to judge Ward - who said, "In consideration of all this d---d matter of essay, "Do So"! I need, from these conclusions to run considerably divergent from my notes in store for your direct information. - But there is a subject of extraordinary import which I have at present under the ban of the Lisievert(?) Scrutiny, and it must out.

Please retain my arithmetic discent of the <u>Tom Colleys*</u>, - for here in are strange revealments. I have told you, that <u>Tom Colley</u> no. 2 was a favorite of <u>Gen. Wm. Campbell's</u>. That he settled him at the "Buffalo Lick", and as <u>Tom Colley</u> no. 3 remembered well, at age 10 yrs. of age, the day (as Sunday Sept 24, 1780?) on which <u>Gen Campbell</u> dashed through the "Mill Gap" to the house, and here he sat in the door with his rifle in his lap during the <u>General's</u> stay, and then rode with him through the gap. The want of record of <u>Colley's</u> name was accounted for in two ways, first, by the loss of muster rolls; but, secondly, by old <u>Dr. Tate</u>, who him-

self at King's Mt., in this way - that the great physical power of Tom Colley and his bulldog courage caused Campbell to retain him always close by his person as and extraordinary in case of any sudden occurance that required the handling of such a man. That Tom. Colley was at King's Mt. he "well himself knew", in the fact that he saw him there: he stated also, that on the way over the mountains, he often saw Colley and Campbell riding together. Hereby hangs the tale. - Incidentally, this same "old Dr. Tate" was with my mother the day before my birth; he left at about sundown telling my grandfather that both mother and child would be dead by morning! that I "could not be born". His old negro, John Broady, was there! My uncle John Colley (yet living at 84) was put upon a fleet sorrel mare at old John Broady's urgent suggestion - proposing to go himself - and he was started over Walker's Mt. for Granny Scott. It was a desperate night but way he went.

"Through thunder, lightning and in rain"! - The old woman mounted her "bay Bob" and, astraddle, like a man - her bonnet hard tied under the chin - with a hickory switch in hand, she led the way by the occassional flashed of the lightning - coming in, at the end of this four-mile race, as old John still delights to tell, several lengths ahead of the sorrel mare, with all his efforts to keep up with her bay Bob! I was born next morning, Sept 2d, 1818, just about sun-up, at a weight of less than five pounds? I have always doubted this last fac. Take, however, this egotism and a little further light. --

Now, to the tale. The tory hung by Gen. Campbell at, or near the place called Midway* was after the battle of King's Mt. I need not now give you the circumstances, I may only say, that Tom Colley no. 2 was with him in this affair. His name was Prayter - a blacken'd name, still deeper, by the circumstances of the murder of Mrs Ben Caywood in 1823. This man, Prayter confessed to several murders and robberies, and named Moses Shelby as his leader in many adventures, both before and after the battle of King's Mountain. And Tom Colley, no. 2 was living in Russell County, the father of a second family, when the first slanders against Gen. Campbell were issued, in regards to which he was greatly astonished - having never before heard, as he would say "by Mortal man that Gen. William Campbell was a coward", and told that he had acted the coward at King's Mt., and that such men as Shelby and Sevier had asserted the fact, his rage was so extraordinary, that he acted like a lunatic - threatening to travel to Tennessee or Kentucky, to kill both Sevier and Shelby! --

It was after the hanging of Prayter, that Colley proposed to Gen. C. a plan for getting hold of Moses Shelby; and it was agreed if the thing could be accomplished that is if Shelby could be gotten into Virginia; they believed the evidence could be obtained to try him by the civil laws and hang him. Moses Shelby - hence all the Shelbys - got wind of this matter, - it was told among them, that Gen. Campbell was determined to bring Moses to justice. Now these facts were told to Gen. Francis Preston, by Elder Thomas Colley, after the death of his father, and also after the publication of the slanders and their refutation by the Prestons. Preston impressed great regret he had not heard the matter sooner, - also that the opportunity had passed of investigating, by living evidence, the character of Moses Shelby. Sir, here is the key in my opinion, which may best unlock the Shelby Slander. ---- Permit me to examine relation to what is written, that weak instrument for such a man as Issac Shelby - his Pamphlet. Does he not stand condemned, in this instrument of some species of revenge? - Of a termined(?) prejudice(?) -After having been in King's Mt. battle ground, and heard this matter of Campbell's cowardice so elaborately discussed - over and over - pro & con - at Yorkville I went up to Gen. Campbell's house - he having sent for me to consult me in regard to trying Mrs. Campbell's portrait, there in a peculair state of idiocy - I spoke

of the Colley history of hanging Prayter. He told he had "once heard of Prayter's being hung - the uncle of the supposed murderer of Mrs. Caywood (or Kaywood - Kaiwood - mostly pronounced Keewood*) and I knew that old Tom Colley, probably 50 yrs. of age at battle of King's Mt. was a right hand man to Gen. Campbell - and we All might have know that Colley knew a great deal in explanation of the Slander. - but he, in 1812 was not less than Eighty, and had long lived in the "Wilderness" on "Grassy", head waters of Sandy - stopping a moment, and smiling, he continued -"a bear and buck slayer, the happiest of men - with an overflowing larder, and all things else that mortal man should, in view of heaven, legally crave!" Now, what are we historians to do with these facts? ---- But, Stop! - Old Colley, no. 2, the last time Elder Tom (no. 3) went over to see him, on Sandy, told, in a large company at night around a log-heap fire, this curious fact: - "I had just jerked up a British musket with a bay net on it, on the last pull up the hill, when General Campbell dashed by me and stopt, - he said, "Colley are you shot?" - No, by g---d: I said. "I order you, Colley, yonder to the branch - tear up anything of mine or Broady's you see to aid in tying up the wounds of the wounded younder. I looked round and went down the hill. Moses Shelby was there, cursing and swearing at being shot. I jerked off of Broady's lap the General's wrapper coat, catching it by each tail, I pulled it in two - old John swearing! I pulled it there into more pieces! Aint this the coat old Isaac sed (?) General Campbell come up in, after the fight, buttoned round him? D---- his old lying tongue"! - He then rode up and went into a rage about the Shelby's & Seviers. ----- See 2d. /P. 565th page, your book "looked down the Mountain saw C. coat off - the trim he had put himself in to fight the battle to." Now, old John Broady did not move, why should he? - while he "looked at him" - whom he saw instead of C., in his black bald-face horse"! Great deliberation, all this, in the greatest heat of the battle! - But how deliberate was Gen. C.'s cowardice! "He had buttoned around him his light colored coat", and "about 30 minutes after the battle was over, came down on foot, with three others, to where the prisioners were". Then he had not been to the bald-face horse to get the coat, now torn up; else having sit on him, he had dismounted, and thus deliberately, after the fight walked about 800 yds. to the place of its conclusion - and John Broady was somewhere else!

The flag was received by a Shelby -(?)! - Major Evan Shelby, Isaac's brother. False, - except that this Major Evan Shelby may have taken into his hands at anytime, after it had been surrendered. - But Isaac, the day after the battle, about 8 o'clock, "was enjoying the warmth of the sun", about (66) when "Campbell walked slowly towards him" coming close by his side, he seems to have whispered to Isaac, "with a smile on his countenance" - a most extraordinary maneuver for Gen. Campbell's countenance on such occasions! - thus expressing himself: "Sir, I cannot account for my conduct in this latter part of the action" - the last thing, after such conduct, that Campbell would have said to any man - and it was never said to any but this one man, Isaac Shelby! - In the succeeding two paragraphs page 567 - we have a specimen of both Isaac's vanity and his envy - at the bottom of which was both hatred and prejudice. But I have specially and specifically marked this the concluding sentence: Of those circumstances which relate to Col. \underline{c} , personaly, and which might have a tendency to diminish his reputation, $\overset{\star}{*}$ or to those who were previously acquainted with him: I am sure that I may say, with perfect truth, that I have never spoken of them in a spirit of detraction." This of an extraordinary lecture for the governor of a State! - The "circumstances" were all personal; - and those which might have a tendency to admonish "his reputation", are just what he has spoken of, not only in confidence, but to the whole world, as just written. Also, "he could say", with infinite truth, that he had never spoken of them in "spirt of Detraction." If not in a spirit of detraction, pray then, in what spirit did he speak of them? Was it in a spirit of commendation? In a spirit of conciliation? or of recuse, or of pardon? for so extraordinary conduct, which

Gen. Campbell himself could not account for? In 3r. /P (p. 567) Isaac had almost forgot that a sword had been voted him by N.C., uptil the year 1810 he thought of it, because he had learned, that the sword, by N.C. had been given to Wm C Preston, that had been voted to Wm Campbell, and that an approaching war with Great Britain had roused him to a recollection for a more useful purpose! - This "elegant sword" to Preston, for the services of Gen. Wm. Campbell in the same great battle in which he was evidently, self-considered, the greatest hero most-deserving of Glory. This was a circumstance that Did produce some feelings of emultion(?) and "soliutude" - the softest words possible in his vocabulary of Envy and Ambition! Hence he wanted "equal justice" - equal glory, which had not yet been done in him! - So he wrote his soliutude to Sevier, of equal neglect below the fame of Campbell, and they demanded their Honors of the old North State. * Fourth /P, "with perfect truth," explains his envy of the "Honors conferred on the memory Gen. Campbell. He actually takes the pen out of the hand of the impartial historian, in a comparison of merits between himself and that hero! The expedition to King's Mt. "was not set on foot by Gen. Campbell nor by Isaac and Sevier", - and; in another place, Isaac takes the honor of planning it to Sevier: hence is all the Honors, glory & fame due to Col. Isaac Shelby! - The paroled Phillips came over the Blue Ridge directly to Isaac Shelby. - "In a few days he went fifty or sixty miles to see Seviere." He, Isaac Shelby, had received all the news - the desertion of Gates and the threats of Ferguson - and he put the thing on foot him - got Seviere, and "that some address was necessary to induce Gen. Campbell to unite with him." these facts he reminds N. Carolina", and that Col. Campbell was not present in the latter part of the action!" in this state of mind - tortured of sleepless nights by envy of the ashes of the ashes of the dead - he "ventured to make some comparison of the services of Seviere and Himself with those of Col. Campbell." - As to those men who 'verified' Shelby's statements, their act is not difficult, by human nature, to be accounted for. Gen. Campbell was a severe man the most rigid of disciplinarians - he, in very truth incurred the hatred of many men and officers. in that expedition. "This fact", old Tom Colley said, "was so plain to him, that he advised Gen. Campbell to "keep a sharp eye on certain among them, who he had his own eye."

Colley also said, that at first, all the tyranny - so called - with the tories, was ______(?) to the charge of Gen. Campbell(?) Col Matthew Willoughby, who died within my recollection, lived just two-and-a half miles south of Abingdon - use to speak of Shelbys as "haters" of Gen Campbell. - Where he lived is called the "Willoughby Place" to this day. Nathaniel Dryden, who was killed at King's Mt., lived four miles further south, at "Dryden's Ford." I saw his "Inventory" today in Will Book No. 1, - was astonished: estimate of his estate £ 147121! - (21st March, 1787. Test, by, John Campbell C.W.C.) Robt. Edmondson's, £ 13600. Test. John Campbell, C.W.C. (Nov 24th, 1780.) To return, and, in five of this Campbell Slander, the Oath of Moses Shelby is to be regarded as a nonentity. - Certainly, sir, referring to your letter, that was a grammatical hiatus, - I thought of it, on my way out into the country: I did mean, and should have said, "also by judge Pearson, with Gen Campbell and Thos J Campbell, in regards to the Wolf Hills title."

This finish, by egotism, is for a purpose. - This Day at this hour, 7 O'clock, A.M., 90 yrs. ago, my father, <u>Hugh Johnston</u> was born - Wythe Co, Va. On 23d. Sept. 1770, both my grand-fathers, <u>David Johnston</u> & <u>Thos. Colley</u> no. 3, were born - <u>Daniel</u>, the son of <u>Patrick</u> from Lessursidry (?), which I have informed you, and son of <u>Hugh Johnston</u> then: All down to myself, first sons, first children! - my Father, <u>Hugh Johnston</u> died 15 minutes to 9 <u>O'Clock</u>, March 19, 1876; <u>Gen. Peter</u> C Johnston died 15 m. to 9 O'Clock March 19, 1877; <u>Gov. David Campbell</u> - died(?) 19th March, 1878 - the then oldest man in Abingdon, in death. - I refer you to my several plots, - but be patient, if tomorrow I leave again. Letter #37 - to Lyman Copeland Draper, dated Aug 21, 1884, Abindgon, Va, from Thos C Johnston. (copied from this scrap)

P.S. <u>James Colley</u>, of Grassy, Buchanan Co. Va., is a son of "<u>Old Dick Colley</u>", the greatest bear hunter - he the son of Tom. Colley no. 2, & half brother to Tom. Colley No. 3, my grandfather. I wrote this, lest I may have called <u>to you</u> the son of Tom. Colley no. 2. Shadrack Colley, brother of <u>Dick's</u>, died in 1854. I painted his portrait thirteen years after from memory wholly. He lived 3 miles NE of this town. <u>Old John Broady</u> told it, after the war, that <u>Col. Williams</u> brought <u>32 Negroslaves</u> into the battle (<u>of King's Mountain</u>.) It was attempted to be kept a secret <u>Broady</u> told it to <u>Gen. Preston</u>, after the surrender of <u>Cornwallis</u>. He said they were sent to the fight by their masters, and that they fought like "<u>devils from Hell</u>" - not one was killed though several wounded; that when <u>Williams</u> fell every negro raised his gun and fired into the surrounding prisoners.

I have counted (numbered) the <u>Colleys</u> from the first senior = grand <u>Colley</u>. But his father in Wales was <u>Tom. Colley</u>, properly <u>Tom. Colley</u>, no. 1 There were then, five regular <u>Tom. Colleys</u>, first sons - with my uncle Tom. of Missouri. I claim myself the 6th.

To the Honorable the Speaker and Gentlemen of the House of Representatives of the Commonwealth of Virginia The Petition and Memorial of the Subscribers Freeholders and Inhabitants of the County of Wythe Respectfully Represents that when the County of Wythe was constituted and Established the Judicial Seat of Justice for the Said County was fixed in a part of the said County far remote from your petioners large mountains which are almost impassable intervening between your Petitioners and their Judicial Seat of Justice your petitioners would Humbly Represent that in Consequence of their Sitution that they labour under innumerable inconveniencies and dificulties insomuch that they are deprived of that convenient and regular administration of Justice to which they are intitled in common with other citizens your petitioners would Humbly Shew that the Session before the last of the General assembly that the County of Giles was Constituted and Established off the west end of the County of Montgomery including a small part of the Counties of Tazewell and Monroe and that the Judicial Seat of Justice for the County of Giles is far more convenient to your memorialists than the seat of Justice for the County in which your petitioners reside That in traveling to the Judicial Seat of Justice for the County of Giles your Petitioners would have good roads and not a Mountain to cross your petitioners therefore humbly concieve That that equal and sound policy which ever actuated the Legislature will regulate their case and redress their greeivances by removing the many inconveniencies and hardships under which your petitioners have laboured for many years in having to travel to the Seat of Justice in the County of Wythe your petitioners therefore pray your Honorable Body to pass a law to annex that part of the County of Wythe to the County of Giles that lies Northwestward of a line beginning at the Junction of Montgomery Wythe and Giles County's lines on the top of Walker's Mountain and along the top of said Mountain to a place known by the name of the Blue or big rock thence a straight line untill it intersects that of Tazewell County on top of Brush Mountain two miles above Nicewonders gap thence with the Tazewell line to its Junction with the Giles County line, your petitioners would Shew that if they Should be annexed to the County of Giles agreeable to their prayer that Still the County of Wythe would remin complete with the Court House about the Center -- your petitioners as is duty bound will pray &c

WHAT A NAME MIGHT MEAN? A person's title in colonial days often had a different meaning than titles used today. Stepmothers were sometimes called mothers-inlaw. Cousins could be relatives of any type -- sometimes even friends. written after a name did not necessarily mean a name the same as his father -- it might be an uncle or a cousin. Housekeeper once meant property owner and could be used for a male as well as a female. Inmate as found in Pennsylvania archives refers to a man living in the home of another person, not necessarily in an Freeman meant a young man, not yet married. Domestic once meant housewife, not necessarily the servant. Mister was a title used only for men of wealth and/or education. A retired man might be listed as a gentleman.
