

Dear Nephew

Augustus P. Hendersen was the oldest child of the Rev Nemiah Henderson by his first wife (who was Nancy Harman daughter of Elias Harman) Old Uncle Nick was one of the early settlers of that country. Guss as he was called did not go out there when his father first settled in that country. But stayed in Giles and Tazewell untill he completed his education & was lisened to practice law. He came passed our house when he was going out to his fathers, in the winter of 1856. While we ware living on Guest river. He was a fine speciman of a young man and afterwards made quite a record as a lawyer. I would have no way of judging the success that he had made as a lawyer, but for one incedent that occured about two years after the county was organized. He was a great lover of a fine horse and my father had bought a verry fine mare of Ky blood, that was one of the finest steppers I ever saw he came to our house to trade for her he had a good horse but he took a fancy to the brown mare and gave Pa forty dollars in cash paper to boot and from the amount of notes that he seemed to have it was good proof that he was making good as a lawyer, in as short a time as he had been there. He married Adaline Kelly a sister of Judge John A. Kelly and they went to house keeping in Gladeville. I don't know what year they ware married and settled there but they mooved from there to Jeffersonville 1861 he went in to the war. I think he was wounded, but got back & settled there and had a good law practice tell he died some years later. He had layed a land warrent on some land down close to the breaks of the mountain. When I was collecting the tax I remember that the ticket was for several hundred acres of land. I don't think they ever got much out of it. Milt French married his sister Rhodie and they ware booth in the race for Commonwealth attorney in 1860. I don't remember anything about the race, but if that was the time he was elected he did not serve but about one year until he went into the war. Senator Newt Harman can perhaps give you a better history of Guss than any one else as he is one that will have a place in the Harman history.

- 9. Thou shalt respect the sensitivities of the living in whatever you record but tell the truth about the dead.
- 10. Thou shalt not become a genealogical teacher or authority without appropriate training and certification.

BENAJAH NORDYKE of NJ; NC; SC; GA; VA; KY

When we look at a map and see the amount of traveling some of our ancestors did, under the most adverse conditions imaginable, with neither good roads nor accommodations such as we have, the distances covered seem almost unbelievable! Often these people moved with families from place to place because of deep religious convictions and to be able to worship with others of like beliefs. Such was a Nordyke family, with the life of one member, Benajah, spanning almost a century.

After I received a copy of a letter from the National Archives, along with the application papers for a pension for service in the Revolutionary War, I did a little further research on this Nordyke family and the picture which emerged was, to me, very interesting. I hope it will be so for others and also that there may be a name or two of value in these comments.

John B. Floyd (1805-1863), one time Governor of Virginia, was Secretary of War for President Buchanan (1857-1860) when the following letter was written. Where there are words I could not decipher I have used _____ and where I am not sure of the spelling of a word I have used a question mark.

Crab Orchard, Ky November 7th 1857

Hon. J. B. Floyd Dear Sir

Believing you are disposed to assist by advice and influence those who served their country in acheiving our independence - I take the liberty of addressing you a few lines in behalf of an old Revolutioner.

I dislike to trouble you, knowing that your duties are arduous, and your time important, yet being a native of the same county from which you hail (Washington Va) and the applicant having lived there the greater portion of his life, we can think of no one as capable of advising in the case as yourself, or who feels a livelier interest in our Revolutionary fathers.

Mr. Benajah Nordyke, (of whom I write) was often

advised by his friends to make application for a pension, but neglected doing so. He served his country for his country's good, and felt and said that so long as he was able to work, or earn a living he would wish nothing of his country. But now that he is reduced to want (having had his earnings of many years destroyed by a fire) is frail and almost blind, and feels greatly dependant upon his friends he is constrained to try if any thing can be obtained. But there is an obstacle (and it is of that that he appeals to you). He knows of no living witness by whom he can prove his service. He entered the service in Georgia, and it is said that the roll of the companies were destroyed when the state Capital was burned.

He was born the 1st May 1766, entered the service at 15 years of age in Wilkes County, Georgia in 1781, and served in the upwarde of 18 months in all, during the years 1781 - 2 & 3. He was under Capt Zachary Phillips (afterwards Col. Phillips) of Col. Joel Phillips regiment, also under Col. Wm. Downs, Capt. Josiah Dunn and Capt.

of this same regiment, and was in Col. Fews regiment at the battle of Kittle Creek (Ga?) and was at the seige of Augusta. Mr. Nordyke lived in Washington County Va., for many years, removed to Ky in 1837 - is the father of Abram Nordyke Esq. of Russell. He is personally known to many of the citizens of said county and few _____ stand higher in point of honor or veracity.

He would refer you to Rev. Jas. King (?) Bristol, Tenn. Col. John Preston, Gov. David Campbell, Francis (?) Preston, Jas. W. Stevens ____.

Also to the Hon. A. S. Talbot, M.C. elect from this the 4th Dis. in Ky.

Respectfully referred to the Hon. Secretary of the Interior War Dept. Nov. 1857 I have found no record indicating that Floyd answered this letter or that Benajah Nordyke received a pension for his service in the war as outlined in a three page deposition #R7691 dated November 15, 1852 which he made at Rock Castle Co., Ky although he lived in Lincoln Co., Ky but because of distance the deposition was made at Rock Castle.

The earliest records I have of the Nordyke family show that they were Quakers. William Wade Minshaw in the ENCYCLOPEDIA of AMERICAN QUAKER GENEALOGY lists the early members of the family in the Burlington Monthly Meeting (Quaker) in New Jersey. There is also a record in the file in the DAR Library in Washington and for easy reference I will use this in the first of these notes.

Aden m Martha Johnson; Israel m Mary Elmore; Beulah m Elijah Foley; Micajah m Charity Ellis; Daniel m (1) Sarah Albright, m (2) Mary Higgins; Phebe m Jehu Ellis; Hiram m Sarah Skeen..... Benajah m Jane Foley (see later.) This record also shows that Aden, Israel & Benajah were born in New Jersey; Beulah & Micajah were born in Stafford, Va; and Daniel, Phebe & Hiram were born in Wilkes Co., GA.

In checking Hinshaw's Quaker records we can begin to see the movement of this family. I feel the two named children above could certainly have been born at Stafford, Va. as a new Quaker Meeting house was established there about that time. We then start to pick the family up in the North Carolina and South Carolina Meetings when they asked for and received what is described as gct - or granted certificate to - indicating that they were moving from one area to another. We know from the letter written by Benajah's grandson and his deposition for a pension that they were in Georgia by 1781.

In 1798 some members of this family were back in North Carolina as they had asked for and received rocf - received on certificate from - N. C., a transfer to LostCreek Monthly Meeting in Tenn. Beginning in 1804 and through 1806 many of them again moved, this time to the Miami Monthly Meeting in Ohio. Abraham and Mary Nordyke and at least two of the sons lived and died in Clinton Co., Ohio; the parents being buried in the Friends' burying-ground there, as well as many other members of the family.

Benajah Nordyke had not only gone against the principles of his family and the Quakers by being in the Revolutionary War, he had also married out of unity and was dismissed or disowned from the Society. The notation from the Westfield Monthly Meeting at North Carolina shows - Benajah dis mou 4/20/1793. He probably had married Jane (Jinna) Foley earlier than this date as the 1850 census of Russell Co., Va. shows that Abram, the son mentioned in the letter to Secretary Floyd, was 58 years old and born in Montgomery Co., Va. We know the dates of birth or ages shown on the early census records were not always as accurate as they should have been and I have been unable to find a marriage record for Benajah but he had a total of seven known children, and I know that Abram Nordyke and Sally Mongle were married on 18 September 1817 in Washington Co., Va. by the Rev. Jeriel Dodge, (Abram and Sally Nordyke were my grgrgrandparents) therefore the date of Benajah's marriage was in the early 1790s. Another of the children of Benajah and Jane, a daughter Matilda, married Hugh M. Grant on 12 May 1829 and it was their son who wrote the letter to Floyd in 1857, on behalf of his grandfather.

Jane Foley was born 2 January 1772 at New River, Montgomery Co., Va. the daughter of Moses Foley and Elizabeth Green. Moses Foley was a Baptist minister in Washington Co. Va. as early as 1794 and about 1815 he moved to Ky. According to the History of Kentucky Baptists he had a total of six daughters and seven sons, one of whom was Moses Foley, Jr. who was a minister at the Crab Orchard church in Lincoln County, Ky where he preached for forty-eight years and died on November 9, 1858.

Lynchburg, Virginia

August 16, 1842

My veary dear and loving son,

I once more by the help of providence take the pen in hand to write you a few lines. We received your letter dated the 14th of November. I do not mind exactly the time, but it found us in tolerable health except your brother Larkin. He was veary low at that time with the fever. He lived untill the thirteenth day after he was taken without eating anything except chicken water and some kind of tea. Nothing else was allowed him untill the thirteenth day and then one spoonful of veary thin mush and a half cup of milk.

You must expect my dear William that my dear Larkin was most gone and so he did seem to be but he was willin to die. As Mrs. ___? told me, the lady whare he lives. His and your sister Catharine nursed him in his sickness, but I went severil times while he lay sick, which I think was about six weeks confinement to the house, but the Lord was pleased to raise him from the bed of affliction and I saw him last Thirsday evening. He was in good health of body and soul too apparently. He is a veary pious youth and if you hear of him preaching the gospel you need not be at all alarmed. He has commenced going to school and is free the 27th of next January and seems to take such a delight in the ways and worship of God. And John is still going on in religious ways. And O my William do you not think that a grate comfort to me? And would it not be a greater one still to hear in your next letter that you have embraced religion? You say in your letter you nor your wife had profest religion, and you have regular meetings with the methodists, Baptists. and Presbiterians.

Well, my son, so you and your wife attend to preaching and do you wish to get religion? Then if you do then get down on your knees and pray to God to have mercy upon you and show you your sinful state that you are in by nature for ye must be born again or ye cannot see the kingdom of God. Oh, my William, read the Bible a great deal and attend to preaching and if there is any revival out with you write me word in your next letter and I pray you my dear son and daughter in law, be you both at the alter that the people of God may pray for your dear souls.

When you read this think on whom it is that has ritten these few lines once more. Tis your dear old mother, and I pray you remember what I say to you on this paper and let it sink deep in your minds. What doth it profit a man to gain the hole world and lose his own soul? Oh, my son, try to save your precious and never dying soul. Lay not up treasures on earth whare moth and rust doth corrupt and whare theves brake through and stele. But lay up for yourselves treasures in heaven whare neither moth nor rust doth corrupt and whare theves do not brake through nor steal, for whare your treasure is thare will your heart be also. Let us all try to meet in heaven.

August 16, 1842

Now I must inform you we are in common health at present as far as I know and hope this will find you and all yours in good health. I have not seen Joseph since before last Christmas. He has gone to Halifax to live. I saw James not long since. He was in common health.

Now dear son, do you not think of ever coming home to see us? We would be so glad to see you and your little family. John says he thinks you might come if you would try rite. And now William, try and come and let us know in your next letter whither you intend to try to come. So farewell, my William, for this time. Your brothers nor sister Catharine is not preasent to joine with me in love to you and family but you may except of it with mine ----

"I take the opportunity of informing you that I am well and I hope this will find you so too.

"I would be glad to see you but I dont no when it will be. I wish you would come in and take the family out with you, for they are in a bad situation which I dislike to see very much and I suppose you do too, but cant help them yet. I am an apprintice to a trade but I think that you and James might take them out for they have no one to help them and try and come in this fall. They are all well at present as common.

"I should like to no what harmess makers bisness is like out there in your country. Perhaps I may want to come out there in the course of time.

"Larkin and John is both got religion. Joined the radical church here in Lynchburg. I believe nothing more at present but answer my leter soon.

Dear Brother.

I take this opportunity to inform you that we are in comon health at present, what few there is of us togather. And I hope these few lines may finde you all injoying good health. Dear Brother we received your letter directed to Leroy sometime since and I was very glad to heare from you and to find that you were on this side of eternity for I had not heard from you for so long. I did not know whither you were dead or alive. But it would have comforted me mutch more if I could of heard that you were on your way to heaven, as I know not whither we shall ever meet again in this world, but I hope that we shall in a better one. And now I wish you to make a start for heaven and try to meet a brother....

I feel it my duty to warn you of your doom for without holyness no man can see the face of God in peace. My friend, do you know whare you are going? Have you reflected what you are engaged in? Is it an object you will be able to think upon tomorrow with pleasure? Wold you pursue it if you were sure you would die tonight? Have you asked God or can you ask God to bless it? If you have not done this, if you cannot do this, then reflect. For all these things God will bring you into judgment.....Stop and consider before it is too late. There is yet time but you know not how short it may bee. O flee to the Savious for the pardon of your sins -- pray that devine grace may be given you. Entreat the Holy Spirit to convince you of the evil of sin and its dredful consequences and to influence your heart and mind to those things which alone can bring you peace at the last. Read the Bible. All these things are taught therein.

Besides, the heavenly world with all its glory and felicity would be a place of torment to an unholy mind. Shold the sinner with his unholy heart and character be admited into the regions of the blessed what would he find suited to his desires and reigning temper of heart? He would find the character of everything totally opposed to his own. He would find every employment of heaven holy and spiritual and opposed to his own inclinations. He would find himself perfectly alone -- no one to associate with him among all the millions of the heavenly host. As I exspect ere long to be standing on the walls of Zion to proclame the glad tidings of Christ to a lost and ruined world and now I proclame to you and beseach you by heaven to repent and believe the Gospel before it shall be everlastingly too late. I know not that I shall ever see you again in this world, but I hope ere long we shall shack hands on the banks of eternal deliverance.....Whatever you find amiss forgive.

Nothing more at present, but I remain your brother untill death

THE McALEXANDER FAMILY OF PATRICK COUNTY, VIRGINIA

The McAlexanders of Patrick County, Virginia, are descended from two brothers, William and John, who were among the five sons of James McAlexander, thought to be an immigrant to America from Ireland or Scotland, who lived on the north fork of Davis Creek in what was first Albemarle County, later Amherst County, from 1756 until his death in January 1798. (His land is now in Nelson County.) Beginning in 1773 James McAlexander acquired land in what is now Patrick County, which he gave to his sons William and John. James McAlexander's five sons were:

- 1. James McAlexander, Jr., born about 1741, died between 1826 and 1830; married Patience McDaniel; one son, David.
- 2. William McAlexander, born January 13, 1744, died March 8, 1822; married three times, last to Tamar Boothe; 21 children by the three marriages, of which 18 survived him.
- Samuel McAlexander, born about 1748, died between 1786 and 1798; apparently unmarried.
- 4. John McAlexander, born 1751, died after 1834; married Agnes Burnett; 10 children.
- 5. Alexander McAlexander, born May 1, 1756, died January 30, 1840; married Martha Burnett; Il children: Jane, William, John, James, Edmund Tucker, Alexander Waugh, Patsey Burnett, Amelia Carlisle, Samuel Ramsey, David Robinson, Joseph Roberts.

WILLIAM MCALEXANDER'S OBITUARY NOTICE

The following obituary notice reporting the death of William McAlexander was published in the Lynchburg Press on April 5, 1822 (page 3). (For other obituaries in this newspaper see Marriages and Deaths from Lynchburg, Virginia, Newspapers 1794-1836, compiled by Lucy Harrison Miller Baber, Louise Ann Blunt, and Marion Armistead Lewis Collins, 1980.) ----, on Friday, the 8th ult. at his residence in Patrick county, after a short illness, which he bore with Christian fortitude, Mr. WILLIAM McALEXANDER, in the 79th year of his age. Few have descended to the tomb more regretted. On the stage of life, his conduct has been most exemplary. At an early age he became a professor of religion and a member of the Presbyterian church--he was a strict observer of the sabbath, and never known to use the name of God irreverently. He was firm in his purpose, inflexible in his integrity, unbounded in his benevolence -- he was the friend of the poor, and the protector of the widow and The good, disinterested neighbor, his heart was the orphan. open to every noble feeling. Mr. McAlexander was one amongst the first settlers of that part of Virginia, and as a true republican soldier placed himself under the standard of his country, and with active zeal bore a faithful part in obtaining our independence. In him we have lost one of the fathers of our He has has three wives and 21 children -- and now a widow and 18 children, besides a numerous train of connections and friends, are left to mourn their irreparable loss.

WILLIAM MCALEXANDER'S GRAVE

William McAlexander's grave is in a small family plot on a ridge overlooking the site of his house on Rockcastle Creek, a few yards from the Rachel DeHart house (built in 1903) and perhaps half a mile west of the Rockcastle Creek bridge on county road 710. William's tombstone reads:

ALEXANDER
WAS BORN JANY
13TH.A.D.1744

There is another stone of similar size with his which is completely illegible but probably is of one of his wives. The only other legible stone in this cemetery (as of 1985) was that of an infant granddaughter, Anny Booth (b. June 6? 1816, d. Feb. 4, 1818). William's widow is reportedly buried on the side of the ridge on the other side of Rockcastle Creek; the site is enclosed by large stones forming a rectangle, but there is no tombstone. As of 1985, William McAlexander's property belonged to Carl Griffith.

William McAlexander was born before the calendar reform of 1752. His birthdate of January 13 is given in New Style, as his age at death shows; by Old Style his birthdate was January 2.



ADAM WALKER FAMILY

Adam Walker Sr. was born in Ireland. When did he come to this country? He married Agnes Davis of PA. Where & When? They moved to what is now Wythe Co., VA. and raised their family.

The Adam Walker Jr. family left for MO. in 1829? and arrived in Pike Co. MO. in 1832? Does anyone know the route they may have taken? They settled in what was known as the Calument District which is near Clarksville, MO. Some of their letters refer to the area where they lived as Walkerville.

In 1845, Wellington Boliver Walker, his brother Clayborne Campbell Walker, his cousin Andres Jackson Doak and A.J.'s wife Rebecca left for Oregon. They settled in the Williamette Valley, approx. 10 miles Northwest of Salem in what was lated named "Spring Valley." Later there was a small community & post office called "Zena."

In 1847, Wellington went back to Pike Co., using a pack horse to carry his supplies. In 1848, Wellington, Walter Montgomery Walker, his wife Jane Mackley Walker, their daughter Mary Virginia Walker (then 4 yrs. old) and Elizabeth, a 13 yr. old black girl left for St. Joseph, MO. where they joined a wagon train for Oregon. Wellington was elected Captain of the wagon train. They arrived in Vancouver on 1 November 1848.

John Purvine of Illinois was in the same wagon train. The Walker and Purvine children intermarried to the extent that is was found feasible to have a PURVINE-WALKER reunion rather that to have two separate ones with mostly the same people. We have a record of over a thousand decendents of the two families who met while members of the wagon train.

Floyd County PARISH VISITS

The Rev. Bowers' records indicate that he preached sermons at Hylton on December 4, 5, and 6 and at Zion Church in Floyd County on December 12, 1886. To begin his ministry in Floyd County, he arrived at 7:15 pm, Thursday, December 30, 1886. He went into the parsonage Monday afternoon, January 3, 1887, and received a "pounding" the same evening. On January 31, 1887, he received a pounding from the town people (48 packages). On February 6 there was a public meeting of Zion's Missionary Society ("Very Fine") where \$5.82 was collected.

He notes that together with Brother D.W. Swain, he paid a visit to Gladeboro, Carroll Co., Va., May 28, 1887, and returned on May 30. He rode 75 miles, preached four times, addressed Sunday School, and visited five

families.

DAVIDSON COUNTY, NORTH CAROLINA, ABSTRACTS OF WILL BOOK 2, 1844-1868 and DEED BOOK 3, 1826-1828 by Mary Jo Davis Shoaf. Soft cover, spiral binding, 82x11", complete name and slave index, i + 132 pp, \$20.00 incl p&h. Order from the author, 5140 Hackney Iane SW, Roanoke, VA 24018. On 9 Dec 1822 Davidson Co, was formed from the part of Rowan east of the Yadkin River, an area populated by Scots-Irish, Germans, and English, many of whom had migrated from Pa, NJ, Del, and Md down the Great Philadelphia Wagon Road. Mrs. Shoaf has previously published Will Book 1, 1823-1846, which is available from her for \$15.00 plus \$1.50 p&h. Davidson Co Deed Abstracts, Book 1 & 2, by Catherine C Middleton, is available for \$10.00 from the Davidson Co Museum, South Main St, Lexington, NC 27292. In the present volume the abstracts are made from the recorded wills and and deeds in the offices of the Davidson Co Clerk of Court and Register of Deeds. A few unrecorded wills located at the NC Archives have been included. In instances where no probate date was given, the author has made effort to find a tombstone inscription showing the date of death. SETTLERS ALONG BACK CREEK - VOL. I by Nelson Harris. This is a history of the Grisso, Poage, Harris and Hayes families and other allied families. The first settlers along Back Creek in Southwest County after 1740 came from Pennsylvania. One of the first prominent settlers in the area was Colonel Andrew Lewis. Based on court records some of the earliest settlers along Back Creek were Robert Poage (1748), John Martin (1768), James Templeton (1770), David Snyder (1781), William Henry (1787), Jobb Shrewsbury (1788), Edward Billups (1794), Obadiah Reynolds (1795), Mathias Grisso (1796) and Robert Beavers (1797). Other families included Wimmers,

Fergusons, Willetts, Websters and Shartzers. Many citizens of Back Creek were among the Confederate forces during the Civil War from Montgomery and Roanoke Counties, Va. The Herald of the Valley, on August 27, 1821, printed the new "Supplement to the Laws of Fincastle." (Botetourt Co, Va.) "The owners of real estate, and housekeepers in the Town of Fincastle, shall once in every Two weeks (and on Thursday) when the weather will permit, sweep the street, opposite his or their intire property or tenement, so that the sweeping from each side of the streets unite in the center; and that the same shall be removed at the expense of the Corporation, as far as proacticable, to such place as three or more of the Trustees shall direct; and any freeholder or housekeeper neglecting or refusing to comply with this ordinance shall for every offence forfiet and pay the sum of one dollar and that the citizens may understand to which of the streets the foregoing ordinance is intended to apply; it is ordered to commence on the Main Street at the west end of Mr. Robert Calhoun's house viz., the old Courthouse, and from thence to the east end of John Nevill's lot; from Mrs. Bartee's ending at the north extreme of the Rev. Robert Logan's house; and from the south end of Crogan's lot to the north extreme of J. Rudisill & McDowell's lots; from the northwest end of Jo. Site's lot to the south end of R. Kyle's kitchen; from Hedricks by Boseman's to the east end of Doct. Woltz' house and from the commencement of the street between Capt J M Bowyer's & Hudle's to the extreme end of the street including Mr Cruch's shop and Mr Woodville's and from thence passing Mr Turner's so as to include the dwelling house.

"Ordered that all racks or other fixtures for the purpose of hitching horses or other stock to which stand on any of the streets of said town, or so near thereto as necessarily to compel such animal to stand on the street, be forthwith removed by the occupant of the property whereon they stand, under the penalty of one dollar for every 24 hours they shall remain after the first day of SEPTEMBER next.

"If the owner or driver of any wagon and team, or other wheel carriage, shall suffer the same to remain in any street in said town more than six hours at one time, unless it be necessary for the purpose of loading and unloading, or shall at any time feed his horses in any of the streets, or any part of the Court House or Common, he,she, or they shall for every such offence, forfiet and pay the sum of two dollars.

GUILLAUME FOUQUET (Fuqua)

contribute by Bedford City-County Museum

Many Huguenots by the name of Fouquet fled from France, 1659 to 1685, because of religious persecution. Among the French Huguenots who came early to the American Colonies, probably from the British Isles, was Guillaume Fouquet, the emigrant ancester of a large family in the United States. The records concern Guillaume Fouquet and his decendants, through four sons, ---

Guillaume Fouquet (b ca 1667-d after 8-1-1698, Henrico Co., Va) md ca 1687 Jane Eyre (b 1671) daughter of Margaret Humpheys and Joseph Eyre, grand-daughter of William Humphreys. Guillaume is mentioned in estate of Sarah Cocke, administratrix of William Cocke, dec'd of Henrico Co, Va. Deeds, wills, etc, 1697-1701 (original). p 112 Va. State Library.

William Fuqua has had a Genealogy on his line, "Fuqua - A Fight for Freedom." The other three sons is being written.

They came to this country for freedom of religion. They were not only concerned about their own but helped other denominations to have a place to worship.

They were ready to fight for this county -- Colonial, Revolution, Confederate and later wars.

Colleges being helped to-day.

Joseph Fuqua and a friend Downey gave 100 acres and 2 lots, 1 for Court House and 1 for Jail for the City of Bedford to be built on.

See notes on Ralph Fuqua who came to Bedford County to make his home. (at the Museum).

DID YOU KNOW THAT-- In 1739, before the Presbyterian Church was organized in Virginia, the great revivalist, George Whitefield, made a trip by horseback from Pennsylvania to Georgia. He dined with Governor Gooch in Williamsburg on Dec 15, 1739. On Jan 9, he wrote in his journal, "... the greatest Probability of doing Good in Virginia is among the Scots-Irish, who have lately settled in the Mountainous Parts of that Province. They raise little or no Tobacco, but Things that are useful for common Life. And I hear the Governor has given Leave for a minister of their own Way of Thinking to come whenever he can be procured." It was Governor Gooch who "opened the door" so the Presbyterians could establish their church in the state.
