

The subject of lineage could actually read LINEAGE-RECORDS as an hyphenated word, as no lineage could ever be established without records. This year of 1986 is the 900th of the first all emcompassing record we English speaking people have of the citizens of a state. In 1085 King William I, during his Christmas court commissioned the Domesday survey. I rather imagine that when most of us think of this survey we assume it lists the names of all the people of England, a total of some one and one half million persons, but most of them did not have names as we know them, that is, first and last names. Only a very limited number of the actual population was listed by name. To give you an idea of the record as presented to the King, I will show one area only, Albury, in Surrey England in the year 1086. The entry in the DOMESDAY SURVEY relating to Albury and translated from the Latin, is told by R. Charles Walmsley, FRICS in a little booklet published in 1974. "Domesday Book" is said to be so named because it judged all men without bias like the Last Judgement - named landowners only and showed the value of their holdings and the extent. I hope the following account of the Survey made under William the Conqueror will be of as much interest to others as it was to me.

DOMESDAY SURVEY - Relating to Albury: In Blacheatfield (Blackheath) Hundred. Roger holds of Richard Eldeberie.

Azor held it of King Edward. It was then assessed for 4 hides; now for 2½ hides. The land is for 6 ploughs. In demesne there is 1, and (there are) 11 villeins and 5 bordars with 6 ploughs. There is a church; and 4 serfs; and a mill worth 5 shillings. Wood worth 30 hogs (a year). Of these hides, a knight holds 1 hide; and (he has) there in demesne 1½ ploughs, and 1 villein and 1 serf; and there is an acre of meadow. The whole, in the time of King Edward, was worth 10 pounds, and afterwards 100 shillings; now 9 pounds.

The following Notes help explain some of the terms and names of the above.

1. Blackheath Hundred. A county was divided into Hundred, each of several parishes, for what we should police purposes.

2. Roger d'Abernon, whose descendants held Albury for five centuries.

3. Richard de Tonebridge, ancestor of the great house of de Clare, Earls of Hertford and of Gloucester.

4. Eldeberie - i.e. 'the old Bury'. Doubtless derived from the Roman enclosed settlement on Farley Heath.

5. Azor. An Englishman who held large estates of King Edward, and did not lose them all at the Conquest. He had made his peace with the Conqueror, but died before 1086.

6. Assessed for 4 hides. A hide was 120 acres, but it does not follow that there were really 480 acres here. It is what we call a rateable value, so reckoned for purposes of taxation.

7. Now - i.e. in 1086 the rateable value is lowered.

8. 6 ploughs. This almost certainly refers to an ancient valuation of King Edward's days, not to any definite measure of land.

demesne. The part of the estate farmed by the lord's bailiff.
 'Home Farm', we should call it.

10. there is 1 - one plough, meaning one team of eight oxen.

11. villiens. Small farmers who had land of their own, worked by them in co-operation, of which they could not be deprived, but who owed certain work on the lord's land and certain payments, and were not free to leave. There were 11 villein holdings here, with one man responsible for each, but most probably with several sons, brothers or relatives on each holding. The population can not be estimated from this.

- 12. bordars. Tenants in a lower class than villeins, perhaps with only a cottage and garden and no farming land. The same remark applies to this number as to that of the villeins.
- 13. church. The Church of Albury Park bears traces of the church mentioned here.
- 14. serfs. Absolute slaves who could be bought and sold. Probably heads of families. They had no holdings of land, as even bordars had on a small scale.
- 15. mill. A water mill. Dues paid for grinding at it worth 5s a year. The Villeins would grind their corn here.
- 16. Wood worth 30 hogs. Wood from which thirty hogs could be provided a year, but it would feed very many more. Thirty killed.
- 17. a knight. In all probability this unnamed knight was ancestor of the family afterwards called de Weston. Weston Street is the correct name of the main street of Albury village. De Westons held it as a separate manor under the de Clares (see Note 3).
- 18. $l_{\overline{2}}^{\frac{1}{2}}$ ploughs. This sound mysterious, but a plough means eight oxen. He had twelve oxen enough to draw one plough with four over. Surrey farmers would plough with less than eight oxen. He also had two tenants his managing farmer and one slave under him.
- 19. worth 10 pounds i.e. in the time of King Edward, before 1066.
- 20. afterwards. After the Conquest of 1066 and the ravage of the country by the march of William's army, which came through or near Albury. The value of the land dropped by one-half that year (1066/67).
- 21. now. In 1086, it has nearly recovered, but the lowered assessment for taxation is allowed to stand.

From the time of the survey in 1086 until Runnymede on June 15, 1215 when the great charter - MAGNA CHARTA - was granted by King John of England, the people started to add second or Surnames to the first names and many occurrences of their lives were being recorded, such as marriages, births and deaths. Most of these records were kept by the churches of England (as well as those of other countries) and even today, if one knows where to look - county or area - many of them are available. When the ownership of property became more prevalent, the records were kept by the civil authorities.

By the time of the first settlement in 1607 in this country some of the people, not all of course, were able to read, held property which could be sold or traded and the transactions had to be recorded. From these records we are often able to carry down generation after generation of a family to form a pedigree. Without records it would be almost impossible to do this. I know there are some cultures where the genealogies are given orally by a very limited number of people, such as was done by the Hawaiians, but even they have now had this information put into book form. When a people have writing they have records, when they do not, there is no way to establish a true genealogy.

From the time of the first settlement in this country until just before the Revolution, records were fairly well kept, both in the churches and by the civil governments, primarily because of property, and names of the titheables which were the principal source for taxes. Marriages, births and deaths were often kept by local ministers of some of the churches as their private property, but many Parish Churches still have existing records which are valuable for research. One of the most informative and complete sources for church records is William Wade Hinshaw's ENCYCLOPEDIA OF AMERICAN QUAKER GENEALOGY. The Quakers kept meticulous records and even though there may be no indication that an ancestor was a Quaker, these records are worth looking into, especially up until the early 1800s when the people started migrating over the mountains and from older states of the coast into the Northwest Territory and other new areas of the country. The hardest period of research seems to be from the end of the Revolution until the first

complete census of 1850; until then land records and sometimes wills were kept but not much else because of distances envolved to seats of government and the lack of laws. It was not until after the early 1900s that most of our states required that vital statistics be recorded, which certainly made for easier research. One of the most important and often overlooked places for records are the family Bibles or Record Books. The prize possession of many of our early families was the Bible. In these were recorded the marriages, birth and deaths, often for a number of generations, and these Bibles were passed down from member to member of a family. If a family Bible is available for research, feel most fortunated. If the contents of any known Bible have not already been published in some form, see that it is done, so the information will not be lost forever from this prime source of LINEAGE-RECORDS.

Searching records can be frustrating, but remember, you have established a bit of history when you have found an answer to a problem and that can be most enjoyable!

PATTERNS OF FREEDOM Records of the Freedmens Bureau 1866 Marriage & 1867 Census Montgomery County, Virginia Compiled and Edited by R. Boulton Dickenson August 1990

Prior to The Surrender at Appomattox, on April 9, 1865, the Bureau of Refugees, Freedmen, and Abandoned lands, usually called the Freedmen's Bureau, was established by an act of Congress approved March 3, 1865. Within the the State of Virginia, following The War of the Rebellion, the bureau was divided into 8 districts, Montgomery County being one of 18 counties included in the 8th district. Brevet Captain Charles S. Schaeffer, a native of Germantown (Philadelphia) Penn., was assigned to the 8th District headquarters in Christiansburg, under Special Order No. 9 of May 23, 1866.

It was under his direction that the following 1866 marriage records, and the 1867 Census, of Freedmen were taken. Where appropriate, the incomplete 1865 census taken by Schaeffer's predecessors, are included. All told, they are among the few such records to survive the disestablishment of the Freedmen's Bureau by Congress in 1868, and the subsequent withdrawal of the bureau from

the States in 1869.

JOURNAL OF THE HOUSE OF DELEGATES OF THE COMMONWEALTH OF VIRGINIA

These volumes contain the approved and rejected petitions and laws enactby the House of Delegates - also those acts enacted. "The Acts of the House of Delegates" (another set of books) include only those acts that was passed. These volumes I found in the Pare Book Room at W & L College. They do not have the earliest volumes. This volume was printed 1827.

THE MITCHELL - ENOS CONNECTION

The Mitchell family of Carroll County descend from Stephen Mitchell who married Keturah Wade in Bedford County, and from William Mitchell who married Elizabeth Mitchell a daughter of Stephen and Keturah. They moved to Grayson County about 1808 from Bedford County. Stephen was a son of Robert Mitchell whose will was proved in Bedford County in 1799. About 25 years ago some one of the family had a paper which stated, "About the middle of the eighteenth century Robert Mitchell and his wife whose maiden name was Mary Enos of Welch extraction emigrated from the North of Ireland to America. They settled at Paques, Penn. for a brief period and then moved to Bedford County, Va. During their sojourn at Paques their first son whom they named James was born. Robert Mitchell and his wife were blessed with five sons: James, Daniel, Samuel, Robert and Stephen."

In the Library of the Historical Society of Delaware in a small book titled "The Enos Family of Delaware 1463 to 1958" by Joseph G. Enos is quoted the will of Richard Enos of New Castle, Delaware, 30 April 1748, proved 3 Dec. 1748 in which his heirs include a daughter Mary and one of the executors was "Robert Mitchell my son-in-law." Richard Enos was the first of the line in Delaware but Joseph Enos traces the line back through New Jersey, Connecticut, and England to the town of Mons, Belgium and Collard Henno who was listed among those present at the reception of Burghers in Valenciennes 7 Feb. 1463.

Giles County, Va., "A6777=7982, Dec 3, 1823, formation new county (which would be Logan Co.). The box would be the one containing the year 1823. (Different people wrote the signatures -- on some pages the handwriting is the same for all signatures.)

The petition of the Inhabitants, of the Counties of Giles, Cabel, Tazewell and Kanawha, to the Honorable Senate & house of Delegates assembled by the State of Virginia respectfully Sheweth, That they are Situated at the extrimites of the above Counties from 60 to 120 miles from their respective Court Houses, over a mountainious & difficult Country to travel, much interSected with dangerous Water Courses, which in Some measure deprives your petitioners of the protection of the laws, and prevents the Settlement of this healthy, and important part of the State------They therefore Pray; the Honorable Legislature will be graciously pleased to pass a Law to lay off, a New County - Beginning at the Junction, of the White Oak mountain, & New river, and proceed with the meanders thereof, till it meets, the line of Kenawha County, thence with the lines thereof, takeing the decideing ridge between little and Big Cole river, till it Comes on a line with the head of Rock Creek, then down the Same, to its mouth, then Crossing little Cole, proceed with the decideing ridge, between Turtle, and Horse Creeks, to the Head of Ugly Creek, thence down the Same, to its mouth, Crossing the Guyandotte, in a Strait line to the mouth of Morrowbone Creek, thence, up the Tug fork of Big Sandy River, to the mouth of Elkhorn Creek. And then proceed with the decideing ridge between Elkhorn Creek, & the Tugfork, and So on a line with the Flat top mountain, to the beginning -- This forming a most community. Bounded County, Sufficiently extensive, being about 75 miles in lenth, & 40 wide; and will contain 700 tytheable inhabitors. Beleiving the honorable legislature, is disposed, to give every facility to the Settlement of the State; and the Consciencence of the Inhabitants, they beg leave in addressing the Honorable Houses again to Suggest their extreme necessity for a New County; and their perfect Confidence in the Wisdom and dispossetion to do Justice, to every part of the State .-----And they further pray, Should, the above humble and respectfull petition be granted, that the Honorable Houses will be further pleased, to appoint Commissioners, from the Neibouring Counties, to locate the Seat for the Courts of Justice, So that all Cause of dispute may be prevented among your petitioners, and your Petitioners will ever pray &c &c &c -----Henry Perry

Mail to SVGS, PO Box 12485, Roanoke, Va.

For members, we will place a small notice in VAN of an upcoming book or of a book that they have published. We cannot put in review notices of books that we have not received.

FAMILY REUNION, PRE-PUBLICATION OF BOOK, NEWSLETTERS, ETC: Limited to 60 words, not including one name and address. We cannot edit a full page down to 60 words - so send the notice as you want it printed. These notices will be put in as space permits.

MATERIAL FOR PUBLICATION: We welcome articles, records, etc for publications.

The material when received may not be used in the following issue, but in a future issue.

- 1. READY FOR PUBLICATION (which the editor loves). Please type (use a carbon ribbon or dark ribbon and CLEAN KEYS.) Use 8½xll" page, single space, with minimum margins of one inch on all sides. Title your article and place as in similar articles used in VAN. Be sure to include your name and address to be identified as the contributor of the article. If not typed, please print or type double space -- some articles that have been written we cannot read or those that are typed with caps are difficult to read. PLEASE read the material over before mailing and double check all dates!
- 2. Give source of material. Original documents where found, type of record, page number, etc., or who now has the document in their possession. We CANNOT PRINT material from printed sources unless we have WRITTEN permission from the publication or publisher. We must have source of material, to give credit to the person who has done the work.
- 3. DEADLINE for submitting material is the first of the month previous to the month of publication.
- 4. Material contributed will not be returned unless accompanied by a stamped, self-addressed envelope -- it would be better to send a photocopy, as letters do get misplaced and lost.

GENEALOGICAL QUERIES: Each member is entitled to one or up to 3 free, 60-word query per issue as space permits. Our editor will not compose queries for you, so please make your query as clear and specific as possible so that others can understand them and have a chance to help you. Each query should include names, dates and locations to identify the problem. Each query must be 60 words or less (excluding your name and address). Please capitalize surnames -- is it Mary Smith JONES (single) or Mary SMITH JONES (widow or divorced). Do NOT abbreviate, we will. Queries for non-members are 5¢ a word not including your name and address.

SURNAME INDEX: Information will include Name (given & surname), Place (location at time of date), Date (birth, death, marriage, where living at the date given). This information will go on one line. If this information takes more than one line or the wife or husband's name is included on a single line, it will be counted as two lines. The surname index will be in the August issue and must be in by July 1st.
