

To the confederate Pension Board of Carroll County

I W A Horton a justice of the Peace for Carroll County do certify that Alfred Gardner and Isaiah Quensenberry whose names are signed to an application made by Tobias Quesenberry for Pension on the 26th day of May 1900 was sworn by me and certified that the said Quesinberry was a member of the 45th Virginia Intantry Company and was a good Loyal Soldier and that they knew him to be Total disabled from Age and Rupture Given under my hand and seal this May the 26th day 1900

In pursuance of an Act of the Virginia Legislature, approved March 7, 1900, T J Huffman, Wm L Utt, Esau W Franklin, E P Givens, and Wm Wisler, all of whom are ex-Confederate soldiers, and residents of Carroll County, Virginia, are hereby appointed and constituted a Confederate Pension Board for Carroll County, to pass upon all applications for pensions made under said act— It is further ordered that the Clerk of this Court issued copies of the Order at once, to be served upon the above appointees as notice to them of their appointment—A Copy

page 29 May 14, 1900 Proceedings of Pension Board of Carroll County Virginia who were appointed during April term of the Circuit Court of said County, T J Huffman, Wm L Utt, E W Franklin, E P Givens and Wm Wisler met on the 14th day of May 1900, in the Clerk's office of County Court to organize which resulted as follows: T J Huggman, Chairman Wm L Utt, Clerk. The Board then fixed upon Monday the 28th day of May to to meet at 10 o'clock AM each day to consider claims for Pension from Pine Creek District, Tuesday 29th for Laurel Fork Dist. Wednesday 30, for Fancy Gap Dist. Thursday 31, for Piper Gap Dist. and Friday the first day of June for Sulphur Springs District and members of Board present except Mr Franklin. After these deliberations the Board adjourned to meet at Hillsville in the Court House May 28, 1900 to transact business.

- Ira White after being Sworn on questioning found that acquisitions were false and his name is continued on Old Pension Roll.
- Canada Williams After being Sworn on being questioned was found to be disloyal that on March the 5, 1865 crossed into

the Federal lines and is hereby stricken from old Pension Roll 8. Malinda Dalton did not appear and the Board found that She has ample means of Support and her name is taken 9. Sarah gentry did not appear and finding that She is not a resident of the State her name is now Stricken from the Old Pension Roll

April 1st 1901

Candada Williams after being Sworn made application to be reinstated in Old Pension list the Board hearing his evidence in his case as to his disloyalty We decided to not reinstate him-Hugh Cox after being Sworn made application to be reinstated on old Pension list the Board hearing his evidence in his case as to his property and disability and the Board decided to leave him from the list as he has ample means for Support.

June 10th 1901

S D Worrell was notified some twenty days previous to the meeting of the Pension Board to show cause if any why his name Should not be Stricken from the Pension of 1900 - he failing to come before the board upon what Stood against him as having not been loyal to the State of VA. went through into the Federal lines in company with Robt. Largen and others the board hereby do Strike his name from the list - as a pensioner. Carter Worrell having the same kind of Notice as the above

Carter Worrell having the same kind of Notice as the above failed to appear and upon the same kind of evidence was ordere by the board to be discontinued as a Pensioner from the former list.

Thursday 12 July 1900

Board met at 10 AM all members Present taking up the regular route of business.

Mr Hugh Cox came before Board to be restored to old list but, the board having certified the old list to the Condition (for his case See "p" 31.)

Friday July 13 1900

Board met pursuant to adjournment at 8:30 AM. After some examination of applications went to regular business Receding. T J Huffman

April 1, 1901

Board convened at 10:30 AM. The following members present, Thomas J Huffman, Chairman Wm J Utt, Clerk. E W Franklin, E P Givens W Wisler

Then received applications from Hugh Cox and Canada Williams to be reinstated on old list but upon their own evidence before the Board they were refused their request Upon the same plea that was allege against them last year.

# THE SELU CONSERVANCY OF RADFORD UNIVERSITY RADFORD, VIRGINIA

Selu Conservancy -- the name has a ring of Cherokee to it, and indeed the word <u>selu</u> means in the Cherokee language "corn," or "the grandmother corn spirit." At Radford University <u>Selu</u> signifies a large parcel of land donated to the University Foundation in the fall of 1989 by John Bowles of Cambridge, Massachusetts. Mr. Bowles gave almost 200 acres that include woods, meadows, and river frontage along the Little River in the Dry Valley section of Montgomery County. He designated the gift as a conservancy for the physical, cultural, and social environments of the area. At the same time that the natural habitats of the flora and fauna are being protected, however, Mr. Bowles also has encouraged responsible usage for educational objectives.

With that charge the faculty and students of the Appalachian Studies Program set out to learn about the history of the property and to take appropriate steps to preserve the cultural heritage associated with it. The learning process promises to be ongoing into the indefinite future, but to date we know that the property was farmed by various families, many of them tenants, up until about 1955. Still standing, at the time of Radford University's acquisition, were two log outbuildings, a newer frame barn, and one brick chimney from the Scottish-influenced I-house that once served as the homeplace. These buildings, excluding the barn, likely date back to the late 1800s, though one of the outbuildings could be older, as suggested by the size of the logs and the building style.

Nearer the river, under the protection of a hill, stands a single-pen log house, which at one time had a kitchen built onto the back. The house contains interior vertical paneling, a partially boxed stairway leading to a spacious loft, a large brick and stone fireplace, and an opening in the chimney upstairs for what must have been the flue for a small wood heater. Outside, the logs are primarily yellow pine with some poplar mixed in; the chimney is a masterful work of field stone, obviously collected from right around the house site. The logs, joined at the corners with common V-notches, are chinked with tightly wedged wood chips in a diagonal pattern, then covered over with cement, surely a more recent addition that probably replaced the original clay or mud. This house, too, appears to date back to the late 1800s.

With these vestiges of a cultural legacy to build on, Appalachian Studies students and faculty have begun to collect oral history from former tenants; to conduct deed, map, and census searches; to excavate around the house site for archaelogical artifacts; to photograph all evidences of material culture; and to restore the deteriorating buildings. The latter project was taken on by two Appalachian Folklore classes in the fall of 1990 under the direction of restoration specialist Thurlowe Scudder.

The first Saturday on the site offered a lesson in squaring a poplar log for building purposes. It also offered a lesson in humility: Mr. Scudder informed the students that the typical log house in pioneer days was erected in about one week's time from the moment the builder stepped into the woods to cut the trees to the moment he closed the door on his new home. In contrast, it took sixteen R. U. students and faculty approximately five hours to hew one log on two sides! At that rate we might have put a building up in two years, but fortunately we had the resource of modern technology to call on.

With the help of a trusty sawmill and the expert guidance of Mr. Scudder, the students learned to measure and notch new logs to replace the rotten ones, to lift and carry heavy logs, to match notches in order to set the logs in place, and ultimately to celebrate the erection of the restored smokehouse. As the wintry days of December sent students into final exams and toward home for Christmas, Mr. Scudder and his crew moved in to complete the restoration of the second outbuilding, the crib. As of this writing, two "new" buildings grace the grounds of the Selu Conservancy. They carry something of a checkerboard look to them because of the mixture of old gray logs and new yellow poplar; but the poplar will weather quickly, I am told, and the strokes of nature's paintbrush will soon make them all of a like hue.

Our reason for restoring these buildings encompassed a two-fold goal: first and most immediately, to provide a hands-on learning activity for students in Appalachian Folklore classes; second and more long-range, to produce a nucleus for a living culture museum that we hope will serve both the university and larger surrounding communities. From our earliest involvement with the Selu Conservancy Project, Appalachian Studies has envisioned a living culture museum whose goal will be to depict the recoverable past, that is, early-to mid-twentieth century. We have informants who actually lived on the farm in the 1930s and 1940s, and we are looking for others who know something of the life there before 1930. Our dream is to restore the log house described above and to reconstruct the I-house that served as the homeplace on the property.

Our task has become more challenging in recent weeks by virtue of a new gift of an additional 200 acres in the same area. This gift comes from another branch of the Bowles family, the heirs of Hargrove "Skipper" Bowles of North Carolina. It is directly traceable to the influence of the original donor, John Bowles.

In our attempt to learn as much as possible about the history and culture of this land and the people who have lived on it, we welcome information, suggestions, and help. The property, in the amount of approximately 400 acres now, is located in the Dry Valley area of Montgomery County, along the Cracker's Neck section of the Little River about one to three miles northeast of its confluence with the New River. Before the Bowles family owned it, it belonged to J. S. Peters, to W. L. and Arintha Peters, to N. T. Showalter, to N. B. Harvey, and others as the years unfold backwards. Parts of it have joined land known as the Grange tract, the Zoll land, the Sale land, and the John Peterson tract.

### BRIEF SKETCH OF THE COURTS OF THIS COMMONWEALTH

from "Virginia Cases or Decisions of the General Court of Virginia, 1815 - 1826", Vol 2 (Virginia Reports Annotated) by William Brockenbrough published 1827, reprinted 1900

1. County Courts are composed of Justices appointed and commissioned by the Governor with the advice of the Council of State........ Four Justices at least are necessary to compose a Court, and on the trial of slaves, charged with felony, the number consists of five at the least. The justices serve without fee ..... for although it is sometimes said that the annual appointment of the Justices in rotation to the office of Sheriff with the continuance for two years, is a compensation for the Judicial office.

These are Courts of general jurisdiction in Law and Equity; the most important duties in matters of police and economy are confided to them; they nominate militia officers (below brigadiers), sheriffs, coroners, &c, and they are Examining Courts of free persons charged with offences, and decide whether they shall be discharged, and acquitted from further prosecution, or may be tried in the Superior or County courts.

The Corporation Courts are composed of a Mayor, Recorder and Aldermen; their appointment, etc, depend on the charters of the respective cities, boroughs and towns.

2. The General Court, and Circuit or Superior Courts, -- The Judges of the General Court are appoint by joint ballot of the two Houses of Assembly .. and hold their office during good behavior.

At the first organization of this court in Oct 1777, it consisted of 5 judges, any 3 of whom to form a quorum.

At that time, its jurisdiction was general over all persons, and in causes, matters or things at Common Law, whether brought before them by original process, by appeal ...... But no original suit could be brought for a less sum than ten lbs, or 2,000 lbs of tobacco. The process of the Court extended to every county of the State.

It was a Court of Oyer & Terminer for the trial of all treasons, murders felonies, and other crimes and misdemesnors, committed by any free person. Offenders in any part of the State charged with treason, or felony must have been, and with misdemesnors might be, tried there.

lished. The General Court by the Act of 25 Dec, was made to consist of ten judges, and they were made judges of the District Courts. Each district consisted of several counties. 2 judges were to sit in each court. There were finally 19 districts, and to each couple of judges, were alloted four districts, except one, which had 3 districts. The whole of the jurisdiction of the General Court in civil and criminal cases, (with certain exceptions,) was transferred to the District Courts, their authority extending over the respective districts, as that of the General Court did over the whole State. No original suit or appeal was, however, allowed for a less sum than \$100, or 3,000 lbs of tobacco; now any Supersedeas, or Writ of Error, for a less sum than \$33 1/3, or 1,000 lbs of tobacco.

The General Court being thus stripped of the greater part of its jurisdiction, it was declared that 3 judges should constitute a Court, except in cases of impeachment, when a majority of 10 was required.

### Virginia Court System

The jurisdiction of the General Court now extended for the most part to the following subjects: .. the Fiscal Court; suits & motions agst public debtors, collectors and defaulters,..... It received probat of Wills, and granted Letters of Administration, and received proof of Deeds, but its jurisdiction in these respects was concurrent with that of the District and County courts. Questions of Law in civil cases might be adjourned to it by the District Courts, and there decided,..... The criminal jurisdiction extended to impeachments of the higher officers of the government, etc...... to such questions of Criminal Law as should be adjourned to it by the District Courts with the consent of the criminal, and to certain treasons, misprisions, and other offences committed out of the jurisdiction of the Court of Common Law. .......

By the Acts of 1 Feb 1808 & 4 Feb 1809, the District Courts were abolished, and Circuit Courts, or Superior Courts of Law in each county of the State were substituted in their stead...... by 1819 there was 15 Circuit Courts ...... Each circuit consists of about 7 counties on an average: there is one of only 2, and another of 10 counties.

The jurisdiction of the Circuit, or Superior Courts of Law in Criminal and Civil Cases, was declared to be the same over their respective counties that the late District Courts exercised over their respective districts, ........

The jurisdiction of the General Court continued as before.

3. The High Court, and Superior Courts, of Chancery. -- Judges in Chancery are appointed by joint ballot of the 2 Houses of the General Assembly, ...... and hold their offices during good behavior.

(Editor's note: General we [genealogists] usually only look at the County or Corporation Courts [order books] when there are other courts we should go to --I have found wills in the Superior Court records, suits over lands, etc. -- don't overlook any source for that information you need. The more understanding you have of the records of the period you are researching, the better the chance of finding that information you want.)

## NATIONAL UNION CATALOG OF MANUSCRIPT COLLECTIONS

It is called NUCMC -- pronounced "NUCK\_MUCK" It means National Union Catalog of Manuscript Collections. .................. If I want to find missing documents, daguerreotypes, cartes de visite, Civil War letters, or military records on Craig, I look in the NUCMC and it tells me lots of missing family collections in America. These 24 huge volumes, and it's fantastic! On my Cockrell line... I had worked for years on that line, and here in NUCMC it tells me the four places that my family had deposited -- for the Yankees took some of the records during the Civil War from my Benton County Cockrell line, and deposited them way up North. Without NUCMC I'd never know where they are deposited.

What line are you working on in America? Look in the indexes of NUCMC -- it's a multi-volume, big series.

Jane Reed Taylor was married to Pleasant Coleman Taylor and was the daughter of Jonathan and Eliza (Sanders/Saunders) Tharp of Surry Co, NC. Pleasant was a mail carrier (by horseback) from Max Meadows to Fort Chiswell, Va until his death 24 May 1893.

Nancy Jane (Taylor) and son John Newman Childress died in McDowell Co, WV and was buried in Dorey Furnace Cemetary, Pulaski, Va, with her mother Jane Reed Taylor. A power pole pylon in in Jane's grave.

### HINTS ON MARRIAGE IN VIRGINIA

by Babe Fowler

Reading a paper on a Virginia family, it stated that there were two dates for a marriage - 5 Aug or 9 Aug 1819. The 1st date is probably the marriage bond and the 2nd the date of marriage. After the Revolutionary War, there were 2 ways to be married. (1) Banns: To announced publicily (usually in church & once a week) for 3 consecutive weeks their intentions to be married. The minister who preformed the marriages was to record it in the court house. The only payment (if the groom had any money) was to the minister.

(2) The groom-to-be would go to the court house and obtain a marriage bond. The bond meant that there was no reason why the marriage would not take place. The surety would be a relative, friend, or a person at the court house who knew the groom and had property that amounted to the amount listed on the bond. If the bride or groom was under age, the parents or guardian were to give permission - written or oral - for the couple to be married or state that they were of age. I have found this age qualification noted on the back of the bond. This bond was to be recorded in the marriage bond register after a fee had been paid to the clerk. This fee was one of the reasons that many were married by banns and many lived too far from the court house to get a license. The clerk then gave a license, which the groom gave to the minister performing the marriage who filled it out with the date of marriage & returned it to the clerk at the court, who then recorded it in the minister returns book. The minister often only filled out a sheet of paper with one or more marriages that he had performed over a period of time and returned that to the clerk. This law applied until 1853 when the bond was no longer required. The forms were printed but generally written out. The bonds after being recorded were often put to other uses as paper was scarce, thrown out for lack of space, destroyed when the court house was burned, given away or stolen, - so we are lucky, if we find any of the marriage documents in the court house.

### Murphy's Law on Marriages

Now that you know what the law (there were other legal requirements but the above are the major points) was and what should have been done - remember that humans were doing these things. The minister may not have recorded the marriage (could be write?), put the wrong date (day, month, year) down; put the wrong name down (one minister return, the minister put down the father's name instead of the bride) or spelled the name in such a way that it couldn't possibly be the name you are looking for (go by sound). Or the minister recorded 'your' marriage in another county. Many of the ministers considered the marriage records as their personal property - not that of their church. Many of these records have turned up in private collections, archives, public 8 private libraries. What were the beliefs regarding marriage of the minister that performed the marriages? I was given this explanation as to why some ministers did not record marriages in the court house. I do not know if it is true - but it sounds logical. After the Revolution, many of the ministers stated that marriage was a religious rite and not a civil rite, therefore, it was not the concern of the state and did not have to be recorded with the state. This went on until the question of who was the legal heirs -- no recorded marriage, then other members of the family would inherit.

I have not come across a case where a suit was brought because the marriage didn't take place, but do know of a case where the bride changed her mind - one week after the first bond was issued, another bond was issued with her guardian writing a consent stating that she had changed her mind. Both bonds are recorded in Botetourt Co, Va. If the bride and groom lived in different counties, the bond should be recorded in both counties. And the minister record the marriage in another county. If the clerk of a county had died or for some reason was not available, the groom would go the another county for the bond - also, if there was an illness, such as smallpox, in the area. The couple would cross state lines to be married. Be known by a nickname or middle name and use their first name only - might be the only time it was ever used. Living too far from the court house, the couple may be married by an itinerant minister or married by a parent or friend who was a layman in their church without a license. When the license was obtained, they were 'legally' married with their small children close by.

Now for the clerks and their offices. Remember that the marriage books are copies and some books have been copied several times. Those of you who have read the early records know that the handwriting can be beautiful to unreadable. The clerk and those who copied the original could have misread the names just as many of us have done. Marriages could have been combined - making one when there is actually two. Indexes can be wrong - unable to read the names so the wrong one is put in the index and you look no farther.

One 'last' word - on the books that have been published. I have heard many people say, "Well, it was printed by ---- and ---- and ---- so it must be true." Once a date, name, etc, has been published, someone else prints it, another printing, so it must be true as so many sources have the same information. Use any printed material as an aid in your research not as a fact. There are genealogists, who have published records, that I am more willing to believe than others. If possible, see if you can get a copy of the original documents. The worst is the book that states the records are here because the law required it. The law may require it, but us humans don't always do what the law tells us to do. And the archives and libraries are on the bottom of the list for receiving government monies, so many of the documents are unknown or have been destroyed by not having proper storage facilities. The typist makes errors, the printer makes errors and all are not caught. I know for I have made too many errors that has not been caught until after VAN has been printed.

The last four paragraphs are just a few of the reasons of why you can't find the record that you need. And then there are some things that I haven't thought of that will happen to you and make you go up the wall. But don't give up, the data may turn up when you least expect it and where it is not suppose to be. Then there are the good things - like getting all 5 marriage documents, having someone hand you the data you need without asking for it.

### MAIDEN NAMES

by Robert Hoover

Without a doubt, unknown "maiden names" can prove to be one of the most difficult things to locate in genealogy work. Unfortunately, in our frustration, we often tend to overlook two of the most prolific sources available for this information. They can be found among the local property record archives. Namely, they are "DEEDS" and "MORTGAGES". The techniques are as follows:

- "DEEDS". In the lower left hand corner of most deeds you will find the signatures of from two to four witnesses. The first one is always from the husband's side. The next one is always from the wife's side. That is to protect her one/third dower right under the law. Nothing you will ever use will give you greater clues to maiden names than the witnesses on those old time deeds.
- "MORTGAGES". In the 1800's and even long before that, it was traditional, when the daughter got married, as a part of her dowry, for her father to either cover the loan or carry the note for his son-in-law. So, if you are working in Nova Scotia or New York in 1840 and you know his name and he is married to Anna Maria, but, you don't know her maiden name, find out who they were making their payments to, because 70% of the times it will be her father!!

The mortgage records in America, including Canada, and the witnesses on deeds are out greatest clue to maiden names. Use them!! from 'Cracker Crumbs', Manasota Gen Soc Inc, 1405 - 4th Ave W, Bradenton, Fla 34205.

(Editor's note: DEEDS: The law of Virginia was that the wife was examined in "privy" (without the husband being present) as to whether she was selling her dower right of her own free will and not under duress. If she was not examined, the wife could come back at a later date and sue for her dowry right. You may not always find witnesses to the deed because of the "privy" law. If the deed was written at home, there will probably be 4 or more witnesses. It was up to the grantee to record the deed and, many A few notes on deeds: times, he did not record it. Or he would sell the property without recording it. [More problems for us] When this happens, a later buyer might sue former owners or heirs to obtain a clear title to the property. Their statements would prove relationships. To be sure of what applies to your research, check the laws of that state and remember that we are dealing with people who do not always do what the law states. Also the clerk may not have recorded the deed when it came in or recorded it many years later. So check all the records in the deed books for that name you are looking for -for some names, use your common sense.)
