Mary Jane Vaden, who has served our organization in many capacities, needs someone who is interested in taking over the recording of our many exchange quarterlies. Sept 13, 1855, Floyd County, Delilah Smith (1827-1909), daughter of Henry A. & Catherine Smith. They had three children: Angeline, Virginia and Eliza)

William Jenkins to Lilah Jenkins Lynchburg, Va., March 23, 1862

Dear wife - I seat myself to write you a few lines to let you know that I am wel and I hope this wil find you all wel. We got to Lynchburg yesterday and wer examend and they wouldnt let me off. We all three have to go on to the regiment. I dont want this to greave you for the God who rules heaven and earth wil be with his people in the sixth truble and wil not forsak them in the seventh. We are in an old tobacco factory. The people are as much excited here as they was at home. I want you all to do the best you can. We have nothing but bred and meat to eat here and everybody says the war will have to close. I trust to God it wil. You needent to write to me til I write again. No more at present but remain your loving husban, so farewell

W. Shelton. May God bles us all is my prare so farwell for a while when you write let me know how you ar geting along with your work no more but remain yourstil death farwel Wm. Jenkins

that you was all wel and doing as wel as you are. I am happy to inform you that I am wel and tolerable wel satisfide tho I would be a heap better satisfide if I was at home with you all for I am getting very tired of lying on the ground tho we must put up with it and do the best we can. A camp life is a hard life to live at the best. You rote you had your corn in a heap and wisht I was there to help you shuck it out. I reckon, Dear Lilah, you don't wish it more sincerely than I do for the time seems long sins I saw you all but I do sincerely hope and pray to God that it wont be long til we shal have the plesher to seeing each other agane. I want you if you hant got grane enuf to do you to buy enuf to do you and what stock you have and if you hant got money enuf to buy with, buy enuf to do you and I wil send you some money the first chance I have. Everything is high and God only knows what two or three months may bring forth. Brother John is complaining of not fealing wel but I reckon it is nothing but cold. Tel the girls that he has rote them three or four letters and hasent got any answers to them and he wantsto hear from them, Pap and Mother and Nan. I was glad to hear that you was wel and I reckon you dont want to see me any wors than I do you. So I must close for the present. May God bles us all is my prayer, so farewel for a while. Wm. Camp Near Richmond, Va. May 14. 1863

Dear Sister - I seat myself to write you a fiew lines to let you know that we are both tolerably well at this time and hope that these fiew lines will come safe to hand and find you well and all of your little children well. I havent got any nuse to rite to you that would be interesting to you more than I have had a long and tiresome march from Suffolk we had a rough march of it we had to march through creeks and mud and some places the water was about half leg deep in the road for miles and we had to march very fast for we was on a retreat and the Yankee cavilry was after braking down men and straglers. We marched about US 85 miles in les than 6 days we got to this place on the 10th of this month I dont know how long we will stay here but we just stopped here to rest and draw clothing and shoes I hope we will stay here a long time for I want to rest a while for I have been marching and fiting as mutch as I want to do. Dear Sister I will impart to you something about your husband's papers and money if you havent got the papers that he had when he was sent to the hospital when he left us he had about 75 or 80 Dollars in money and he had a bond on Albert Mathus for about 25 Dollars and John W. Haden was Security on the bond and I thought it was my duty to inform you about it and if you havent got the money nor the bond you had better get somebody to talk to

Captain Shelton about it I recon that he knows the place whare he died and maby he would know who was in charge of the hospital at the time when he died and if does you had better give him something to get it for you. Give the children my love and best respects and tel them that I would like to see them the best kind and that I hope this war will soon end and that the Lord will spare me and let me live to return home again and see them So I will now close hoping to hear from you soon may God bless you all is the prare of your dear brother

Dear Sister: Through the kind providence of God I am spared up to this time and take pleasure in droping you a few lines to let you know that we are both tolable well at this time and hope when these lines comes to hand that they may find you and all the rest well. We are in prety good winter quarters but we dont know how long that we will stay I was in hopes that we would get to come to Virginia but I am afraid that we wont get to come but Cornel Trigg sends word that he thinks that we will get to come by March I do wish that we may for the fare is verry hard we dont draw no flour nothing but corn and been (sic) beef such as we would not eat at home you wrote to me that you was in hopes that thare would be peace this spring but thare is not mutch prospect of peace as I can see unless the solgers just comes home anyhow thare has not bin anybody reinlisted in our brigade as yet and I dont think that they will the generals are so hard on the solgers that and the gard duty so hevy that we cant hardly stand them you wrote to me to try and get a furlow to come home but I fear that thare is no chance of me a furlow. So I will close for the present write sune I remane your affectionate brother until death

Camp Glade Spring, Washington Co. June the 8, 1863

Dear Wife and Children - I seat myself down to let yew know that I am well as comon and when these few lines come to hand they may find you enjoying the same blesing and doing well and I wood like to see you and the children. I hope an trust to God it wont bee long till this distressing war will come to a (illegible, line in fold of paper) ever again as we once did. Dear Wife we must put our trust in God for he is with us wherever we ar and hee sees and knows everything we do for hee is with us nite and day. Dear Wife I hant got much nuse to write to you at this time and I want you to doo the best you can for yourself till I com home. An tell the children they must doo all they can for you and therselves and I want you to let me know whether you heerd from Sire latly and I want to know how you ar giting along with your work and how your (line illegible) and you must giv all the best nuse you can from Floyd and tell mee whether Thomas is gone or not. There is a talk about us a leeving here and a going to Tenneesee but I dont know whether we will or not Dear Wife I want you to write to mee as often as you can an dont forget to write and ile rite every week if I can or every two weeks I could a got mee a substitute since we bin here for three thousand dollars in cash Dear Wife I must bring my leter to a close but I would much rather tell thes things to you than to write it to you It would bee more pleasure to mee Write soon as you can I will bee your afectionat husband until deth Daniel

Daniel Bower to Elizabeth Bower

Camp Naroes (Narrows) June the 25 1863

Dear Wife I this raney morning seet myself down to drop you a few lines to let you know that I am well as for helth I have got a bad coff an cold by giting so wet I received your kind leter dated the 18 of June and was trewly glad to reed your kind leter an to heer from you an that you was all well as comon an doing well and I hope when these few lines come to hand they may find you all well an doing well dear wife you say your crop looks fine and I am trewly glad to heer it and I wish I could bee with you there and the children I hope an trust to God it wont bee long before this trublesome wor will stop so as we all can return home to owr wives an children but God only know when it wil bee we must put our trust in him I hant got much nuse for you we have a gradeel of gard duty to do it takes about eighteen a day bee sides the pickets there is eight pickets on every day I was out on picket yesterday we stan twenty fore owrs at a time but I dont care if we can stay hyr which we will I reckon

from what they say I hant heerd from William sence we left him they have had a hevy batle in Tennesee an the fifty forth was in it and they say they was cut all to peces but I dont know it to bee so It may bee false report I want you to write to mee if you have heerd from Shelvy latly I got a leter from \_\_\_\_\_\_\_ yesterday and hee says his family is all well I must bring my leter to a close by saying ile bee your true and afectionat husband til deth

## LEGISLATIVE PETITION for GILES and PULASKI COUNTIES, VIRGINIA

To the Honorable the General Assembly of Virginia

The petition of the undersigned a citizen of the County of Giles in the State aforesaid would most respectfully represent, That a turnpike road from the said County to the County of Pulaski across Cloyd Mountain, has been long desired by a great portion of the Citizens of the South, west, and is unquestionable called for by the best interests of this part of the State, with a view therefore to, its Construction, your petitioner prays that your Honorable body pass a law authorising your petitioner to construct a turnpike road at a grade not exceeding five degree across said mountain, to Convene at Fo point near the great crossings of Walkers Creek in Giles County, passing through the Gap of Walkers mountain and across Cloyds mountain to back Creek in the County of Pulaski -- Your petitioner askes that said road be required to be made eighteen feet wide or a less width except at such points as may require digging & there to be a less width, not less than fifteen feet ------ Your petitioner askes that

## EVENTS OF OUR CHILDHOOD

by Rosalee Collins Pless 1877-1966

(Written in 1913)

When I was about six years old, my father put a few household goods in a covered, one-horse wagon, and started out to Wise County, Virginia, in the fall of 1883. We three children rode on the one seat in the front end of the wagon, while our father held the check lines and drove, walking along side the wagon and my mother trudged along behind us. The wagon was drawn by a fine old, 25 year old, Percheron mare of almost human intelligence.

I shall never forget an incident that occurred on the second or third day of our journey. We were travelling on the first hard surface road ever built in that part of the state. We were nearing the point where the first railroad was built in that part of the state crossed the rock road when we heard a train whistle. We children had never seen a train, and father supposed that old Puss, the big mare, had never seen a train either; so my mother yanked us out hastily and placed us on a high stack of lumber by the roadside, jerked off her old split bonnet to cover the mare's right eye with it, and my father covered the left eye of the mare with his old broadrimmed felt hat. Old Puss only raised her head and wiggled her ears a little, and the men on the train platform lauged heartily and cheered.

My father bought land and raised a crop the first year we lived in Wise County. During that summer while he was building a cabin on his land, we lived in a house on a farm, located about two or three miles from Pound Gap on George's Creek between two high mountains.

This summer was a very hot, dry one, so much so that the waters dried up till only pools of water thick with clouds of almost pure sulphur remained along the creek. An epidemic of mountain cholera took the life of my four-year old sister, and tho I too became ill with it, my life was miraculously saved. The wife of the man who had bought the rest of the big farm, had brought some whiskey along when she saw how sick I was. She took a half-teacup of the whiskey and set fire to it; when the blue blaze died out, she had me drink what was left in the cup. They always felt that this is what cured me. Soon the early frosts and fall rains had seen from one to five family members lying dead at one time. The next spring in the month of May brought another little girl to take the place of my deceased sister, but she too was with us only 18 months when another scourge of cholera took her away. This saddened my father so much that he sold his little cabin and started to Cumberland Valley in east Tennessee to find a new home. We traveled this time in a covered wagon drawn by two mules. After we had got out on the Cumberland mountain, we camped on a flat rock on what seemed to be table land, and next morning drove back to Crossville, Tenn., and on back to Carroll Co., Va. where my father again bought land. This was in the fall of 1887. The winter of 1888 saw another little sister born, and die. That was the year that my father bought me my first little china doll.

Before that time, my mother had always made our rag dolls, making whole families for each of us. We would take a market basket of our rag dolls and play all day in the shade of a green tree, until our ma called us. But the tradgedy of death of our four year old sister destroyed the joy of playing with dolls for us, as well as many other pleasures of childhood activities. So we buried the three families of rag dolls between the little houses over the two little graves of my sisters.

At this stage of our childhood, times were hard, work and money scarce, wages low. My father worked in the iron mines to support his family and pay for his land. Our shelter at first was a leaky old house made of logs. I remember one night a girl friend of mine stayed overnight with us, and it rained so hard and leaked so badly that we had to sleep under a big old umbrella. Notwithstanding, our parents were courageous and worked with a vim to fix up our home and send my younger sister and I to school, four miles away which we walked.

We had much Bible reading in our home, and singing of songs. And my father, who was not highly educated, stressed education for my remaining sister and I. He was very gratified when I graduated from Milligan Business College, Tenn., in 1902.

(Note: Rosalee Collins Pless was daughter of George and Sinia Smith Collins, who last lived near Hillsville, Va. She was the last of her line, as she had no children, and her sister never married. Rosalee was a fine artist and well known around Russellville, Tenn., in the 1930's, where she then lived, for her skill and talent in spinning, weaving, and making of cornhusk dolls.

### BIRLEY'S LETTER

This letter was written by Lou Gordon Birley of Marion, Indiana, to ther parents George and Susannah Bish Gordon of Giles County, Virginia. Catherine mentioned in the letter was her mentally retarded sister who lived with her parents. Uncle John Cain and Aunt Caty (nee Gordon) lived near Lou Birley. Only these two sheets survived the years. The letter was written prior to December of 1883, because Susannah Bish Gordon died 10 December 1883.

But marion is a hed of time in everything all But her streets they have Bin Building schoolhouses court houses railroads and let ther streets go like a mud hole i think that is economy well enoughf of that. father i will send you & mother & Catherine a Crhistmas present of two eollars as i did not get the things reddy that in intended to send you i would send you a dollar a piece if i had it this is my own money that i send to you i want you to keep mother in good shoes for i think she has deserved them. Russell Co, Va, Order Bk 6, p 30: May 2, 1818: Michael Sword who resides in the county of Russell in the state of Virginia wishing to become a pensioner pursuant to the provision of an Act of the Congress of the United States passed the 18th day of March 1818 entitled "an Act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war," personally appeared in Court and declared on oath that he enlisted as a private soldier in Winchester in Virginia some time in the year 1777 as near as he recollected, under Col. Nevil. He did not recollect the number of the Regiment, but it was in the service of the United States. He served nearly four years and was discharged at Williamsburg in Virginia. He was in the battle fought at Germantown where he was taken prisoner and sent to Philadelphia. he was sent from thence to New York and was there exchanged and joined the American Troops at White Plains - under Col John Nevil and passed through the Jerseys till orders came for a detachment to South Carolina, that Col Crabtree commanded the Troops until their arrival at Charleston. That he was taken prisoner again at Charleston. That the first captain under whom the said Michael Sword served was Capt Robert Higgins. he afterward served under Captain Leonard Cooper. he does not at present recollect the name of the officer who discharged him. He also stated that Col Nevil was first in command of the detachment that went to Charleston. And from the knowledge which some of the members of the court themselves have, as well as from other satisfactory evidence, the Court are unanimously of opinion and do certify that the said Michael Sword is a person of credit as a witness; that it was generally understood in the neighborhood of the residence of the sd Michael Sword previous to the passage of the said Act of Congress, that the said Michael Sword served in the revolutionary war; and that the said Michael Sword is in such reduced circumstances in life, as to need assistance from his country for support. All which is ordered to be certified to the Secretary of the Department of War.

Bk 6 p 46; 2 June 1818: The following affidavit taken before a justice of the peace for this county to corrobrate the proof offered at the last Court by Michael Sword, an old revolutionary soldier was produced in Court, and ordered to be certified, and is in the following words, to wit: Russell County, to wit; This day personally appeared before the subscriber a justice of the peace for Russell County aforesaid **James McKinney**, a person to me well known and made oath on the Holy Evangelist of Almighty God, that this affiant was drafted and served as a soldier in the Northern Army under General **Washington**; that while in Winter Quarters at Middlebrook in the jerseys where Major **William Grohan** commanded he knew and was acquainted with Michael Sword whom he understood to be a private enlisted soldier in the regular service of the United States. This acquaintance continued from the 27th of December 1778 till the 16th of July 1779 when this affiant was discharged. **James McKinney**. Sworn to and subscribed before me this 22 day of May 1818. **James Dickenson**.

Bk 6 p 131; July 6, 1819: This day personally appeared in Court Michael Sword who at a Court held for this County the 5th day of May 1818, made a declaration on oath for the purpose of obtaining the pension allowed by the

Act of Congress of the 18th of March, 1818, and further declared on oath that the line he served in was the <u>Virginia</u> <u>Line</u>; and he being interrogated by the Court upon the points stated in his first declaration, the Judge of this Court is of opinion that his statements aforesaid are true which is ordered to be certified to the Secretary of the Department of War.

## IT'S THE LAW

Virginia Statutes Pertaining to Cemeteries

(Continued from VAN 1991 Vol. XV, page 132)

## Article 3. - Disposition of Property for Maintenance and Care.

- S 57-32. Who may hold such property. Any cemetery company chartered under the laws of this State, or the trustees of a church, or any trustees holding title to a cemetery, or burial ground, may take and hold any property granted, be-queath, devised, or given upon trust to apply its income to the improvement, repair, or embellishment of the cemetery, or any burial lot or monument or tomb or vault or other erections in such cemetery, according to the terms of such grant, bequest, devise, or gift. (Code 1919, 59; 1918, p. 103; 1920, p.10.)
- S 57-33. Limitation on amount. No gift, grant, devise or bequest from any 1 person for any and all of the purposes named in this article shall exceed \$30,000 in value or amount, and any such gift, grant devise or bequest heretofore made not in excess of \$30,000 shall be valid; nor shall the aggregate amount and value of all gifts, devises and bequests which may be held for the improvement, repair or embellishment of any single lot in any cemetery or burial ground, including the monuments, tombs and vaults therein, exceed \$10,000 at any 1 time. All gifts, grants, devises and bequests for such purpose in excess of the amount herein named shall be void. (Code 1919, § 59; 1918, p 103; 1920, p 10; 1952, c.350.)
- S 57-34. Amount to defray original cost not limited. Nothing contained in this article shall be construed as limiting the amount which may be given, bequeathed or devised to defray the original cost of the cemetery, burial lot, monument, vault or other like erection or structure, nor shall this article be construed as affecting any estate that has been distributed or settled on the basis of the law then existing. (Code 1919, S 59; 1918, p 103; 1920, p 10.)
- S 57-35. Trusteeship for administering funds for perpetual care. The board of directors of any incorporated cemetery company may by bylaw establish a trusteeship for holding and administering all funds paid to such cemetery company for the perpetual care of any lot or lots in the cemetery conducted by the company, and such trusteeship, once established, shall only be revoked, annulled or modified by and with the consent of the circuit court of the county or the corporation court of the city within whose jurisdiction the cenetery is situated. (Code 1919, § 59; 1918, p. 103; 1920, p. 10.)

ARTICLE 3.1. - Endowment Trusts for Perpetual Care.

S 57-35.1. Definitions. - The following terms used in this article shall, for its purposes, have the following meanings:

"Cemetery" means any land or structure used or intended to be used for the interment of human remains. The sprinkling of ashes or their burial in a biodegradable container on church grounds shall not constitute the creation of a cemetery.

"Interment" means all forms of final disposal of human remains including, but not limited to, earth burial, mausoleum entombment and niche or columbarium inurnment. The sprinkling of ashes on church grounds shall not constitute interment.

"Endowment Care Fund" means a fund created to provide a sufficient income to a cemetery which will enable such cemetery to provide care, maintenance, administration and embellishment of such cemetery adequate to the circumstances. It includes the term "Perpetual Care Fund" and the two terms are used interchangeably.(1964,c. 534; 1981,c.268; 1985,c.186.)

- S 57-35.2.Certain representations unlawful; minimum trust fund required. -After June 26, 1964, it shall be unlawful for any person, firm, association or corporation, hereinafter referred to as "person," owning, operating or developing any cemetery to sell or offer for sale in this State, either as principal or otherwise, any lot, parcel of land, burial or entombment right in such cemetery, and in connection therewith to represent to the public in any manner, express or implied, that the entire cemetery, a single lot therein, or burial or entombment right therein will be perpetually cared for, unless adequate provision has been made for the endowment care of the cemetery and all lots, burial or entombment rights therein as to which such representation has been made. Each person who shall undertake to develop any such cemetery after June 26, 1964, shall deposit in a bank or a savings and loan association in this State in an irrevocable endowment trust fund a minimum of \$25,000 before the first lot, parcel of land, burial or entombment right has been sold. (1964, c.534; 1977,c.52.)
- S 57-35.3. Deposit in trust fund required upon sale of interment right, lot, etc. - Each person owning, operating or developing any such cemetery before or after June 26, 1964 shall hereafter deposit in a bank or savings and loan association in this State, or in another state, if such person has, prior to June 26, 1964, entered into a trust agreement by which he is required to make at least the minimum deposit required hereunder, a minimum of ten per centum of the receipts from the sale of lots, interment rights and aboveground crypts and niches, excluding belowground burial vaults, which amount shall be paid in cash and deposited with the trustee of the care fund not later than thirty days after the close of the month in which such receipts are paid to such owner. Provided, that in the case of such sales made prior to July 1, 1975, such deposits of at least ten per centum of any payments shall be paid to the trustee not later than thirty days after the close of the month in which any such payments on the sale are thereafter paid to such owner and all of such deposits shall be paid to the trustee not later than thirty days after the close of the month in which all payments on the sale are completed. (1964, c.534;1975,c.570;1977,54.)
- S 57-35.3:1. Additional deposit not required upon subsequent sale of the same lot, etc. - In the event ten per centum of the sales price of the items mentioned in S 57-35.3 have been deposited in a care fund before or after June 26, 1964, no care fund deposit shall again be required on subsequent sales of the same lot, crypt or niche. (1964,c.534.)
- S 57-35.4. <u>Recovery of amount of original deposit.</u> Whenever such person owning, operating or developing such cemetery has deposited in the perpetual care fund a sum equal to twice the amount of the original deposit as provided in S 57-35.2, exclusive of such original deposit, the trustee shall then allow such person owning, operating or developing such cemetery to recover the original deposit by withholding up to \$25,000 of the amounts thereafter due the care fund or until the amount of the original deposit in the care fund has been recovered. (1964,c.534.)

\$ 57-35.5. Who may serve as trustee; bond. - The trustee of the endowment care fund shall be appointed by the person owning, operating or developing such cemetery, and shall be removed only as provided by \$57-35.All trustees, other than banking institutions operating under the laws of this State or national banks operating within the State, maintaining a trust department, or a state or federally chartered savings and loan association located in this State with federal insurance of accounts authorized to do business in this Commonwealth, shall furnish a fidelity bond with corporate surety thereon, payable to the trust established, which shall be designated "Endowment Care Fund (or Perpetual Care Fund) for (name of cemetery)," in the penel sum equal to not less than fifty per centum of the value of the principal of the trust estate at the beginning of each calendar year, which bond shall be deposited with the commissioner of accounts of the county or city wherein the principal office of the person owning, operating or developing such cemetery has its principal place of business, or if such person be a nonresident corporation, then within the county or city in which the cemetery lies; provided, however, that no trustee who is serving upon June 26, 1964, shall be required to furnish corporate surety as provided herein.

For the purposes of this chapter, savings and loan associations which are under state supervision and federal associations located in this State organized under the laws of the United States and under federal supervision are authorized to act as a trustee for any deposit which is invested in a savings account of the association, provided that such institution's deposits are insured by the Federal Savings and Loan Insurance Corporation.(1964,c.534; 1978,c.459.)

- S 57-35.6. Application of Title 26. Trustees appointed hereunder shall be governed in their conduct by the provisions contained generally in Title 26 of the Code of Virginia, except as provided otherwise herein. (1964,c.534.)
- S 57-35.7. <u>Reports of trustees; audit of records.</u> -Trustees appointed hereunder shall report within four months after the close of each fiscal year to the commissioner of accounts of the county or city wherein the person owning, operating or developing the cemetery has his principal place of business, or if such person be a nonresident corporation, then in the county or city within which such cemetery lies, the following information:

(a) The total amount of principal of endowment care fund held by the trustee;

(b) The securities in which said endowment care fund is invested and the amount of cash on hand as of the close of the fiscal period;

(c) The income received from such endowment care fund during the preceding fiscal year; and the trustee shall further submit an affidavit furnished by the person owning, operating or developing the said cemetery stating that all provisions of this article applicable to such person have been complied with.

(d) The commissioner of accounts shall audit the records tendered by the trustee as well as any sources thereof which he deems necessary, at least annually and shall have full power, including power of subpoena, to inspect the records of the cemetery owners or operators. Failure to comply with the subpoena of the commissioner shall constitute a misdemeanor. (1964,c.534; 1975,c.581.)

S 57-35.8. Use of income from fund. - The income from the endowment care fund shall be used solely and exclusively for the general care, maintenance, administration and embellishment of the cemetery and shall be applied in such manner as the person owning, operating or developing such cemetery may from time to time determine to be for the best interest thereof. (1964,c.534.)

- S 57-35.8:1. Records and reports of owner, etc., of cemetery.- Each person owning, operating or developing any cemetery subject to this article shall record and keep, in a book maintained for that purpose, detailed accounts of all transactions, receipts and accounts receivable subject to \$ 57-35.3, and of all expenditutes under \$ 57-35.8; and such records shall be subject to examination by the commissioner of accounts of the city or county in which the cemetery is located, or by his designated representative. Each such owner, operator or developer of such cemetery shall report annually to the commissioner of accounts the totals of all receipts subject to \$ 57-35.3, and of all expenditures under \$ 57-35.8. (1975,c.570.)
- 8 57-35.9: Repealed by Acts 1975, c.581.
- S 57-35.9:1. Further provisions as to exemption of certain cemeteries. The provisions of this article shall not apply to cemeteries owned and operated by a county, city or town or by a church or by a nonstock corporation not operated for profit if such corporation shall once every three years file with the Commissioner of Accounts proof that (1) the corporation has not compensated any officer or director, by salary or otherwise, except for reimbursement of reasonable expenses incurred in the performance of duties as an officer or director: (2) that such corporation is not engaged in the sale or construction of vaults or lawn, garden or mausoleum crypts, as defined in \$ 57-39.8; and (3) that the proceeds from the sale of all gravesites, burial rights and entombment rights in such cemetery have been used or are being held by it for the sole purpose of defraying the direct expenses of maintaining such cemetery. (1978, c. 542.)
- S 57-35,10. Violation of article a misdemeanor. Violation of any provision contained in this article shall constitute a misdemeanor and each act or failure to act in violation hereof shall be a separate offense. (1964, c. 534.)

Article 4. - Abandonment; Removal of Remains.

S 57-36. Abandoned graveyards may be condemned; removal of bodies. - When a graveyard, wholly or partly within any county, city of town, has been abandoned, or is unused and neglected by the owners, and such graveyard is necessary, in whole or in part, for public purposes, authorized by the charter of such city or town, or by the general statutes providing for the government of counties, cities and towns, such county, city or town may acquire title to such burying ground by condemnation proceedings, to be instituted and conducted in the manner and mode prescribed in the statutes providing for the exercise of the power of eminent domain by counties, cities and towns. The court taking jurisdiction of such case may, in its discretion, require the county, city or town to acquire the whole burying ground in which event the county, city or town may use such part thereof as may be necessary for its purposes and sell the residue. The court, however, shall direct that the remains interred in such graveyard, if possible so to do, be removed to some repository used and maintained as a cemetery. (Code 1919 § 54; 1985, c.95.)

Montgomery Cty., Va. Go out Rte 11 east to 604, turn south and the first dirt road goes to the old Hawley place. A man from Florida lives in the house at the top of the road and can tell you how to get to the cemetery. You will have to walk up the hill from his house, or have a 4-wheel drive vehicle. #### POINDEXTER

(The following is the text of an historical tablet of granite erected at the entrance to the old Poindexter cemetery, Franklin County, Virginia, located Route 1 - highway route 655 east of Rocky Mount and Red Wood.)

Buried here is a line of descendants of the ancient Norman gentry named Poingdestre of the Isle of Jersey whose lineage from the present generation of the early 1400's is of verified unbroken record.

"One of those Jersey feudal lords, Thomas Poingdestre, Seigneur of the Fief es Poingdestre, had an adventurous son, George (b 1627), who anglicized the spelling of his surname, making it Poindexter, and emigrated to Virginia, settling initially at Gloucester, 1657; later was co-owner of the land which became Williamsburg; with Nathaniel Bacon was co-owner of the first ships owned by the colonists; was a participant in Bacon's Rebellion; was a vestryman of Bruton Parish Church, 1679; later moved to New Kent County and there built the famous Cross house, "Criss Cross", c. 1690, which still stands, representing a uniquely fascinating example of colonial architecture.

All of the American Poindexters descended from this George Poindexter, among them being leading patriots and soldiers of the American Revolution, public servants such as governors George Poindexter of Mississippi and Joseph Poindexter of Hawaii, Sen. Miles Poindexter of Washington, and many other notable figures in the saga of our country."

Among the grandsons of immigrant George Poindexter was one, Philip Poindexter, b 1708 in New Kent Co. He migrated, c 1750, to Lunenburg County - later partly transformed (including Philip's locale) into the newer county of Mecklenburg. There he became a champion of the Revolutionary cause of the colonists. His name is enshrined as one of the Revolutionary signers of the famour Mecklenburg petition to the Virginia Assembly.

Meantime he had married Sarah Crymes, daughter of Col. George Crymes (later of Revolutionary War fame), from which marriage were born five children, one named John Poindexter. He married Nancy Elizabeth Neal in Lunenburg County, 1792. They then migrated to this place. They and successive generations of their descendants are buried here, comprising the most consecutive generations of the oldest fully documented line of any family buried anywhere in Virginia. 1.1.

Note and comments by the editor: Many errors were made when the clerk copied the marriage returns in the register; also, what appeared to be ditto marks could be dark spots (water shows up as dark or black spots on microfilm) on the paper, please remember that the copy was made from microfilm and parts were very hard to read (impossible in some cases) -- please forgive any errors that we may have made and correct us. We were sent a copy of a previously published Pulaski Co marriages, but could not use them for corrections or comparison as no written permission was sent with them. One of the most important things to remember in genealogy (for me) is to believe nothing in print until you have seen the original and then get several other records to prove that fact - if possible. In 'translating' the marriage record - remember the handwriting. Do we put down what we think we see or as it is written? You put down what it seems to be. Examples: the 'a' is looped at the top or not closed, so it looks like an 'o' or 'u' - you write the latter and, if sure, make a notation that the letter is an 'a'. And you never change the spelling of a word or name in a document. We make no corrections of a document! A footnote serves that purpose.


