

LEGISLATIVE PETITION for GILES COUNTY, VIRGINIA

The citizens of Pearisburg and its vicinity would humbly represent that they are situated some seventy five miles distant from the plaster banks and Salt works in the County of Smyth and that they have been accustomed for the last fiew years to procure from the said works a general supply of salt for the common and ordinary purposes of life. That from the distance and impassable state of the road over which they have to travel to and from the place aforesaid It must be apparent to all that articles so important to the agriculturist and every member and class of society when brought here is furnished at a price far exceeding its intrinsic value The road at this time of the year is in such condition that a good team will with much difficulty draw from the the banks and works about one ton" of either of the aforesaid articles whereas if the road was in good " dition the same team would readily and easily haul twice that quantity. The undersigned would further represent that the time is not far distant when the turnpike from the Red Sulphur Springs in the County of Monroe to Newbern will be in successful operation and that the Cumberland Gap turnpike now under contract will soon be compleated the contiguity of both of which improvements is about forty-five miles distant at the nearest point from the said banks and salt works that an improvement in the road from Capt Shannon's on Walkers Creek to the places aforesaid will be of immense and incalculable advantage to the citizens of the County of Giles as well as those of the Counties of Mercer Green: and and Monroe as they are now accustomed and necessarily compelled to furnish themselves with the articles of Gypsum from the Holstein Banks particu-(ink spots)

larly when it is remembered that a part of the said road is almost in an impassable condition and added to which fact they will soon be subjected to the payment of tolls on that part of the turnpike running by Capt Shannon's the point above designated for the commencement of the aforesaid improvement and that too upon waggons that cannot haul more than half a load over the said road passing from the designated point of aforesaid to the said Banks and works in the County of Smyth both of which facts when taken into consideration must augment rather than lessen to the Consumer in the foregoing counties of Giles, Mercer, Monroe and Greenbrier the price of the said articles of plaster and Salt: The undersigned believe and are satisfied of the fact that when the Cumberland Gap improvement is finished and is under Successful operation that Citizens generally of the County of Botetourt will supply themselves with plaster from the Holstein Banks in the event the improvement asked for shall be granted. The undersigned are satisfied of the fact that of the road from Shannon's to the Salt works and the Plaster Banks was improved and put and kept in good Condition but it would greatly reduce the price of salt and plaster to the Citizens of the County aforesaid and bring them into successful competition with the Liver-pool salt and the Nova Scotia plaster particularly in the latter article as the fact is established that the Holstein plaster is worth \$5 more in the ton than that imported from Nova Scotia. The fact being demonstrable that if the improvement in the road so much desired was effected that the price of the articles of salt and plaster would be greatly reduced

to the Citizens of the Counties aforesaid and it must be conceded that it

would bring into more general use the commodity of Plaster. The undersigned conceive that the Citizens living on the road between John Kirk's (near the forks of Walkers Creek in the County of Giles) & the banks and Works are onerously taxed with labour in keeping the Said road in its present and general repair There would be some incentive to the citizens living upon that road to keep it in good repair or in such order and condition as could be some consistent with justice and convenience of the travelling upon the same would in the end remanerate them for the labour there extended but unfortunately such is not the fact. The road is but little travelled save by plaster and salt waggons and then the drivers and houses are supplied with provisions and provended by their respective owners.

The undersigned wish not to be consider as unworthy the patronage of your honorable body they concieve that they are entitled to the notice the protection and generosity of the Legislature of their native State they concieve and do declare that for their means and facilities they have done more for the improvent of the roads lying within the limits of their County, than any people in the Commonwealth and when their resources are exhausted they hope and believe that the Legislature of this venerable Commonwealth will not refuse to aid and assist them so far as it is consonant with justice policy and the interest of the Community To that end therefore they humbly petition and respectfully solicit your honorable body to pass a law which has for its object the erection of a gate across the said road requiring each waggon laden with plaster or

salt passing through the same to pay a toll of two dollars. That the State appropriate the sum of Ten thousand which together with the tolls arising from the gate to be erected thereon is to be expended in opening the said road after the same is located by the State Engineer all of which is to be laid out by a board of Directors appointed for that purpose and that the hands now allotted to work on said road together with such as reside above John Kirks and between Walkers Mountain and the mountain north of it as far West as the Banks be required to labour in "d of opening the improvement eight days annually or pay its equivolent in money until the said improvement is finished - That the Directors have full power and authority to proceed immediately to the performance of the duties enjoined upon them and that when the said improvement is completed and is successful operation that the gate be discontinued and that the hands living upon and adjacent to the said line of improvement be required to keep the same in repair And in duty bound your petitioners will ever pray &c

CIVIL WAR LETTER from soldier in Bedford County, Virginia

December 17, 1862 Liberty, VA

Dear Mother and brothers

I write you a few lines to let you knowe that I am well at this time and I am in hopes this fewe lines may find you all in joing the same blessing. I will starte to my redgement this evening you may send your leters to the redgement. I want to her from you all soo you must rite to me as soone as you can. I will rite to you as soone as I can. I want you all to live in this world so that when wee come to deep we may all meete in heven. I have not time to rite a nothing more.

Dear Nephew

After Coln Menifee made that country his head quarters for awhile there was not much hostil oposition to the southern cause for some months, & the war spirit was not so high as it was soon after that. Just before Menifee made his first raid to Ky Isaac Fleming the second son of old uncle Jack & Aunt Marry Fleming volenteered in some company I don't remember what company it was, but he was with the command on that raid. A fiew days after their return to this side of the mountain he went over in to Ky to visit some of his relatives on Shelby Was decoyed to a house by some women and shot from a corn field and instantly killed. He was the first of our near neighbors that lost his life in that strife. Just one thing after another seemed to fan the flame of the war spirit, and the country was badly devided. suffered greatly.

I wrote you that Coln Menifee had started his military operations by such theft that he was reported to the war department & had gone to parts unknown to the writer.

Coln James Milton French the oldest son of old Uncle George French and was a young lawyer of some note, and had been verry active aiding in the drilling and traing of the first volunteers, had made many speeches for the southern cause went to the front with about the first volenteers from that county (Wise). I don't know, whether he held any commishion or not when he went to the war. But about the time that Menifee was getting in bad with the war department, Coln French came back to Wise Co & made some speeches against the kind of warfare that Menifee had started. He made one speech at Holly Creek, the people was well pleased with his idea of a state line force that would protect all citizens alike reguardless of their political faith. In the spring of 1863 I think it was French got some companies from Bland Co & some from Wise together I think he was in Camp awhile at Gladeville also on Indian Creek. Had his idea been carried out it would have been a good thing for that section. But he made the great mistake of mooving his little command to Pikeville Ky and trying to make his headquarters there. He soon prooved that he was a better taulker then he was a military stratigist. He had not been in Camp but a short time untill the Federal forces come up the river surrounded the town captured him and the most of his men. However he had formed quite a friendship with old Coln Dilts of Piketon, while he was there. I heard of Dilt's saying that Coln French was all the honest rebel that ever lived. It was also said that it was through the enfluence of Dilts that he and his men ware exchanged much sooner than they would have been. When he & his men ware exchanged his men that was from Bland never came back to the state line service, but joined the eastern army and he made some record as an officer in the war.

After the war was over Milt made a verry prominent lawyer and was elected to the state sennet from Giles & Bland Counties. Was in the sennet when your uncle Jerry was there at the time of the crash at the capital. Your Pa was still at home from the effect of his wound when French had the command of the state line service. When he went back to Camp I think Coln Printis was in command & was the Commander of that the 7th battalion tell the close of the war. Some time in the last part of 62 I think it was George D. French a younger brother of Milt French made up a company and was mustered into service in the 7th battalion. That batalion was in camp first one place & then another while a kind of gerilah warfare was going on most all the time. I don't think they ever had a regular camp any nearer Holly Creek than the mouth of Indian, there ware scouting parties all over the country, there was but little neutral ground on which to stand. Some men had gone into the brush for protection. About that time there was what was called a union home gard formed. I don't think they had any connection with the federal army or war department, but their main object seemed to be to keep rebels out of that country or kill them outright so times commenced getting worse & worse.

Some time in the latter part of the summer of 63 or fall of that year Capt George D. French & a fiew men went down to see his father's folks gether up some of his men that was out without leaf, Lieutenant John Fleming was in command of some of the men that belonged to your Pa's Company in the squad seemed to be devided a bunch of them was fired on over on the south of the mountain and Wilie Mullins was killed. He was a brother of old aunt Bettie and Aunt Lizie Mullins. Either that same day or the next day as the bunch of men under the command of French and Fleming was fired on as they ware crossing the big ridge

and Marshel Keel was killed. he was a son in law of old Uncle Jack Fleming. The Confederate soldiers then left there as it was unsafe for them to travel any whare for the woods seemed full of union bush-whackers. Some later that same fall Major Chiniworth with his men went into camp at the Jack Mullins place on the Crane'snest. I don't know what kind of a march they were on, or whare they had come from, But as soon as it was known that a rebel force was camped there the union home gard got their forces together to give them a battle. They, the home gards, met on Longs fork about the old Protestant church late in the evening before they fired on the camp next morning at day light. They stayed there tell just before day. Eddie French was down the creek that evening and they held him as a prisenor until they started on their march next morning. I don't know the straight of either side in that, the only real battle that was fought in that section during the war. The union force had all the advantage of his ground they fired into the camp just as the rebel force was getting up without even a picket fire. The first volley they fired one reble soldir was killed. As soon as the rebel soldiers got their arm, with their military training they charged right up the ridge under the fire of the union force firing as they went and killed a number of them before they reached the top of the ridge. Bob Killin Charles Hibbtts and little Revel Bartley are all the names that I remember now of the men that was killed in that fight. That was the last real resistant that was made by them. The most of the men that escaped went over to Ky and some of them joined the Federal army. some fiew scouted around in the country for awhile. Uncle Wm Neel and James A. Kilgore was captured along about that time and taken to Camp Chase, Uncle Wm got back home in a fiew month but Jim Kilgore did not come back tell after the war. At new year 64 your Pa and George French brought their companies down to that section to moove their families out. The country was so unsafe at that You no doubt have heard your parents say that they went to Guest river & stayed tell after the war was over. Old uncle George French mooved to Russle Co & never went back there any more.

About that time nearly everry boddie was mooving one way or the other. The union people crossed the mountain to Ky the southern people got farther away from the state line, so but verry fiew people ware left in that whole section of Wise Co, and what was left had verry little to live on. But one fortunate thing for what was left, there was verry fiew soldiers of either side passing that way. So there was not the strife during that year that there had been during 62 and 63. I don't remember of any

one that was killed during the year of 64 in that section. Early in 65 there was a camp of men went in to hiding about the head of Caney or some where up there. I don't know whether they had much preference for either side or not. But they seemed to want to live on what they could get from the citizens, that had nothing to spare. For several months they stayed there. The report was that there was some six or eight of them, well armed. So when they had stayed there for some time, they, ware surrounded and fired on by some parties and the whole camp was killed I never heard just who it was, that killed them. No one that might have known would say much about it. So that was the last blud that was shed during the war in that section that I heard of. In the spring of 1865 nine years after my young eyes had first beheld the beautiful little vallie of Holly creek I looked on it in a verry different way, it then showed the effects of the war houses ware standing vacant fences ware down brush & bryers had overgrown the fields, and even the woods that was so clear of brush only nine year before was then so thickly grown up with brush that you could hardly get along the pathes. So many people had left their homes & what had remained had lost the most of their live stock. the most of the farmers that stayed had to tend their farms with oxen but fiew horses in the country when the war closed. I dont think that that country got over the effects of the war in fifteen or twenty years.

The war strife was still pretty high for some years after it closed. In my next sheets I will write you some things about the reconstruction day so I will close now I cant go over to see you all when Ann and Minie goes home but I meant to go just as soon as I can.

p7: The Commonwealth v Preeson Richards: The prisoner was indicted for burglary & larceny, in the District Court, held at Accommack ct-house, in Oct 1789 was found guilty.the offence to have been committed in the county of Northampton, at the parish of Hungars."

p7: Denny Fairfax v Robert Stephen. The Same v David Hunter: ...Dist Ct of Winchester, in Apr 1790Copies of Caveats from the Land Office, certified by a clerk of the office, and not by the Register, void.

p7-8: The Com'lth v John Proctor: Forgery of Power of Attorney. The prisoner as indicted in Apr 1791, in the Dist Ct of Richmond, for having & falsely made,power of attorney... for William Cosby. "I, William Cosby of the co of Chesterfieldappoint William Nichols of Dinwiddie Co money due me for service in the Cavalry in the Continental army ... 11 Dec 1790, (signed) Wm Cosby". Court ... that the verdict ought to be arrested & the said indictment quashed."

p8: The Com'lth v Hugh Dowdall: .. indicted at the Dumfries Dist Ct, in Oct 1791. for passing in payment a counterfeit dollar...

p9: The Com'lth v John Whealand: ... indicted in May 1789 at the Dist Ct of Dumfries for ... counterfeiting sundry pieces of base coin

p9-10: The Com'lth v John Crane, the Younger: Winchester Dist Ct, Sept 1791.

"John Crane, the prisoner at the bar, was informed by his reapers, that one
Campbell's reapers had sent a challenge to his. That in consequence of this
supposed "challenge", the said John Crane went with others out of his own field
into the field of the said Campbell, which was adjoining to that of Crane's, and
that the said Crane did make use of threatening language, such as he could whip
any man in the field, meaning Campbell's reapers, amongst which was Abraham Vanhorn; but after some altercation we find all parties appear to be reconciled; but
before said Crane left the field, another dispute arose, in which Crane challenged
them to fight, man for man, which Campbell's party agreed to do, of which number
the said Abraham Vanhorn was one: when the parties came near together, they parlied and disputed for sometime, the issue of which was, that the prisoner at the
bar swore that if he fought any man that day, he would let out their guts, and
likewise that he would fight Joseph Vanhorn the next morning, for ten dollars,
which the said Abraham Vanhorn was to bet him. The prisoner at the bar leaving

Campbell's field, after some time a certain John Dawkins, one of Crane's reapers, suspected some insult given by Campbell's party and going to fight any one that would insult him. The prisoner at the bar observed this, requested the said Dawkins to get him a club and he would take his knife, which knife he took out his pocket, declaring they could clear their way through the whole of Campbell's party, upon which the said Dawkins desisted from prosecuting his intentions, and likewise the prisoner at the bar. We find that between sunset and dark, that the said Abraham Vanhorn with several others passing through the field of John Crane, the prisoner at the bar, to confirm a bet which was to ensue the next morning and also making a noise and singing which the said Dawkins conceived was an insult insult to the prisoner at the bar and his party. There upon Dawkins called out that he could whip Joseph Vanhorn. Joseph Vanhorn replied it would be no credit to him if he did, as he was a larger man; upon which the prisoner at the bar came out, and ordered them out of his field, or he would blow them through upon which they immediately quitted the field; he then called for his gun, which was refused by his wife; he then called for his knife & pursued them to the fence, exclaiming Abraham Vanhorn, you have used me ill, and I'll be damn'd if I don't have satisfaction. Then the said Abraham Vanhorn replied, not more so than you have used me. The prisoner then requested the said Abraham Vanhorn to come over the fence and fight him; the said Abraham Vanhorn made answer, that he the said prisoner at the bar would use a knife or razor; the said prisoner at the bar replied, come over the fence, and I will give a fair fight: the wife of the said prisoner at the bar came down crying out, Mr Crane I am surprised you should de mean yourself to fight with such a set of negrofied puppies. By this time the prisoner at the bar, & the said Abraham Vanhorn, were much irritated, at which the said Abraham Vanhorn, and Isaac Merchant one of Campbell's reapers, had their shirts stripped off, which the prisoner at the bar had not; the prisoner at the bar and the said Abraham Vanhorn attempting to get at each other across the fence, who was prevented by John Dawkins. Then the said prisoner struck at Merchant, who struck the said prisoner at the bar, and turned him around, who immediately joined in combat with the said Abraham Vanhorn We find in the combat that the said Abraham Vanhorn threw the prisoner at the bar on the ground, and kept him there for some time; at length the prisoner at the bar seemed to get the advantage of the said Abraham Vanhorn, at which time the said Abraham Vanhorn cried enough and said his guts were cut out. We do find that the said Abraham Vanhorn did receive several wounds with a knife or some sharp instrument of which wounds the said Abraham Vanhorn died, and that the wounds were given by the prisoner at the bar." The jury asks for a special verdict - is he guilty of murder or manslaughter? The court - he is quilty of murder.

plo: The Com'lth v William Williams: "We of the jury do find that Wm Williams did steal ... the negro slave Solomon,... on 25 Oct 1791 out of the possession of Thomas Edwards, to whom the said slave was hired for 1 yr by Elizabeth Edwards..."that judgment ...ought to be given for the defendant.

p32-33: The Com'lth v Stephen Stewart & Ephraim Potter: .indicted at the Dist Ct of Prince Edward, in Sep 1795, for stealing a horse of the price of 20 lbs... the goods & chattels of John Standfield; the time laid is the 27 Sep 1793 & the place, Halifax Co, ...the prisoners pleaded & tried separtely, ...& each found guilty.on being asked why sentence of death should not be pronounced agst them, they severally prayed the benefit of the clergy ...14 Nov 1795 the court decided "that the defts are entitled to the benefit of clergy ...; that the sd dist ct to proceed .. & that no new indictment ..be preferred against them. (At this period of time, benefit of clergy was very seldom used except in specific instances. If a person could read and write (earlier times it meant the person was going to enter a religious order), that person would be released from any punishment. The benefit of clergy could be used only once. Also earlier, the prisoner would be burnt on the hand.)

p33: The Comm'th v Robert Mitchell: the jury gives 'special verdict' murder or manslaughter only....the prisoner indicted at the Winchester Dist Ct, Apr 1796 Robert Mitchell .. in a state of intoxication arrived home beating his wife ... Frederick Becktoll, who was boarding with them, interposed to part them a fight between them Mitchell got a gunBecktoll left the house .. returned ... fighting between them & Becktoll was shot...Mitchell's son told to place the gun beside Becktoll's body so it would look like he shot himself.... The court decides Mitchell not guilty of murder.

p34: The Com'lth v Edward M'Guire & James Tidball: An indictment was found by the grand jury of the Dist Ct of Winchester in Oct 1796, agst 5 persons, of whom the defts were part. James Heydon (supportin himself...by gaming only) with being on 30 July 1796, at Winchester the keeper of an unlawful gaming table called faro ..in the tavern of James Edmondson in Winchester charged Edward M'Guire, the deft, Samuel Vowel & J Tidball the deft with playing the gameeach pleaded not guilty The court - "the indictment agst the the defts is good

p34: The Com'lth v David Hays: .indicted at Dumfries Dist Ct in Oct 1798 for larcery of a slave. a negro slave Tom owned by John Hunter. said slave was a runaway ... The court said "the law is for the deft".

pl27: The Com'lth v Benjamin Vawter: Co Ct of Caroline for retailing spiritous liquors with license ...\$30 fine ...Court - cannot appeal.

"The Petition of Sundry Inhabitants resideing in the Counties of washington. wythe and Grayson humbly Represents that they are dsireous of having a new County Established from the three aforesaid Counties agreeably to the following boundaries. 'Begining in Grayson County on the dividing line between Virginia and North Carolina where the State line Crosses to the Elk Creek thence a Direct line to the dry Run gap on the top of the iron mountain thence North twenty five Degrees west to the top of Walkers mountain in Wythe thence westardly along the top of S'd mountain to the indians Graves where the Road Cross S'd mountain from Saltvill to the main Road in washington from thence a Direct Cours to the highest Point of the white top mountain in GraySon County Continueing in a Straight line to the State Line of North Carolina and thence on Eastwardly Cours along the s'd State line to the begining'

"which said line metes and bounds will Contain about 1500 Square miles. "your Petitioners would Represent as grieveances that the citizens of grayson have nearly forty miles to travel to there Court hous over a veryRugged Road, and have to Cross new River on hors Back there being no ferry for there accommodation and are frequently Prevented from attending the Courts on account of high water, and that the Citizens of washington and wythe have upwards of thirty miles to travel to there Respective Court houses -- the Prayers of your Petitioners is that a new County may be Established out of the three aforeSaid Counties which the belive will not be a very great injury to Either of the S'd Counties and a very Esential Benefit to your Petitioners

and as in Duty Bound will Ever Pray"

Dear Mr. Weddle,

Having received your letter of July 12th, I must correct your impression taht I am omiscient in Dossenheim. I am working about the population of Handschuhsheim, the neighbour village, so some Informations about the Dossenheimers are at hand. The situation at the beginning of the beginning of the 18th century were pretty bad for the population here. In 1689 a French army had burned down and destroyed most of the Towns and villages in the Palatinate and so also Handschuhsheim and Dossenheim, all earlier records in the places were distoyed. Several times after 1700 the inhabitants were plundered by foreign soldiers. So the Intentions for emigration were numerous, but the gouvernment did not incourage them, as they wanted to repopulate their burned out country. Especially well to do families were retained, beggers, and other unwanted people rather encouraged to emigrate, there are even notes, that the community chest paid the passage for unwanted inhabitants.

Now the Wedels:

In the book "Kurpfälzische Auswanderer von unteren Neckar" Werner Hacker list quite a number of Dossenheimer Wedels:

- 22.3.1726, Michael WEDEl, citisan, requests emigration to the "Island of Pinssfania", request was denied, the Schultheiss ordered to take care that he remained in Dossenheim.
- 6.5.1726 John Michael the younger, without means, is granted the same request.
- 1759 John Michael WEDEL, born 1697, married to Maria ROSCHER emigrates to Jütland (Denmark) with 3 children.
- 12.4.1752 Anna Maria WEDEL, a widow, emigrates to the "New Country". (second note: "to Carolina, with a child")
- 9.5.1752 Georg WEDEL, born 1691, went to Carolina with his wife, Bar-bara SCHLEPP and 2 children.
- 7.5.1764 Johann Peter WEDEL, mariied to Sybille HEER went to Mary's Land in America.
- 1764 Georg Albracht WEDEL , born 1711, went to America with his wife Eva Catharina.
- 13.2.1764 Peter WEDEL requests emigration to Pennsylvania, where his brother and other near relations are already living, with his wife and 5 children. Request granted, arrived in Philadelphia 27.10.1764.

So you see that in 1726 at least two Michael WEDELS were in Dossenheim, both wanting to emigrate. Supposing the elder stayed on and emigrated later to Denmark, the younger, the poor one, might be your ancestor. Your notes about his son Martin do not find a correspondence here, the name of Beckelheimer or the like does not appear in the books here.

The neighbouring villages of Dossenheim and Handschuhsheim were under the same parson in the beginning of the 18th century, so I find in the H'heim Register the Confirmation of two Michael WEDELs, one at Easter 1696, one at Easter 1698, as the age at the confirmation was about 15 years at that time, they might be born at 1681 resp. 1593.

Regrettably the names of the parents are given in neither case.

In the "Land sales register" (Gerichtsbuch) of Handschuhsheim I find that Hans Michael WEDEL bougt a vineyard in Dossenheim togesther with his sister Margarethe WEDEL on Aug. 1st, 1718. (That probably was the richer one!)

So I cannot give you any proof that your Martin WEDEL or his Father Michael came from Dossenheim, nor certified dates about their parentage. In Handschuhsheim the name of WEDEL is found as early as 1516, but without the possibility to find family lines.

At present my time ist limited by my Handschuhsheim studies, so I cannot look into your Dossenheim people. A friend of mine, living in Dossenheim and doing some research there might find something more, I shall relay your request to him. Could you find anny dates of Michael Wedel that could specify his time of birth or emigration?
