

Dear fellow genealogists:



p264-7. **Francis Lindsay v The Com'oth:** Superior Ct of Law, Pittsylvania Co .....petitioner was sentenced to the Penitentiary for 7 yrs for stealing a gelding, of a sorrel colour, the property of **Charles Kesee**. ..charged 14 Feb 1823

p267 **Thomas M Randolph, Gov &c v Isom L Brown, James Roach & William M'Bee** Adjourned case from Superior Ct of Law for Morgan Co. ... The defts were put under a peace bond ...particularly towards **Samuel Jackson** ..

p 267-268. **Brookes Baker v The Com'lth:** Superior Ct of Prince Edward Co... Adjourned case. Petitioner indicted for assault and battery on **Nancy Davis**

p 268. **Hill Carter v The Com'lth:** Superior Ct of Law for Charles City Co. Ferries - failure to keep up. He did wholly discontinue the said ferry..... Court: judgment reversed.

p268-70. **William Rasnick v The Com'lth:** Forgery and counterfeiting. Superior Ct of Law for Russell Co. The prisoner and 2 others [**William Ervin** and **Rachel Rasnick**] were jointly indicted ...

November Term, 1823

p 275-276. The Com'lth v **Robert T Sims:** Superior Ct of Culpeper. Deft was indicated for an assault on **James Y Horner**. .. The deft was described in the indictment as a "labourer". The deft pleaded in abatement that he was yeoman and not labourer. Court: The difference between yeoman and labourer is sufficient to abate the indictment.

p 276-78. **Hudson Sprouce v The Com'lth:** Indictment murder. Superior Ct for Albemarle Co. Oct term, 1823. ...**Sprouce**, labourer ... **John Terrell**, one of the venire-men, heard the evidence of **Patsy Woods**, .... principal witness of the prosecution ..... prisoner was a stranger to him and lived at least 13 miles from him. .. juror **Abraham Wiant** .... Court: new trial.

p 278-279. **Francis Derieux v The Com'lth:** Superior Ct of Greenbrier Co... Indictment felonious stabbing, with intent to kill. ... given 1 year. .... assault on **Samuel M'Clung**, a deputy sheriff ... court held 19 July 1823 ...

p279. **William Richards v Thomas Goodson:** Superior Ct of Montgomery Co..... **Goodson** obtained judgment agst **Richards** for debt .... **Richards** took the oath of an insolvent debtor .....

p 279-280. **Nathan Attoo v The Com'lth:** Superior Ct of Augusta Co. The deft was indicted as a free man of colour, of the forgery of a paper ..... of one **Jacob Coiner**. ... offence was committed 10 May 1823 .. Court: writ of error accepted - the prisoner acquitted and discharged.

p 280-281. The Com'lth v **John Shelton**: Superior Ct of Brooke Co. Sep 1923, the prisoner, a free white man, was indicted for grand larceny, committed before 1 Aug 1823, and convicted.

## June Term, 1824

p 281-83. **Reuben Wicks** v The Com'lth: Superior Ct of Nottoway Co. Murder. The prisoner was convicted and sentenced to death for the murder of one **George Hood**. The dec'd had charged the prisoner with stealing some iron from the shop of the dec'd. .... The prisoner threaten to kill him ..... The next evening, he appeared in custody at colonel **Jeter's** tavern ..... The day after his examination took place, the prisoner was committed for larceny, but bailed. The dec'd left for his home on foot. The prisoner was seen at the tavern the same night. The next morning, **Hood's** body was found ... he was a blacksmith .....

p283-84. The Com'lth v **Richard Booth**: Superior Ct of Petersburg. Indicted 10 May 1821 with assault on negro slave, **Bob**, the property of **Robert Fenn**.

p 284-285. **David Mabry** v The Com'lth: Superior Ct of Law of Greenville Co. The prisoner, a free man of color, indicted for stealing property belonging to **Nathaniel Land** ....

p 287-8. The Com'lth v **William Daniels**: Adjourned case from Superior Ct of Lewis Co. Indicted for the disturbance of a religious meeting. **Wm Daniels** yeoman on 6 Oct 1822 .. at a place commonly called Flat Woods .. did on purpose ....disturb a congregation of Methodists ...

p 289-305. The Com'lth v **John Dandridge**: Contempt. Superior Ct of Law, James City Co, city of Williamsburg, on 25 Sep 1823 ..... **Jesse Cole**, **Richard Coke**, and **Richard Booker** ..... **James Semple**. Judge Superior Ct of Law for James City Co.

p 305-310. **John Aldridge** v The Com'lth: Superior Ct of Law for Henrico Co. The petitioner, a free man of color, indicted for larceny of Bank-notes .... 21 Dec 1823 ..

## June term, 1825

p 311-2. The Com'lth v **John Callaghan** and **John Holloway**: Adjourned case of the Superior Ct of Law, Alleghany Co. ....Justices of peace - Sale of office **Oliver Callaghan** to be clerk of said court ...

p 313. The Com'lth v **John Bryant**, alias **John Hopkins**: Superior Ct of Law for Henrico Co. The prisoner, now a convict in the penitentiary, was convicted in Apr 1824, by the Superior Ct of Law for Rockbridge Co., of horse-stealing and given 5 yrs ... having escaped committed other crimes ..... convicted Oct, 1824 before the Superior Ct of Law for Nelson Co .. the prisoner was charged before the Superior Ct of Law for Henrico co.

p 313-15. The Com'lth v **George Ryan**: escaped from prison 17 Sep 1824, captured 10 Dec 1824.....

p315-6. **Francis Wells**, qui tam, &c v **James Garland**: Superior Ct of Law for Henry Co. **James Garland**, an attorney ..... the deft as attorney for **Isham Petty**, had brought suit agst **Thomas Wells**, .... **Garland** secured payment by a deed of trust on his land to **Rice Garland**, as trustee .....

p317-8. The Com'lth v **John Linton**: Bail bond - forgery for altering a bail bond. Superior Ct of Law for Russell Co. ".....that we **John Sergeant**, **William Bays**, **Charles Cleghorn**, **Jon. H Wood** ..... are firmly bound to **Henry Wood**, High Sheriff of Scott Co ...15 Mar 1823 .....**Jonathan Wood**, deputy sheriff of Henry Co .....

p 319-20. **Massey Thomas** v The Com'lth: Superior Ct of Law for Westmoreland Co .....Writ of error .... deft's attorney argued " that formerly the practice was, after the jury was entrusted with the Cause, to keep them together without fire or candle, or meat or drink, until they had agreed: ...

p 320-23. **Joseph Burgess** v The Com'lth: Writ of error. Superior Ct of Law for Prince William Co, the petitioner was sentenced to be hanged for murder of **Charles Gollyhorn** ...1824... The deft and dec'd were seen together on the streets of Dumfries ..... deft walked out of town to a house ca 2 miles distant where he was domesticated ...both men were labourers ...

June Term, 1826

p 323-4. **Joseph Byrd** v The Com'lth: Writ of error. Superior Ct of Law for Surry Co. ..indicted for burglary and larceny ..... the testimony of **John Suter**, an accomplice

p 324-26. **Michael Quinling** v The Com'lth: Insolvent Debtor's Oaths Superior Ct of Law of Kanawha Co Adjourned case Indicted and convicted in Aug 1821 for two several assults and was amerced in the cases \$55. ....In Feb 1825, the Com'lth attorney that since **Quinling** took the insolvent oath "he hath acquired lands and tenements, which he now owns"..... Court: The court cannot recover since **Quinling** had been discharge of all debts .

p327 The Com'lth v The Justices of Kanawha Co: To compel Justices to build bridge. ... to contract for rebuilding or repairing of the bridge across the ravine, near and above the House of **Nelson Priddy**, on the north-east side of the Great Kanawha, where the public road leading through said county, crosses the same.

p 327-329. The Com'lth v **John J Jackson**: Assault and Battery - Fraudulent prosecution: Superior Ct of Law for Wood Co. ...on 29 Sep 1824 the deft was indicted for an assault and battery, committed 28 Apr 1824 on **Christian Schultz jun.** ..... **James Henderson** prefer an indictment agst him for the same offence .....

p342-4. The Com'lth v **Samuel Murray, Jun**: Adjourned case from the Superior Ct of Hanover Co. Deft was indicted for the larceny of a calf, property of **William Pollard** ..... 25 May 1825 examination of deft .....value of calf, \$6

p 344-46. **Thomas Kennedy** v The Com'lth: Writ of error. Superior Ct of Law for Rockingham Co. Indicted and convicted for rape. ...**John Embry**, a jurymen, was committed in his opinion before the trial. **James Gray**, one of the jury, spoke to **Robert Mooney**, his relation, ..... **Archibald Rutherford**, another juror, ... affidavit of **Richard Robinson** .... Denied.

p 346. The Com'lth v **George Adkinson**: Gaming. Superior Ct of Henrico Co. .... by playing at "Faro in a house on the east side of twelfth street, and in the rear of James Heron's store, a place of public resort in the city of Richmond .....on the information of **Samuel B Harwood**, .....the deft said he was baptised by the name of **George Walden Atkinson** ...

p347. **James H Walker** v The Com'lth: Writ of error - what is a public place ..Superior Ct of Greenville ... Deft had played at whist, and probably other games, in an old house located on the public square attached to the Court house of Greenville co, which was originally built for a jail .....it has remained with the door open .... deft had betted nor exceeding half a dollar

p347-9. **David E Brown** v The Com'lth: Challenge to fight duel. Superior Ct of Loudoun Co. deft sent a challenge to Doctor **John Rust** ... on 21 Mar 1822

p 351-362. The Com'lth v **Benjamin Cawood**: Adjourned to the General Ct, by the Superior Ct of Law for Wythe Co, on 15 Oct 1824. .... venue changed from Washington Co Superior Ct - on 26 Apr 1824, **David Campbell**, foreman ..... of Grand Jury .... presentments ... agst **John Walker** for larceny .....**Mary Davenport** for larceny .....**Nancy Davenport** for larceny ..... **George Winniford** for not having a road in repair .... jury adjourned til next day ..... **Benjamin Bowman** for perjury ..... **Abraham Snodgrass** and **Joseph Snodgrass** for obstructing the process of the Law .....**Moses Whitaker** for an assault ..... **Benjamin Grier** for an assault .... **Samuel Caldwell** and **Thomas Caldwell** for larceny .....And having nothing further to present they are discharged. .... on 1 May 1824 (3 May)... to secure a jury for the trial of **Benjamin Cawood** (husbandman), **David Prator** (labourer), and **Polly Prator** (spinster), accused of murder ..... for the murder of **Mary Cawood**, the wife of the said **Benjamin Cawood** .....

p362-387. **Elizabeth Selden**, Widow, **Cary Selden** and **James Selden**, Two of the Sons of **Miles Selden**, the Elder, Dec'd, v **John Coalter**, **John Adams**, and **Samuel G Adams**, Ex'rs of **Richard Adams**, Dec'd. ....petition of the pltf's, were devisees of **Miles Selden**, sen of Tree-hill, Henrico Co. . Testamentary paper given to son **Joseph Selden** the farm called Mill-Farm and slaves **Tenah**, **Moll** and child, **Jude**, **Lewis**, **Morriss** and **Nelson**, **Taff**, [(b)Ned) and their brother **Sam**, [(b)Billy, Little Sam, and Old Sam] also Old Sam; son **William Selden** my Fairfield farm, slaves **Patty** and her 4 children, **Sally** and her 4 children,

[(c) Isham, Daniel and John sons of Nelly] [George, Edmun, Tom] (sons of Milly); to son James Selden Tree-hill farm, land called Duval's, slaves [(d) Old] Betty, Flora, Grace, Louisa Betty, Emanuel, David, Tom, Miller(children of the 1st named Betty) [(d) Ned] and Charles and Claiborn .....his brother Cary Selden; son Cary Selden -slaves George, Edmund and Tom (sons of Milly), Nathan and his wife Jenny; given to son Miles Selden before his marriage" -- page stopped and no date .... A schedule of property to the payment of debts .... Benjamin W Leigh .. both papers in the handwriting of Miles Selden sen .....William Mayo, William H Macon, and Harry Heth believes the papers to be in the handwriting of M Selden sen. .... A will dated 10 May 1800 names his son Miles, his wife, daughter Patsy, sons Armistead, Cary, Joseph, William and James ..... appoints his brother Joseph and his wife gdns of his children, .... his brothers Joseph and Nathaniel, and his son Miles jun, his ex'rs. This will proved in General Ct after the death of the testator, on the 13 June 1811..... Miles Selden jun alone qualified as ex'r - Joseph the brother being dead, and Nathaniel refusing. ... Miles sen had purchased land called Fairfield from William Savage dated 21 Apr 1800 for his son Miles ... May 1802 purchased Woods-Farm from David M Randolph and exchanged it with his son Miles for Fair-field estate. ...In yr 1806 Joseph Selden the brother died and devised to Miles slaves ..... Armistead Selden the son died in 1801 without issue. Patsy Selden, the daughter, married William H Roane in 1809, and died without issue in 1810. Wm H Roane deposed ...conversation with Col Selden Apr 1811, a few weeks before his death ....James youngest son ..... The family of Col Selden removed from Tree-Hill in 1814.....Austin Talman deposed ..land he had purchased of John Turpin .....William Mayo deposes .. during the last illness 30 Apr and 18 May 1811, when he died ..... Mr Fulton purchased slave from Jun,. Witness Susanna Hawes ....That Miles jun lived in Prince George, and Nathaniel, the brother, in Henrico. Miles jun had 6 children when his father died ... deed of trust by sen to David Bullock and Thomas Norvell dated 6 Feb 1811 for debt due Frederick Harris ..... Jesse Fraser deposed .... Joseph Bailey .... George Kezee ... William Randolph ..... that William Selden qualified as ex'r of Miles Selden jun in the yr 1814.....

## ABRAHAM &amp; ELIZABETH NAFF BARNHART

Abraham was the third son and third child of Daniel and Elizabeth Naff Barnhart. Both his mother and wife were named Elizabeth Naff. His birth date is given as 16 Oct 1795, in "Barnhart Family Record" by Josephus Barnhart. (1) The same book gives his date of death as 12 May, 1872. Census records and the date his estate was inventoried after his death would appear to validate this date. I have found no official records of either his birth or death.

In the "Barnhart Family Record" Elizabeth Naff was born 17 March 1798 and died 23 May 1882. (2) This books says her parents were Jacob and Elizabeth Naff. John Boitnott in "Naff and Related Families" (3) Agrees that she was born in 1798, but indicates that her parents were Isaac and Barbara Naff. The birth dates coincide and are in agreement with the age given in later census records. It is interesting to note that both Jacob and Isaac are brothers, and children of Jacob and Eva Naff, Their sister is the mother of Abraham. This makes Abraham and Elizabeth first cousins. This was not an unusual occurrence at that time. I would believe that due to the sparse population the pool of available spouses was limited. They also were members of the Brethern Church, who members tended to marry within that church.

Their marriage took place in Franklin County Virginia on 21 October 1818. (4) The name of the minister is not shown. George Knave was listed as surrogate. They were the parents of nine children. Daniel born 8 Feb. 1819, Hannah born 12 August 1821, Jacob born 25 Sept. 1823, Rebecca born 1827, John born 13 Feb. 1829, Abraham born 11 Nov. 1831, Elizabeth born 26 Sept. 1834, George born 8 Aug. 1837 and an unnamed son who died as an infant. There are several sources for the birth dates of the children. They are shown in both "Naff and Related Families" and "Barnhart Family Record" and there is general agreement. These children are also listed by name in Abraham's will and in the settlement of the estates of both Abraham and Elizabeth. All the children were born in Franklin County.

Abraham and Elizabeth, and their children were members of the Brethern Church. Abraham was an Elder in the church. (5) It is interesting to note that four of Abraham's sons also served as Elders in the church. Abraham's brother Daniel was also an Elder in the church.

Census records have been found for the years 1820 through 1870 in Franklin County, Virginia. Prior to 1850 the census listed only the head of household by name, other members of the family were listed by sex in certain age groups. In 1820 (6), 1830 (7), and 1840 (8) Abraham was listed as head of household in Franklin Co. Va.. No township was listed for these years. In the 1850 census (9) Abraham

was counted with Elizabeth and three children Abraham, Elizabeth and George. His occupation was listed as farmer, no township was listed. The 1860 census (10) has Abraham and Elizabeth in the Googinsville P.O. district of Franklin Co.. His occupation is given as "Dunkard Clergyman". He had real estate valued at \$1,700 and personal property of \$250.00. His last census record, 1870 (11), has him enumerated in Bonbrook Township of Franklin Co. living with Elizabeth. His occupation was farmer and real estate value was \$1,500.

When Abraham's father died he owned three parcels of land. Among them was a parcel of 208 acres he had purchased from James Calloway for 100 pounds CVM (current money of Virginia). On 1 Feb. 1813 Abraham's brothers John and Daniel sold their interest in this property to Joseph Flora for 100 pounds. At that time Abraham and his sister Susannah were still minors. On 5 May 1817 he and his sister sold their remaining interest to the same Joseph Flora for 100 pounds. (12) As the deed makes no mention of this sum being paid to each, I assume it was divided between them.

On 6 April 1819 Abraham bought 140 acres from his brother John for \$500.00.(13) That is the equivalent of about \$5,325.00 in today's dollars according to "How Much is that in Real Money" by McCusker.(14) The 50 pounds he received as his share from the sale of his father's property would have equaled about \$2,500.00 in today's money.(15) The fact that a man in his early twenties had that much money would seem to indicate that his inheritance was substantial.

George Nafe, on 13 June, 1840, sold 18 acres to Abraham for \$18.00. This amounts to \$4.50 per acre.(16) There are two deeds involving Abraham written on 3 June, 1861. He sold 2 1/4 acres to his nephew, John Barnhart, for \$20.00.(17) and John sold him 2 1/2 acres for \$30.00.(18) Both of these parcels are along Gill's Creek.

I could find no other record of land owned by Abraham, however I believe he owned other properties. In a deed dated 31 Aug., 1912 his son, Abraham Jr., sold 205 acres to his son George, for \$500.00.(20) There is no metes and bounds description of the property, only the names of the adjoining property owners. The land is further described as "being the same lands formerly owned by Abraham Barnhart Sr. and willed by him to Abraham Barnhart." Daniel, the father of Abraham Sr., owned 508 acres in Franklin County at the time of his death. I can find records of only 308 acres being transferred. Could this 205 acres been part of Daniel's estate, and thus been acquired by Abraham Sr? This is only speculation as I have no evidence.

Abraham died 12 May, 1872, near Wirtz in Franklin County, where he had lived his whole life. I have no record of his death or burial. I would believe that he is buried in

the cemetery of the Germantown Brick Church of the Brethern, the church that he had served as an Elder. I have found no stone marking his grave, but there are some older graves with missing stones, and some illegible ones. His wife, Elizabeth, died 23 May 1882. Again, I would believe that she is buried next to him, but have no documentation.

Abraham made a will dated 3 July, 1869 and admitted to record 2 June, 1873. The will named his wife Elizabeth, his seven surviving children, and the two children of his daughter Elizabeth who had died in 1859, as heirs. His son Abraham Jr. was named as executor.(19) The will provided that after the death of his wife, the property was to be divided equally. Abraham Jr. was to "have possession of all my land at the price of \$3.50 per acre." His wife was to take such household and kitchen furnishings as she may deem necessary.

An appraisal of the personal property of Abraham showed a total of \$299.32.(21) This included \$79.05 of personal property, \$178.12 in bonds and notes and \$42.15 worth of property his widow kept. At a sale held 15 Aug., 1873 a settlement of the personal estate was filed and recorded showing a total sale of \$184.25, which was distributed to the heirs.(22)

The sale of the personal property of Elizabeth, widow of Abraham, after her death netted \$31.28.(23)

A paper filed with the Franklin Co. Court and recorded 3 June, 1844 shows a disbursement of \$11.18 to each of the distributees.(24) Another paper filed with the Court 7 March, 1888 shows the same disbursement as the previous document, and a balance of the estate of \$6.72.(25)

None of these papers concerning the disbursement of the estate make any mention of the \$3.50 per acre that Abraham Jr. was to have to have paid the estate for his father's lands. I have not found any record of this disbursement, but I will search for it the next time I am in Franklin County.

## WILL OF JOSEPH HAYNES

Fincastle, Botetourt County, Virginia

Will Book C, pp. 6-10

I, Joseph Haynes of Botetourt County and State of Virginia do hereby make and ordain this my last will and testament in manner and form following that is to say

1st I desire that all the perishable part of my estate not hereafter bequeathed be sold immediately after my decease and out of the moneys arising therefrom my just debts and funeral expences be paid and should the perishable part of my property prove insufficient for the above purposes then I desire that my outstanding debts be collected and applied to the purpose aforesaid.

2nd After the payment of my just debts and funeral expences I give to my beloved wife Jennet Haynes the whole of my plantation whereon I now live with all the land adjoining thereto on both sides of Jacksons River during the term of her natural life together with the use and labour of the following slaves to wit: one negro man Ben, one other negro man named Daniel, one other negro woman named Jenny with her with her two youngest children, with the whole of my household furniture of every description also the whole of my farming utensils the half of my stock of hogs & fowls (except what is and shall be hereafter excepted) also her choice of four horse beasts (??) and one half of the horned cattle, the whole of the dead provisions liquors and grain of every description on the Farm. Also it is my desire- will that my two daughters Jennet Harriott Haynes & Granville Haynes do live with my wife as part of her family and shall be allowed their board washing de gratis untill they enter into matrimony agreeable to their mother's consent - (It is also my will that my son William Henry Haynes live on the said Farm, shall husband the same for his mother's use, and she shall make him such compensation as she shall deem to be right. And in case that he doth not perform those duties to his mother's satisfaction that then his mother shall be authorized to lay off one third part of the said plantation exclusive of the Mansion house, and other buildings for his own use.)

3rd I give and bequeath to my son William Henry Haynes after the decease of my wife the whole of my plantation whereon I now live with all the lands adjoining thereunto. And one one sixth part of the live stock of hogs & cattle, one half of the hay and one sixth part of grain, and two negroe boy to him and his heirs for use. Also I give and bequeath to my said son William Henry Haynes at my decease one good feather bed & furniture, one young horse and a young mare now called his, one rifle gun now called his, all the books and implements furnished him for his learning & improvements forever. And I do further will to my said son William his choice of all the slaves at the death of my wife wife that are not otherwise disposed of provided he shall discharge & perform the duties to his mother hereby enjoined by this will. (And in case that he doth fail to perform those duties he is to have no such choice.)

(note: Joseph must have changed his mind about the above paragraph, because most of it is marked out with an X, leaving just the first sentence. mdb)

4th I also give and bequeath to my said son William Henry Haynes for the benefit of my daughter Ann Gilliland a negroe girl called Rachal, and one fifth part of my estate that I shall hereafter direct to be sold for the benefit of my five daughters to be husbanded by my said son William and the profits applied to her use and subsistence during her natural life and at her death the said estate so given in trust shall be equally divided between the legitimate heirs of her body and I do give the same to them and their heirs forever.

5th I give and bequeath to my daughter Elizabeth Holloway one negroe called Dinah at the death of my wife one fifth part of my estate that I shall hereafter direct to be sold by my Executors to her and her heirs forever at my death.

6th I give and bequeath to my daughter Agnes Kitchen one fifth part of my estate that I shall hereafter direct to be sold by my Executors -- Also the sum of three hundred dollars (in case I do not furnish her with a negroe girl and in case I do she is only to have the fifth part as aforesaid) to her and her heirs forever.

7th I give and bequeath to my daughter Jenet Harriot Haynes one negro woman named Lidia, two young cows and calves one horse beast and a saddle called hers -- one good feather bed & furniture called hers and one fifth part of my estate that I shall hereafter direct to be sold by my Executors to her and her heirs forever but in case of her death her part shall descend and be divided amongst the whole of my daughters.

8th I give and bequeath to my daughter Granville Haynes one negroe girl called Sarah, two young cows and calves, one horse beast & saddle one good feather bed of furniture and one fifth part of my estate that I shall hereafter direct to be sold by my Executors to her and her heirs forever -- and in case that my daughter Granville dies before she comes of age or married then her part of the estate to be equally divided between the whole of my daughters.

9th I will that my Executors dispose of at publick sale the following tracts or parcels of land to wit: one tract of four hundred acres whereon John Holloway now lives, one other tract on the north side of Jacksons River opposite the lands I live on and joining Alexander Wilson Esq. One other tract lying on Gillaspies Mill Creek in Bath County held in joint tennacy with Andrew Moore Esq. containing twenty two hundred acres -- one other tract containing one hundred acres lying in the Falling Spring Valley and County aforesaid adjoining the lands of Majr. Massey and Francis Crutchfield purchased from Joseph Thompson and John Oliver dec'd. his bond assigned to me for a title and my said Executors hereafter to be named is hereby authorized to make legal conveyances for the said several tracts of land above mentioned. Also my Executors are hereby authorized & requested to sell at private sale amongst the legatees only or at publick sale as may seem to them most desirable for the benefit of the heirs the following property to wit:

one negroe man named Davey and Boy Baccus with the residue of my stock of horses and horned cattle not heretofore disposed of -- also my stills and vassals to be continued on the farm -- and the above property when sold is to be equally divided between my five daughters as before devised.

It is also my will that at the decease of my wife that all my slaves not heretofore bequeathed or disposed of, with every other article of my estate of every description not will(ed) or bequeathed shall be sold at publick or private sale at the discretion or my Executors as aforesaid and the monies from the same to be equally divided between by five daughters as aforesaid to wit: Elizabeth Holloway, Agnes Kitchen, Ann Gilliland, Jennet Harriot Haynes and Granville Haynes in the manner & form ~~aforesaid~~ before stated.

10th and lastly I do appoint my friend Martin McFarran Esqr. my brother William Haynes and my son William Henry Haynes my Executors of this my last will & testament hereby revoking all other wills & testaments by me made and done & they are hereby revoked. In witness whereof I have signed sealed and acknowledged this my last will and testament this 21st day of October, in the year of our Lord Eighteen hundred & Six in the presence of

Note to be added to the fifth article of my will. When John Holloway was building the house he now lives in his intention was to build it only one story high but I prevailed on him to build the same two story high and he did so. In order to comply with what I think just it is my will that my Executors appoint two or more good men to value the said second story of the house & when valued that my said Executors allow the said John Holloway the valuation out of the land that I have directed them to be sold for the benefit of my five daughters (to sold for the benefit of my five daughters -- repeated section, mdb) and after this deduction then divide as before directed.

# KEEPING THE ONCE LOST FROM GETTING LOST AGAIN, by Richard Andre

One of the most rewarding sidelights of the genealogical hobby is the discovery of the last resting place of our long departed ancestors.

It is somehow sad to consider that many old graves are unmarked and often times it is only through our research that their location becomes known.

The writer has discovered at least five in his own family line that were either unmarked or the original stones have eroded away.

What can we do to assure that future researchers will be able to find and identify these graves?

Any individual can usually see that a modest stone is cut and placed on an unmarked grave once the person is sure of his fact.

Most monument companies, especially small struggling ones, will sell a simple flat granite headstone for less than \$50. Note I specify granite because it is timeless, and scoundrels will steal bronze markers. You must consider that the well-cared-for cemetery you see today may be left to fend for itself in a hundred years or so. Do not choose an upright stone because it will eventually fall or be pushed over.

Now here is a simple tip. The installation of a small headstone, say 50 or 60 lbs., is very easy! Just buy a 90 lb. bag of sakrete- dig a hole about 6 inches deep exactly the size of the sakrete bag-place the bag in the hole and cut out the top of the bag. Lay the headstone exactly on top of the exposed sakrete and I guarantee mother nature will do the rest. The rain and natural dampness will solidify the sakrete and the new headstone will have a good solid foundation.

Your Petetioners further States that they At the Superior Court of Law held for the County of Giles at the April Term 1811 was Admitted to, and did take the oaths of Fidelity To the Commonwealth and declared their intentons of becoming citizens of the united States.
