**MEMBERSHIP:** Each SVGS membership will be mailed a copy of the "Society's" quarterly, the VIRGINIA APPALACHIAN NOTES (VAN). The VAN is published quarterly, usually in February; May, August and November. Previously these issues were followed by an annual index issue. Effective with CY 1996 the annual index will be included in the November issue of the VAN for that year or in a subsequent issue of the next year.

Society memberships are on a calendar year basis and those memberships, which are not renewed by January 30, will be deemed as inactive and removed from the VAN mailing list. Single or family memberships are \$20.00; Organization and Library memberships are \$15.00. Members with mailing addresses outside the United States shall add \$10.00 to the above fees and all monies are payable in U.S. currency. Issues of the VAN, 1995 and earlier, are available at a reimbursement cost of \$4.00 each, as long as the supply lasts. More recent issues are \$6.00 each. A bulk mailing of old VANS to one address may be eligible for a 10% discount.

All payments should be made by check or money order, payable to Southwestern Virginia Genealogical Society, Inc. or to SVGS, Inc. and may be mailed to Post Office Box 12485, Roanoke, VA 24026-2485.

### ROBERT AND VIALETA LINUS HILL Early Franklin County Settlers

Robert and Vialeta Linus Hill were my ggggg-grandparents. Their daughter, Ruth Hill, married Walter Bernard, who was my Revolutionary War grandfather.

I have been researching the Hill-Bernard-McNeil families of Franklin County, Virginia for approximately 10 years and really do not like to have mysteries develop in my research. It also does not help to live in Social Circle, Georgia, and have everything you are working on in Franklin County, Virginia. Or so we thought,

Having already entered Daughters of the American Revolution with Walter Bernard as my Patriot, I really wanted to become part of the local Colonial Dames chapter. This meant that I must prove an acestor who was here in the 17th Century (1600's). This bacame an obsession!

Having no luck in Franklin county with Robert Hill or Walter Bernard, we approached my son's history professor at Erskine College, Due West, SC, who suggested that we take the Bernard name north into Pennsylvania and Maryland. This earch still has not located the Bernard family in question, but did connect us with the Hills.

Robert Hill and Vialeta Linus were married on 9th month 12 1741 at the New Garden Quaker Meeting house in Chester County, Pennsylvania.<sup>1</sup>

It was a requirement of the Quaker Meetings at this time that the bride and the groom state their intent to the monthly meeting and then a committee was appointed to interview each party regarding the request for marriage. This was done and is recorded in the Monthly Meeting Minutes for New Garden Meeting. 7th month 26, 1741 was when they first asked for permission to marry. Their second intentions were requested on 8th month 31 1741 and they were given the liberty to marry. By 9th month 28 1741 it was reported in the monthly meeting minutes for New Garden Meeting House that they were married.<sup>2</sup>

The only other reference to Robert Hill came on 11th month 30 1747/48 when the meeting learned he was in legal trouble with his creditors. For this he was disowned from the Society of Friends on 1st month 26 1748. The latter reference was very poorly microfilmed and it was hard to read.<sup>3</sup>

\* Mrs. Williams is a native of Franklin County, Virginia, and recently won one of the 1996 Essay catagories in the United Daughters of the Confederacy Historian General's Essay Contest. She wrote about Linus Hill Bernard, her g-grandfather and how the Union Invasion affected her family. The current family project: locate the Williams connections in Montgomery and Charlotte Counties in Virginia

There is no clear information on who were the parents of Robert Hill. Parents of the bride and groom always sign in the right hand corner of the marriage certificate under the name of the bride and groom at a Quaker marriage ceremony. In this case no one signed in that position. However, Ann Hill did sign the certificate with other friends who attended.<sup>4</sup> She was the wife of Samuel Hill, and they were received at New Garden on 8th month 25, 1735 from a meeting in Limerick, Ireland; Ann appearing before the Women's Meeting, Samuel before the Monthly meeting.<sup>5</sup> It is possible these were Robert's parents. Ann later asked the Monthly Meeting to grant her and her children (not named) permission to move to a Monthly Meeting on the "Frontier".<sup>6</sup>

Robert and Vialete do not appear in the New Garden Monthly Minutes again after he is disowned. Perhaps they have already left the area or that this is when they began the journey to Virginia. This would fit into the time frame in the area that became Franklin County. Maps which show the travel routes into areas of Virginia would indicate that perhaps they travelled the Pennsylvania Wagon Road into what is now Franklin County, Virginia.

The marriage certificate shows that Vialeta Linus lived in the county of Chester in" ye Province of Pensilvenia" and that she was the daughter of Thomas Linus of "Newprovidence in ye County of Philada. & rpovince aforesd."<sup>7</sup>

Several references to Thomas Linus were found at the West Chester Historical Society in West Chester, Pennsylvania. Item #4399 in the computer system there showed a list of returned letters to the Post Office in Philadelphia. The list is dated January 15, 1741 and shows that a letter was returned to Philadelphia for a "Linus" at New Garden. Of course, the letter has long been destroyed, but William Penn did keep good records.

Reference was also made to a notice published in the Pensylvania Gazette dated June 12, 1746, WHEREAS Jane, the Wife of Thomas Linus, of New Providence Township, in Philadelphia County, hath lately made frequent Practices of eloping from her said Husband, and running him in Debt; these are therefore to forwarn all Persons trusting her on his Account, for he will pay no Debts by her contracted, after the Date hereof. Thomas Linus.<sup>8</sup>

This information is submitted in hopes that other family connections will become interested in completing the "rest of the story." My husband and I have made two trips to Chester County, Pennsylvania. We have walked on the grounds of the New Garden Meeting House, founded in 1714, at New Garden, and also at London Grove Meeting House, Chester County. These meeting houses remain in much the same style as when Robert and Vialeta Linus Hill walked on their grounds.

DID YOUR QUERY NOT GET PUBLISHED? Here are a few reasons why a query may not get published:

1. Query is too long. The rules state 60 word limit (I sometimes allow a <u>little</u> more if space permits).

2. Query that is not readable. Mostly this is because of punctuation rather than handwriting. Try to keep sentence fairly simple.

3. No query is made. The editor cannot tell what information you are seeking.

4. Too many queries are submitted. The limit is 3 per issue. If you send more, some will have to wait until the next issue. If you send more for the next issue, some will get left out.

5. No address on the query itself. Many times envelopes get separated from the body of the query and we do not know the address.

6. You are not a member and you did not send payment with your query. Queries for non-members are five cents per word (do not count your name and address. We do not bill for queries.

7. There may not be room. Rather than put only one or two queries at the top of a page, they may be carried over to the following issue.

## DOCUMENTATION

The dreaded "D" word keeps many good genealogists from submitting their work to publications. It keeps many good writers from publishing their work. However, documentation is not intended to make your research more difficult, it is intended to make it easier. It is intended to make it easier for you to let your readers know where you found your information. Unless you let them know, they think you made it up. Well, that is not exactly true. Some people will think you fabricated the whole thing, others will think you are being stingy and others will think you don't really know what you're doing.

We want you to submit your original research to the VAN for publication. However, we do want your work to be properly documented. By "properly" we simply mean we want you to let us know where you found your information.

Do you remember the thrill you felt the first time you located a missing ancestor or found one that shares your full name that you did not know existed? When you share your sources with others, they can feel the same thrill, perhaps by finding someone in the same source that did not apply to your branch of the family and which you, therefore, did not list in your research.

Below are some guidelines that the VAN will be using to determine if proper documentation has been used in articles submitted for publication.

The most important aspect of documentation is that the following information be given:

- 1. The title of the source
- 2. The author of the source (if applicable)
- 3. The publisher of the source
- 4. The date of publication, edition number if applicable
- 5. Where you found the source

This can be done in any one of several methods.

- 1. Any of the style manuals can be used
- 2. A reference list at the end of the article which is referred to in the body of the work using a number followed by a page number
- 3. A narrative style in which you simply make reference to the source within the body of the work (This method works best on short pieces with few references)

If you have kept good notes for yourself so that you know where you found information, then you should have no problem documenting your work. Even if you did not write down all the information, you should be able to go back to the source to complete it.

Beware of family traditions. If you have a piece of information that you have known all <sup>99</sup> your life, but you don't know exactly where the information came from originally, it is "family tradition." That does not mean that it isn't true or that you can't use that information in your article. It simply means that you must label it as family tradition unless you have done the research to substantiate your family tradition, in which case you show the sources that proved the family tradition to be correct. In another situation, you can remember when you were a very young child your Great-uncle George telling you the story of three brothers with your last name who came from Europe during the 18th Century to settle in America and that two of them became heads of famous families, but you are descended from the third brother who disappeared without a trace. . .etc. When you put this information in your article, you must state that George told you the story. This does two things; it informs us that the story is "family tradition" and it let's you off the hook as saying that it is completely true until such time as you can prove it.

One more caveat is the notion that "if three sources say it is so, then it is considered 'common knowledge' and does not need to be documented." Many times in the world of genealogy, an article references a published family history then goes on to elaborate on what has already been published. The family history and the article DO NOT CONSTITUTE TWO SOURCES. Remember, when you cite a published work, you should check the documentation of that work to make sure you are not citing two references to the same source as two different sources.

Remember, we at the VAN do want you to submit your articles of original research, we do want to know what you are doing on your own family history. Just remember that when you make a statement, you should also answer the question: "How do you know that?"

## Last Will and Testament of Caspar Reed

Berks Co., Pennsylvania proved 5 October 1789

In the name of God Amen. The fourteenth day of January in the year of our Lord One Thousand Seven hundred and Eighty eight. I Caspar Read of the Township of Tulpehoccon in the County of Berks in the State of Pennsylvania Yeoman, being weak of body but of sound mind and memory, Thanks be to God for the same. And calling to mind the mortality of my body knowing that it is appointed for all Men to Die, do this fourteenth day of January aforesaid make ordain and publish this my Last Will and Testament, in manner following. That is to say...

*Imprimis* And first of all I recommend my soul into the Mighty Hand of God that gave it, and my body to the Earth to be buried in it. Christian like manner at the discretion of my executors herein after named and appointed.

Item I do order all my just debts and funeral charges to be honestly paid and adjusted.

Item I give and bequeath unto my six beloved children or to their proper representatives and to their heirs and assigns forever all my estate wherein it hath pleased God to bless me with in this world to be equally divided amongst them share and share alike. That is to say, To my Eldest Son John George Read one sixth equal share, To my Son Michael Read one sixth equal share, To my Daughter Elizabeth Catharine intermarried with John George Gall, one sixth equal share, To my Son Philip Read one sixth equal share, To my Son Frederick Read one sixth equal share, and To my Daughter Mary Margaret intermarried with George Gebhard one sixth equal share, which will be six equal parts and shares. To hold the same to them or their proper representatives and to their heirs and assigns forever. Allowing unto my Son John George Read the sum of ten pounds lawful money of Pennsylvania over and above his equal share with the others the same to be for his first birth right.

*Item* I give and bequeath unto my Son John Caspar Read and to heirs and assigns forever the full sum of one hundred pounds lawful money of Pennsylvania which I have already paid him which is and shall be in full satisfaction for his hereditary share and portion out of my estate and estates.

*Item* I give and bequeath unto my son in law Adam Emrich and to his heirs and assigns forever, the full sum of two hundred pounds lawful money of Pennsylvania which shall be in full satisfaction for the hereditary shares and portions of my daughters Mary Barbara and Christena out of my estate and estates. And whereas I have already paid the said Adam Emrich the sum of one hundred pounds in part of my two daughters shares and hereditary portion to whom the said Adam Emrich was intermarried. So that he hath yet to receive the sum of one hundred pounds which he the said Adam Emrich shall receive of

my Son Frederick Read of the State of Virginia and fetch the same at his own expense and 01 charges and that in four years after my decease and no sooner. And whereas my daughter Elizabeth Catherine hath issue four children with her first husband Hermanus Baddorff deceased, to with Michael, David, Philip, and Casper, all sons of the said Hermanus Baddorff aforesaid. It is therefore my will and I do hereby order that the one equal half sixth part of my daughter Elizabeth Catharine hereditary portion be equally divided amongst the said Michael, David, Philip, and Casper share and share alike and the other half part to be for the use of my daughter Elizabeth Catharine. It is further my will that my executors deduct out of my son Philip's share the sum of twelve pounds which sum I have advanced to him towards paying his saw mill. And in order that my executors may be the better inabled to make my children's shares aforesaid proper they are to have due regard and reference to certain papers and receipts given by my children for money advanced unto them by me. And Lastly I do hereby ordain nominate and appoint my trusty and beloved sons John George Read and Michael Read (the said Michael Read to have the same commissions as my Son John George Read and no more) my whole and sole executors of this my Last Will and Testament and to see this my Last Will and Testament justly and honestly fullfilled according to the true intent and meaning thereof and I do hereby revoke disallow and make void all other wills or legacies whatsoever by me heretofore made whether in words or writing allowing this and no other to be my Last Will and Testament.

## The Morristown Gazette February 9, 1898

### "Hannah Family Reunion" Birthday of Mr. and Mrs. George Hannah Also their marriage anniversary and the ninetieth birthday of Mrs. Elizabeth Hannah January 25, 1898

An intensely interesting event was enjoyed at the old homestead of the DeVaults, at Austin's Springs, Washington county, Tenn., Jan. 25, 1898. The ninetieth birthday of Mrs. Elizabeth Hannah (more familiarly known as "Grandma Hannah") was the occasion of a large assemblage of her friends and relatives, and all the living children were present--and her children's children unto the third and fourth generation were there.

As Mrs. Hannah and her family are all well known by many, an account of this event will not be uninteresting.

Mrs. Elizabeth Stover was married to Mr. George Hannah on their birthday, Jan. 25, 1826, at the stone residence of her parents in Roanoke county, the garden spot of Virginia. Her father's farm is now the site of Roanoke City. Hr. Hannah was a citizen of the same county.

When their family had multiplied to the Scriptural number, seven, they concluded to emigrate to East Tennessee (which was then a new country) where their children would have better opportunities.

In December, 1841, they commenced their journey in wagons, hacks, etc., etc. It was before the days of railroads. They crossed the Blue Ridge Mountain, following what is now the valley route of the railroad, until they came to Watauga River. They found this beautiful stream past fording from recent rains. They pitched their tents and went into camp on her bank until they could cross and make their way on down to the rich valleys below.

Mr. Valentine DeVault, Sr., the landlord of the bank on which they were camping, came down to see who the movers were. The acquaintance proved to be agreeable on both sides, so much that Mr. DeVault invited Mr. Hannah to take his family to the house and be entertained there--which hospitality was accepted. A mutual friendship sprang up, the ties of which have grown stronger through all the intervening years since, and which was the foundation for the ninetieth birthday celebration of the only living head of these two families. Mr. DeVault persuaded Mr. Hannah to occupy a house on his land, a mile up the river, until he would have time to seek a satisfactory location. There were two houses in the same yard; one was empty, and one stored with grains, fruits and vegetables. Mr. Hannah moved his family into the empty one. Mr. DeVault told Mr. and Mrs. Hannah to use all they needed of the stores there, and that it was unnecessary to keep any accounts.

Mrs. Hannah was an expert with her needle and, as it was before the days of sewing machines, it was a valuable accomplishment. With much nice neat work she tried to return the many favors received. The two eldest children were girls, Mary Elizabeth and Edna. They were experts, for their age, being only fourteen and eleven years, with knitting needles, which was also a valuable accomplishment in those days.

Hose and gloves grew like magic, and were given by Mrs. Hannah to Mrs. DeVault for herself and family.

Mr. Hannah bought a farm of 300 acres one mile south of what is now Bluff City, seven miles from Mr. DeVault's. In two years Mr. and Mrs. DeVault sickened and died within two days of each other, leaving their lands to their three young sons, Isaac, Jacob and Valentine, who were at that time in their young manhood. A large brick house was in course of erection. It was finished by them. The contractor, Mr. Jordan, was a courtly young man for whom they formed a high regard. Soon after the house was finished Mr. Jordan married. They gave him a grand reception, to which the Misses Hannah were invited, who had grown to be beautiful, winsome young ladies. Mary Elizabeth was a blonde, small, with bright intellect and modest deportment. Edna was a brunette, tall, amiable and modest. They made their debut at this reception. Isaac, Jacob and Valentine were in the full development of young manhood--were well-proportioned, erect--six feet high and over--handsome, gallant and courtly, and were considered the best opportunities for husbands in all the country. Cupid put in his arrows on that "infair" occasion and from that time the gallant Isaac went wooing the fair Mary Elizabeth. Her parents were highly elated. After a few months he asked for her hand in marriage. Their consent and blessings were graciously given.

Then came a wedding and reception at the old homestead. They went to housekeeping in the house she had occupied with her father at first, until a new palatial brick residence on the same ground was built. Jacob married the accomplished Miss Elizabeth Clark, of Nolachucky. They located immediately across the river, and built one of the pretties houses in the county.

The union of Isaac and Mary Elizabeth threw Edna and Valentine much together. Soon it was known. Cupid has successfully used his arrows again. After a time Edna's hand was asked by the greatly favored Valentine--again, as the first couple, with the hearty consent of the parents. Again nuptial ties were celebrated; and the kind Edna, with dark brown eyes and hair as black as a raven's wing, became the mistress of the grand old homestead, where Mrs. Hannah has made her home in these later years. Had all men been like Valentine and all women like "Grandma Hannah" there never would have been the sarcasm written about mothers-in-law that has been.

Twelve children were born to Mr. and Mrs. Hannah, first three girls, then three boy; then three girls, and three boys: Mary E., Edna, Sarah J., John W., E. Mark, James S., Lucy C., N. Francis, Charlotte So., George M., Andrew J. and Farel Bratcher. Two--Sarah J. and James S.-- died in their childhood. Mary E. died, leaving a family of five children; N. Fanny, who married Dr. James Stewart, died; leaving a family of three children. The eight living were present at the reception: Mrs. Edna DeVault, John W., of Tusculum, Mark, of Austin's Springs, Mrs. Lucy C. Jarnagin, of Morristown, Mrs. Charlotte McFerrin, of Bristol, George M., of Austin's Sp'gs, Dr. Andrew J. and Dr. F.B. of Umatilla, Fla. The two youngest, A.J. and F.B., are the Joseph and Benjamin in the old lady's affection. They brought tropical fruits and vegetables with them from Florida, which added much luxury to the already luxuriantly prepared dinner.

We CANNOT PRINT material from printed sources unless we have written permission from the publisher, which you MUST FURNISH. We must have source of material to give credit to the person who has done the work. (3) DEADLINE for submitting material should be at least two months before date of publication. (4) PLEASE do not send material that you want returned - send a photocopy to us instead. That way it won't get lost, as letters do get misplaced, when passed from one person to another.

**SURNAME INDEX:** Information will include name (given and surname), place (location at time of date), Date (birth, death, marriage, or where living at the date given). "WASKEY, William Christopher - Montgomery Co, VA - 1900-10 death" If this data takes more than one line or the spouse is included on the same line, it will count as two names. The limit is 10 names. The sumame index is published in the August issue.
