**MEMBERSHIP:** Each SVGS membership will be mailed a copy of the "Society's" quarterly, the VIRGINIA APPALACHIAN NOTES (VAN). The VAN is published quarterly, usually in February; May, August and November. Previously these issues were followed by an annual index issue. Effective with CY 1996 the annual index will be included in the November issue of the VAN for that year or in a subsequent issue of the next year.

Society memberships are on a calendar year basis and those memberships, which are not renewed by January 30, will be deemed as inactive and removed from the VAN mailing list. Single or family memberships are \$20.00; Organization and Library memberships are \$15.00. Members with mailing addresses outside the United States shall add \$10.00 to the above fees and all monies are payable in U.S. currency. Issues of the VAN, 1995 and earlier, are available at a reimbursement cost of \$4.00 each, as long as the supply lasts. More recent issues are \$6.00 each. A bulk mailing of old VANS to one address may be eligible for a 10% discount.

All payments should be made by check or money order, payable to Southwestern Virginia Genealogical Society, Inc. or to SVGS, Inc. and may be mailed to Post Office Box 12485, Roanoke, VA 24026-2485.

# Henry Harrison Earles of Floyd County, Virginia

Henry Harrison EARLES was born in the 1840s in Floyd County, Virginia and died in 1928. His mother's name was Francis "Fanny" EARLES. He is described as being 5'5" with light hair, fair complexion, and grey eyes.

In January 1864, Henry enlisted in Company A, 24th Regiment of the Virginia Infantry. In the spring of that year he was assigned guard duty in Tarboro, North Carolina, then he returned to Virginia. On a damp, rainy May day, after three days without food, he was shot with a muzzle loading rifle during the Battle of Drewry's Bluff (near Richmond). The bullet entered through his stomach and exited near the spinal column. It was thought he wouldn't survive, but after several weeks in field hospitals, he pulled through. Those that knew him say the wound didn't seem to bother him too much. He survived the ordeal with dignity and was proud to have served. On February 6, 1865 Henry was medically discharged from service. In later years, he was granted a military pension from the state of Virginia and in 1908 he was awarded the Confederate Cross of Honor by the Daughters of the Confederacy.

In January 1875, Henry married Susannah Mary LESTER (1850 - 1885), daughter of Fleming W. and Permelia O'BRIEN LESTER. Henry and Susan had eight children. Susan died at the birth of their last child.

In September 1891, six years after Susannah's death, Henry married Rosetta Mildred COLE (1863-1956), daughter of Bird, Sr. and Sarah IDDINGS COLE. They were introduced by Capt. Peter SHELTON. Both SHELTON and Bird COLE, Sr. served in the Civil War, but dates and regiments are unknown. Henry and Rosetta had five children.

Henry Harrison EARLES was active in the Floyd County community having served 30 years as Registar and 30 years as an Alum Ridge school trustee. He was also a successful brick mason having made the brick for the Old Floyd County Courthouse (now torn down) and building several structures which are still in use. He also was a farmer and raised corn, wheat, and oats, as well as, cattle and sheep

Henry Harrison died July 8, 1928 in Alum Ridge in Floyd County. His wife, Rosetta, and three children, India, Lace, and Ada, were with him in his final moments. Henry and both of his wives are buried in Beaver Creek Cemetery, Floyd County, Virginia.

Dear Ruth:

I found your three cemetery articles in the August 1997 issue of "Virginia Appalachian Notes" very interesting. You are to be commended for your efforts to document the history of Craig County.

The article on the Huffman Cemetery at Captain, Craig County did not include information on two of the community's prominent citizens. Capt. Guy Dingus Huffman, commander of Company K, 46th Virginia Infantry Regiment, CSA, and his wife Sarah Jane Hutchison, daughter of Col. Robert Mason Hutchison and Mary Elizabeth Tawney who was the daughter of Daniel Tawney and Elizabeth Price.

I don't know if the stones are still there or not. They were near the center of the cemetery. A large part of the old sassafras tree fell several years ago. Possibly it damaged the stones. I copied the stones quite a few years ago. They read:

> SARAH JANE HUFFMAN BORN APRIL 16, 1827 DIED SEPTEMBER 21, 1914 DAUGHTER OF COL. ROBERT M. HUTCHISON AND MARY E. TONEY

CAPT. GUY D. HUFFMAN CO K 46 VA INF REGT CSA BORN NOVEMBER 27, 1829 DIED JANUARY 19, 1910

Over the years I have noticed quite a bit of confusion concerning the names of the Huffman cemeteries (Huffman Cemetery at the Herman Huffman place and the Huffman Cemetery at the old Walter Mills place), the Hutchison Cemetery and the Hardwick Cemetery. The Huffman Cemetery at Captain is really the Capt. Guy Huffman Family Cemetery. Some think it is the Hutchison Cemetery because it is at the old Col. Robert M. Hutchison place. the Hutchison Cemetery is on the old Hardwick place which causes it to be called the Hardwick Cemetery. Jane Wallace the wife of Robert Hutchison, Sr. was probably the first burial in the cemetery about 1815. Elinor Eakin, the first wife of Col. Robert Hutchison was probably the second burial. Robert Hutchison, Sr. was buried there about 1825. The cemetery located at the Herman Huffman place is the Huffman Cemetery. I failed to mention that Captain got it's name from Capt. Guy because there was a post office there early in the 1900's with that name.

Court Quarterly sefsion County of Montgomery at the Courthouse on tuesday the first day of August 1820

- p. 95 Polly & al Paupers vs Patton. Jury sworn to wit. Abrabado Wadkins, John Snider, Jacob Price, John Dobbins Jr John W. Charlton, Jacob Slobaugh, Robert Page, William Shelor, John Barger, John Barringer, Peter Hornbarger Samuel Lucas and returned a verdict in the words following. To wit, we of the Jury do find that Polly the Plaintiff first mentioned is the Daughter of Rachel who recovered her freedom in the Superior Court of Law for Powhatan County at the May Term last upon the ground that she was descended in the female line from an Indian woman brought into this Country at a time when they could not be made slaves, and that the other plaintiffs are the children of said Polly and the grand Children of the said Rachel, We do therefore find that the Plaintiffs are free persons and not slaves, and we do afsefs their damages to one cent.
- p. 96 Polly & al Paupers vs Patton. On the Motion of the Plaintiffs and for reasons appearing to the Court, the verdict rendered by the Jury in this case on this day is set aside, and it also appearing that the Plaintiff Polly has had two Children since the commencement of this suit, To wit, Sally and Maria, they are thereupon on their Motion...made parties plaintiffs in this suit and thereupon Cause a Jury, To wit. John Barger Jr, James Simpkins, Peter Hornbarger, Jacob Price Robert Page Jacob Hoback, Adam Wall, Alsabodo Watkins, John M. Charlton, John Baringer Elias Skelton and David Craig, and returned a verdict in the following words To wit, we of the Jury do find that Polly the Plaintiff first mentioned in this declaration is the daughter of Rachel who recovered her freedom against John Draper Senr. in the superior Court of law for Powhatan County at the may term last upon the ground that she was descended in the female line from an Indian woman brought into this county at a time when they could not be made slave, and that the other plaintiffs are the Children of the said Polly and the grand children of said Rachel, we do therefore find that the plaintiffs are free persons and not slaves, and we do afsefs their damages to one cent.

## INTRODUCTION OF CHARLES THOMAS BURTON TO THE SOCIETY

Some of you have not had an opportunity before today of meeting or getting to know our guest-of-honor. I've had the pleasure of knowing him for twenty-nine years, so I was honored to be asked to say a few words about the man and his work.

Charles Thomas Burton lived a fairly normal life until the 1950s. He had a family, and he was working as a mechanic for the Wright Motor Company in Roanoke, when he developed tuberculosis. Because of his illness, he was unable to work for several years. It was during this time that he discovered the genealogical and historical collection in the alcove under the stairs of the Roanoke Public Library, which was in the former Terry home on the hill in Elmwood Park. It was at this time, too, that he was struck with another disease - a powerful disease - sometimes referred to as the Genealogy Bug, and he began researching his own family.

After recovering from tuberculosis, Mr. Burton did agricultural survey work in Botetourt County. This work provided him with first-hand knowledge of the properties, the streams, the families and the cemeteries of the county.

Eventually he would begin researching for others - those who wanted to join patriotic societies, as well as those across the country whose roots were in Botetourt County.

As a genealogical researcher, Mr. Burton became familiar with the vast wealth of records in the Botetourt County courthouse and other area courthouses. He also became a "regular" in the Roanoke Public Library's Virginia Room. His familiarity with the family names, the land, and the court records available made him a "natural" in the role of researcher.

His personal collection of notes on the families and properties grew as a result of the research done for his clients. He compiled family group sheets on individual families as he researched them, realizing that they would be useful for future inquiries he might receive. He kept meticulous records on his research in files and on card indexes. He had made scrapbooks of hundreds of historical articles from the newspapers - some written by Goodridge Wilson and by Raymond Barnes - and he indexed them.

Mr. Burton began compiling records he found into books, perhaps to make his own work easier so that he could have the information on hand instead of rechecking the microfilmed censuses or the court records he used so often. He realized others could benefit from these compilations as much as he did, and he began printing and selling some of his work on the censuses, tax and tithe lists, land records and court entries, to name a few. In collaboration with Mrs. Vicie Fowler, he compiled the marriage records of Botetourt County from 1770-1819.

The Roanoke Public Library was surprised and excited to learn that we were to become the repository for Mr. Burton's outstanding collection of genealogical and historical research. Mr. Burton, we pledge to preserve and protect your work while still making it available to those who would benefit from using it. Your collection has been transfered to archival quality folders and boxes, which are being housed in our climate-controlled Special Collections room to insure a long life. An index to the collection is being compiled to make the general contents known to the researchers.

I'm so glad we could have this reception today in honor of Mr. Burton. He has earned welldeserved respect and recognition from people all across the country, from those who have known him personally or through correspondence, to those who know him only by the work he has done. We who have been bitten by the Genealogy Bug can be grateful for people like Charles T. Burton for his dedication and his interest in the pursuit of this region's history.

And now I'd like to add a personal note: When the Roanoke Public Library hired me in 1969, I was truly GREEN. I was just out of college and had no previous experience in genealogical research. But I had some things in my favor - I was raised with strong work ethics; I had a keen interest in my own family's history; I've always enjoyed working jigsaw puzzles, which is just like genealogical research. And the greatest thing in my favor was a good-natured, regular patron who came to the Virginia Room nearly every day. He must have sensed my helplessness, as well as my willingness to learn, because he never failed to answer my questions, no matter how stupid they were. He was never too busy to show me what he was doing, why he was using certain records, and what he hoped to get from them. When he spoke to others, I listened, because I knew I'd learn something. Mr. Burton was my teacher!

Mr. Burton, I have so much to thank you for, but I would especially like to say thank you for your guidance, for your patience, and for your encouragement. You are a very special person!

After Carol spoke, Babe Fowler also said a few words about some of the special aspects of her 30 year friendship with Mr. Burton. He had pointed out to her that in her research she had a father who was five years old when the son was born; that there were three men who had been combined into one man because they had the same name; and that she and Mr. Burton both had the McClure family in their background, but that he would not claim Babe as kin. During the 30 years of their friendship, they have discussed everything under the sun.

Rev. Nelson Harris, Roanoke City Councilman, presented Mr. Burton with an engraved paperweight to show Roanoke's appreciation of the contribution made by Mr. Burton.

Mr. Burton himself delighted the audience with an anecdote of his childhood in which he was sent to the store by his mother when he was four years old to get a bar of soap. Because of his tendency to forget, by the time he got to the store he had forgotten what he was to get and had to go home without it. The second time his mother sent him, he repeated "bar of soap" over and over until he got to the store and was able to make the purchase for her. Later in life, when he had learned to write, he solved his problem of forgetfulness by writing down everything--a good lesson for all of us.

GENEALOGICAL TIP from *The Longhunter*, Vol. XX, Issue 3, pg. 51. In some records the occupation is capitalized as identification and follows a name without a comma. very few people in the colonial period had three names. John William Carpenter in 1785 was probably John Williams, carpenter. John Henry Taylor may well have been John Henry, tailor. Some wills and deeds have been found to have been indexed by occupation, not the name.

When researching information in the 1850 census, remember that IA indicated Indiana, not Iowa as it does in later records.

Marriage Bonds/Licenses and Minister's Returns as Indexed in the Floyd County Court House, Floyd County, Virginia starts on pg 85. Each query should include name, dates, and location to identify the problem. Please CAPITALIZE sumames - is it Mary Smith JONES (single) or Mary SMITH JONES (maiden & married name). Do not abbreviate, we will. If not typed, please PRINT — some written queries we have not been able to read. Queries for nonmembers are 5¢ (cents) per word not including your name and address. Queries must be received prior to the 1st of the month preceding publication.

# FAMILY REUNION, PUBLICATION OF BOOK, NEWSLETTERS, ETC.:

Limited to 60 words, not including your name and address. We cannot edit a full page down to 60 words — so send the notice as you want it printed. These notices will be put in as space permits. Members will be given priority in publishing these notices.

MATERIAL FOR PUBLICATION: We welcome articles, records, etc. for publications. The material when received may not be used in following issue, but in a future issue. If a large amount of material is sent, it may take a while to publish because we try to have a variety of material in each issue. (1) READY FOR PUBLICATION (which the editor loves). Please type using a carbon ribbon or dark ribbon and CLEAN KEYS. Use 8 1/2" x 11" paper, single space, with a minimum margin on ALL sides of 1 inch. Center your title. Be sure to include your name, address, and date (year) on the document. If not typed for publication, please PRINT PLAINLY -some articles that have been hand written we have not been able to read, or those that are typed with all caps are difficult to read. PLEASE read material over before mailing and double check all dates. (2) GIVE SOURCE OF MATERIAL. Original documents - where found, type of record, page number, etc., or, if known, who now has the document in their possession. We CANNOT PRINT material from printed sources unless we have written permission from the publisher, which you MUST FURNISH. We must have source of material to give credit to the person who has done the work. (3) DEADLINE for submitting material should be at least two months before date of publication. (4) PLEASE do not send material that you want returned - send a photocopy to us instead. That way it won't get lost, as letters do get misplaced, when passed from one person to another.
