#### **Historical Note:**

In 1967, H. T. Aldhizer III of Salem, Virginia, was the spokesperson for an informal group that circulated a petition calling for the elimination of pollution and improvement of water quality in the Roanoke River and Smith Mountain Reservoir. The group formed as the State Water Control Board worked to adopt water quality standards and held a public hearing May 16, 1967, in Roanoke, Virginia.

## **Scope and Content:**

The collection includes: correspondence with agencies and elected officials; newspaper articles; background information on water quality; and the public hearing record from the May 16, 1967 event.
